

IMPROVEMENT IN SCARFS.

Specification forming part of Letters Patent No. 208,093, dated September 17, 1878; application filed June 24, 1878.

To all whom it may concern:

Be it known that I, MORRIS HENSCHEL, of the city, county, and State of New York, have invented a new and Improved Scarf, of which the following is a specification:

In the accompanying drawings, Figure 1 represents a rear elevation of my improved scarf, and Fig. 2 a vertical transverse section of the same on line x x, Fig. 1.

Similar letters of reference indicate corre-

sponding parts.

The object of this invention is to furnish for scarfs of all kinds an adjustable centerpiece, which may be readily adjusted whenever its edge is worn out or soiled, so as to expose a new and unsoiled edge and impart to the scarf a neat and clean appearance until it is entirely worn out.

The invention consists of a scarf with a sliding adjustable center-piece, that is doubled back over a top cross-band of the scarf and passed through a retaining-loop at the lower

part.

Referring to the drawings, A represents a scarf of any suitable form and material, and B a center-piece, that is made of the same material and of oblong shape. The center-piece B may be made either single or double, as desired. In the latter case it may be used on both sides.

The center-piece B is passed from the front of the scarf over a cross-band, U, of the scarf at the upper end of the same, then turned down and passed along the back of the scarf, between the part to which the shield is attached and the front of the scarf, to a retaining-loop, D. The lower end of the centerpiece is always retained in position by the loop D, which is attached to the lower part of the scarf.

When the edge of the center-piece B is soiled by use the front part of the center-piece is drawn up and the worn section drawn down at the back until a new section is exposed at the front, which adjustment is continued as often as required until both scarf and center-piece are entirely worn out.

In most cases a single center-piece will be sufficient to outlast the scarf, as it may be readjusted whenever required, exposing each time a new section of the center-piece, and overcoming thereby effectually the annoying and disagreeable appearance of the scarf presented by the soiling of the edge of the center-piece.

Having thus described my invention, I claim as new and desire to secure by Letters

Patent-

The combination, in a neck-tie, of the shield or knot-piece, the rigid cross-piece, the attached neck-band, the elastic rear loop, the body-pieces of the scarf, permanently attached to the shield, and the movable center-piece, doubled around the rigid cross-piece, all constructed and arranged to operate for the purpose set forth.
