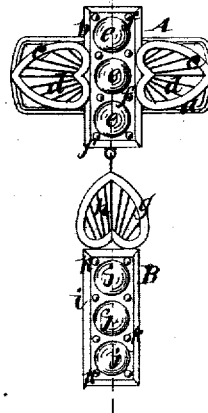

## DESIGN FOR BRESTPIN AND PENDANT.

Specification forming part of Design No. 8,299, dated April 27, 1875; application filed April 9, 1875.  
[Term of Patent 7 years.]

### CASE B.

*To all whom it may concern:*

Be it known that I, LEONARD S. BEALS, of Astoria, in the county of Queens and State of New York, have invented a Design for Breastpin and Pendant, of which the following is a specification:

This invention is illustrated in the accompanying drawing, in which Figure 1 represents a face view. Fig. 2 is a sectional view.

Similar letters indicate corresponding parts.

This design consists, as to the breastpin, of two oblong escutcheons crossing each other at right angles, and one of which is ornamented with heart-shaped shells and the other with a row of buttons. It consists, as to the pendant, of an oblong escutcheon depending from a heart-shaped shell, and ornamented with a row of buttons.

In the drawing, the letter A designates my breastpin, and B the pendant. Referring to the breastpin, *a b* are two oblong escutcheons placed one across the other. The escutcheon *b* is smaller in proportion to *a*, and it is made with straight sides and ends, while the escutcheon *a* has straight sides and convex ends. The escutcheon *a* bears on its face and on opposite sides of *b* shells *c*, which are heart-shaped, and ornamented with interior radia-

tions *d*. On the face of the escutcheon *b* is a row of buttons, *e*, which have a circular outline, and are interspersed with pearls *f*. Referring to the pendant, *g* designates a shell, which is heart-shaped, and has interior radiations *h*. From this shell is suspended an escutcheon, *i*, having straight sides and ends, and the face of which is ornamented with a row of circular buttons, *j*. The buttons *j* are interspersed with pearls *k*, similar to those of the escutcheons *a*, as shown.

What I claim as new, and desire to secure by Letters Patent, is—

1. The design for a breastpin composed of the oblong escutcheons *a b*, shells *c*, and buttons *e*, substantially as shown and described.

2. The design for the breastpin and pendant, the latter composed of the shell *g*, escutcheon *i*, and buttons *j*, substantially as shown and described.
