

DESIGN FOR INKSTANDS.

Specification forming part of Design No. 8,755, dated October 26, 1875; application filed July 14, 1875.

[Term of Patent 3½ years.]

To all whom it may concern:

Be it known that I, SAMUEL J. VAN STAV-OREN, of Philadelphia, in the county of Philadelphia and State of Pennsylvania, have invensed a certain new and useful Design for Inkstands; and I do hereby declare the following to be a full, clear, and exact description of the same, reference being had to the accompanying drawings, which form part of this specification, in which—

Figure 1 is a perspective of the design for inkstand and base.

The object of my invention is to provide a design for an inkstand which shall be commemorative of the centennial of the American Independence, and also of the Battle of Bunker Hill and of the Old Liberty Bell in Independence Hall, in the city of Philadelphia, State of Pennsylvania.

The nature of my invention is fully represented in the accompanying drawings, to which reference is made, and which consists in a design for an inkstand the body of which is a representation of the "Old Liberty Bell" in Independence Hall, in said city of Philadelphia, which may be made of any suitable material, as metal, glass, or india-rubber, including the counterpart crack, as shown at a, and the motto and inscription around the upper portion of the bell, "Proclaim liberty throughout all the land unto all the inhabitants there-

of." "By order of the assembly of the Province of Pennsylvania for the State House in the city of Philadelphia;" also, the name of the makers, "Pass and Stow," and the date "MDCCLIII." The bell rests on a square or rectangular base having projections, on which are placed miniature representations of the Bunker Hill Monument, as shown. On the base are also the figures "1776" and "1876," and the words "Liberty Bell" and "Bunker Hill."

What I claim as my design is-

1. The design for an inkstand consisting of a miniature representation of the Old Liberty Bell in Independence Hall, in the city of Philadelphia, resting on a base having the miniature representation of the Bunker Hill Monument, formed at or occupying the angles, respectively, substantially as shown and described.

2. The design for an inkstand-base consisting of the same, having at the angles thereof miniature representations, in relief, of Bunker Hill Monument, substantially as shown.
