DESIGN FOR GLASS DISHES.

Specification forming part of Design No. 8,827, dated December 7, 1875; application filed December 1, 1875. [Term of Patent 7 years.]

To all whom it may concern:

Be it known that we, JAMES S. ATTERBURY and THOMAS B. ATTERBURY, of Pittsburg, in the county of Allegheny and State of Pennsylvania, have originated and designed a Glass Dish for Table use, of which the following is a full, clear, and exact description, reference being had to the accompanying photographic illustration or drawing, making a part of this specification.

The nature of our design is fully signified in the accompanying photographic illustration of said dish, to which reference is herein made.

The object of our design is to remind the observers thereof of the source from which they derive their "daily bread," and at the same time present the symbol of that redemption through which they can only hope to partake of the bread of eternal life.

A represents the bottom portion of the glass dish, the interior of which is smooth or plane surfaced, and of oval form, as shown in the photograph. This oval portion is on the outside wholly depressed, so as to leave an oval ring or rim, b, surrounding it, which ring will rest in contact with a surface supporting the dish, thus protecting the configurations upon the exterior of the bottom A from abrasion or disfigurement.

In the act of manufacturing the dish impressions, lines, and indentations are made in the glass on its exterior portion, within the ring or rim b, in such manner, by means of a die, as to impress permanently therein, with proper shades and outlines, the form of "the cross," as at c, which projects from and rises above a rock, d. At the right of the cross, with one foot and one knee resting upon the rock, is a figure, e, intended to represent a heavenly messenger, who, with inclined body and extended arm, grasps one hand of a figure, f, intended to represent a Christian believer, who, with his other hand, clings to the foot of the cross, with his body against the rock, and beneath the whole, in like manner impressed in the glass, are the works "Rock of Ages," while on the main body of the cross appear the words "Simply to Thy cross I cling." Above the bottom A is a plane inte-

rior surface, B, of oval form, surrounding the bottom A, and rising outwardly and upwardly therefrom, to properly form the sides or wall of the dish. On the right hand of this wall, in raised letters, on the inside of the dish, appear the words "Give us this day," while in continuance of the sentence the words "Our daily bread" appear in like letters on the left-hand wall. Beyond the part B, and extending outwardly and upwardly, is a circumferential portion, D, which constitutes an outer rim of the dish, and limits the capacity thereof, and to this rim handles, as at g g, are applied.

A dish for table use thus designed may have its artistic effect heightened, if desired, by the application of appropriate colors to the configurations impressed in the bottom A above described.

The above design is intended for any article of glassware.

What we claim as our invention is—

1. The design of a glass dish having impressed in the bottom thereof the configura tions, substantially as described.

- 2. The design of a glass dish having the figure of a cross and a rock impressed therein, and the words "Give us this day our daily bread" on the sides of the dish, substantially as described.
- 3. The design of a glass dish, having an impression in the bottom thereof of a cross, and with the words "Simply to Thy cross I cling," impressed upon the cross, substantially as shown.
- 4. The design of a glass dish having a cross and a rock figured thereon, with the words "Rock of Ages" beneath, substantially as
- 5. The design of a rock, the figure of two beings, and a cross impressed upon glassware, substantially as shown.
