


DESIGN FOR A FAN.

Specification forming part of Design No. 9,138, dated March 14, 1876; application filed March 2, 1876.

[Term of Patent 3½ years.]

To all whom it may concern:

Be it known that I, LUCY M. BEARD, of the city of Brooklyn, county of Kings and State of New York, have originated a Design for a Fan, of which the following is a full, clear, and exact description, reference being had to the accompanying photographic drawing, making part of this specification.

The nature of my design is fully represented in the accompanying photographic illustra-

tion, to which reference is made.

Figure 1 represents one side of my fan, aud

Fig. 2 the other.

At or near the center of Fig. 1 is printed the coat-of-arms of the United States of America, consisting of the shield, eagle, and motto, "E pluribus unum." On the right side of the eagle is the present ensign of the United States, and beneath it is a picture of the present President, U. S. Grant. On the left hand side of the eagle is printed a picture of the flag said to have been used by General Putnam at the battle of Bunker Hill, having upon it a pine tree and the mottoes "Qui transtulit sustinet" and "An appeal to Heaven." Beneath this flag is a picture of Gen. George Washington, the first President of the United States. From the eagle's mouth, and just above it, is a scroll bearing the words "Let us have peace." Surrounding the central figures above described are pictures of sixteen of the Presidents of the United States, in the regular order of their succession, beginning with John Adams and ending with Andrew Johnson, with the name and date of accession to office printed under-

neath each, respectively.

In the center of Fig. 2 is a picture of the signing of the Declaration of Independence

of the United States of America, at Philadelphia, Pa., on the 4th day of July, 1776. Surrounding this picture of the signing of the Declaration are arranged the national ensigns of England, Russia, and other nations.

My design may be printed either plain or

in appropriate colors:

What I claim as my invention is—

1. The design for a fan having on the central portion of its face a representation of the United States coat-of-arms, Putnam's flag, the national flag of the United States, and the portraits of Presidents Washington and Grant, the same being surrounded by portraits of the intervening Presidents, substantially as described, and shown in the accompanying illustration.

2. The design for a fan having on its face a picture of the signing of the Declaration of Independence of the United States of America, surrounded by the national flags of different nations, substantially as described, and shown in the accompanying illustration.

3. The design for a fan having on the central portion of one side a representation of the United States coat of arms, Putnam's flag, the national flag of the United States, and the portraits of Presidents Washington and Grant, the same being surrounded by the portraits of the intervening Presidents, and on the other side a picture of the signing of the Declaration of Independence of the United States of America, surrounded by the national flags of different nations, substantially as described, and shown in the accompanying illustration.
