DESIGN FOR PEN-RACKS.

Specification forming part of Design No. 9,142, dated March 14, 1876; application filed February 16, 1876.

[Term of Patent 7 years.]

To all whom it may concern:

Be it known that I, OTTO F. FOGELSTRAND, of Kensington, in the county of Hartford and State of Connecticut, have invented and produced a new and original Design for Pen-Racks, of which the following is a specification:

The nature of my design is fully represented in the accompanying drawing, to which reference is made, and in which—

Figure 1 is a perspective view of a pen-rack of my design; and Fig. 2 is a like view of a pen-rack, in which the pen-supporting arms are ornamented in the same manner as the corresponding parts in Fig. 1.

A A represent the bases of the rack, the contour of which bases is composed of straight and curved lines, each end of said bases being dropped a little to form feet, as shown. The sides of A are bordered by a plain ledge, within which, at the center, there is a disk-shaped projection, upon each side of which there is ornamental scroll-work on a roughened ground. Extending upward from the bases A A are the pen-supporting arms BB, the parts A A and B B being connected by rods C C. The sides of the arms B B are bordered by a raised ledge, and from the ledge, at the lower edge, branch ledges extend upward across the arms, and project at the upper side, at which point they are enlarged into a cluster of curved figures, forming hooks a. Shoot-

ing out from the main branches are smaller branches, bearing leaflets, thereby giving the ledge upon the lower side of the arms and its branches the appearance of a growing vine. The sunken groundwork of the arms, between the ledges and branches, has a roughened surface. At the junction of the parts A B, upon the inside, I form scroll-braces and leaflets, as shown. In Fig. 2 the arms B B, although double, and of a different contour from the same parts in Fig. 1, are ornamented in the same manner, having the hooks a and leaflets all of the same vine-like appearance above described.

I claim as my invention-

1. The design for a pen-rack, in which the arms B B and hooks are composed of a sunken ground, ornamented by ledges and branches in vine-like form, substantially in the manner shown and described.

2. The design for a pen-rack, composed of the bases A A, ornamented by a raised border, sunken and roughened and raised scrollwork, and arms B B, ornamented by ledges and branches in vine-like form, substantially in the manner described, and as shown in Fig. 1.
