## DESIGN FOR A BADGE.

Specification forming part of Design No. **9,168**, dated March 23, 1876; application filed March 13, 1876.

[Term of Patent 3½ years.]

*To all whom it may concern:*

Be it known that we, WILLIAM SCULLY and PIERRE A. DUFOUR, of St. Paul, in the county of Ramsey and State of Minnesota, have invented a new and original Design for Badge, of which the following is a specification:

The nature of our design is fully represented in the accompanying photographic illustration, to which reference is herewith made.

The object of our invention is to furnish to visitors to the Centennial Exposition a neat and elegantly-designed badge, by which the State or country they hail from may be readily recognized; and it consists of a ribbon of suitable color, with a scroll and monogram of the letters "U. S." at the top, a shield mounted with a top ribbon, and an eagle above the ribbon, and the Liberty Bell being suspended at the lower part of the shield.

In the illustration, A represents the ribbon for our badge, which may be made of any desired color, or in the colors of the nation represented, or in imitation of the American flag, or otherwise. At the top end of the ribbon is arranged a scroll, B, passing over monogram of the letters "U. S." A shield, C, with a lateral top band or ribbon, D, and the American ea-

gle perched above the same, and the Liberty Bell of Independence Hall hung to the lower part of the shield, is arranged in the central part of the ribbon, and provided, as well as the top scroll, with suitable inscriptions, indicating the names of the State or country from which the visitor comes, and the Centennial character of the badge. The top scroll and shield, with attachments, are stamped out of suitable sheet metal, and finished in appropriate manner to form a tasteful badge, and afterward a reminiscence of the Centennial Exhibition.

We claim as our invention—

1. The design for a badge, composed of the ribbon, with top scroll and monogram, and of a shield having the top band and eagle above, and Liberty Bell below, substantially as described and shown.

2. The design for a badge, composed of the shield, with a band or ribbon and eagle at the upper part, and the Liberty Bell at the lower part thereof, substantially as described and shown.
