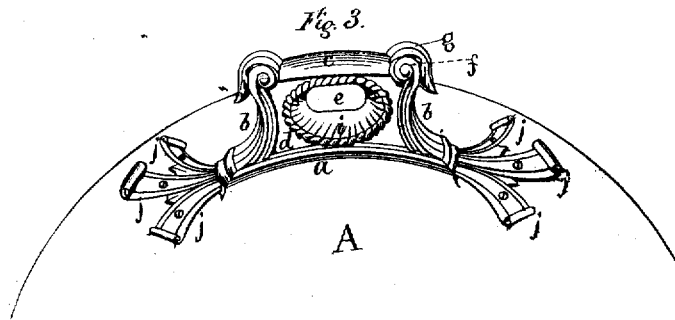
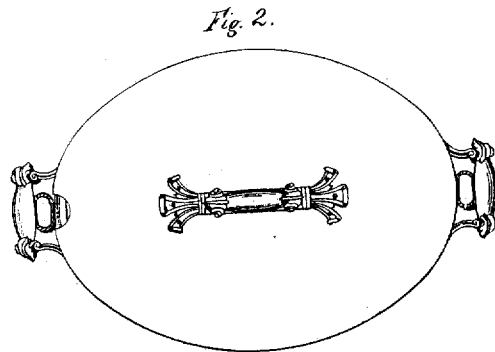
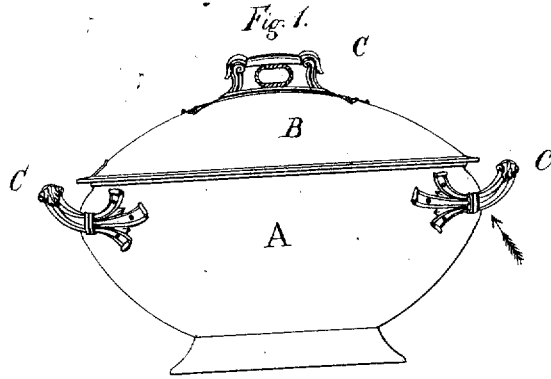

## DESIGN FOR HANDLES FOR TEA-SETS.

Specification forming part of Design No. **9,385**, dated July 11, 1876; application filed May 16, 1876.  
[Term of Patent  $3\frac{1}{2}$  years.]

*To all whom it may concern :*

Be it known that I, EDWIN HAVILAND, of the city of Brooklyn, in the county of Kings and State of New York, have invented a certain new and useful Design for Handles for Dinner, Tea, and Toilet Sets; and I do hereby declare that the following is a full, clear, and exact description of the same, reference being had to the accompanying drawing, which forms a part of this specification.

The object of this invention is to produce a new and original design, of an ornamental character, for the handles of dishes, such as breakfast-sets, dinner-sets, tea-sets, and toilet-sets.

The accompanying drawing illustrates the design—

Figure 1 being a side elevation of a vegetable dish provided with my ornamental handles. Fig. 2 is a plan or top view of the same; and Fig. 3, a view of one of the end handles when looking in the direction indicated by the arrow in Fig. 1.

The handles are shown as applied to each end of the dish A, and to the top of the cover B, in the usual way. C designates the handle, the general shape of which is that of an oblong, having a base, *a*, which is secured to

the dish A, or cover B, and having curved end pieces *b*, and an overhanging coping, *c*. These features define a parallelogram-like panel, *d*, which is provided with recesses or a through-and-through opening, *e*. I provide the tops of the curved end pieces *b* with a scroll-like finish, *f*, and surmount each of the same with an ornamental leaf, *g*, and I also provide the coping *c* with a rounding upper surface, and I preferably provide the opening *e*, whether it be entirely through or but part way through the panel *d*, with an ornamental rope-like edging, *i*, and I also preferably provide the base *a* at its end with ornamental diverging tongues *j j j*, which lie upon the dish as if holding the handle thereto.

What I claim as my invention is—

A design for the handle of a dish, consisting of a base, *a*, the curved end pieces *b b*, having a scroll-like finish, *f f*, the coping *c*, with its rounding top, and the panel *d* with its opening *e*, all with or without the leaves *g*, and edging *i*, substantially as herein shown and described.
