

DESIGN FOR INKSTAND AND MATCH-SAFE.

Specification forming part of Design No. 9,843, dated March 6, 1877; application filed February 17, 1877. [Term of Patent 7 years.]

To all whom it may concern:

Be it known that I, OTTO F. FOGELSTRAND, of New Britain, in the county of Hartford and State of Connecticut, have originated and designed a new and original Design for an Inkstand and Match-Safe, of which the following is a full, clear, and exact description, reference being had to the accompanying engraving, making part of this specification.

The nature of my design is fully represented in the accompanying engraving, to which

reference is made.

A A represent two ink-wells; B B, the covers; C, the base, and D the cover of the matchreceptacle. The base is a six-sided figure in top view, four sides of which are straight and two curved, the latter being concave, and placed at the right and left of the front, as shown. This base rests upon five legs, one of which is plain, and four of which (represented by a) are ornamented by a raised border at their sides and base, and at the top by a row of circular elevations, the space inclosed by said border and elevations being vertically fluted, as shown. The parts forming the remaining portion of the sides of the base are ornamented in substantially the same manner as described in another application of even date herewitn.

The top of the base has two ink-well depressions—one at each end—and at the front, between the two curved sides of the base, is a match-receptacle, of which D represents the cover. The surface of the top not included by said receptacle and ink-wells is ornamented by both raised and sunken ornaments.

The match-receptacle cover D is bordered by a ledge, ornamented by intersecting straight lines. Parts of the spaces inclosed by said intersecting lines are covered by transverse bars, all as shown. In the center of the cov-

er is a cone-shaped handle, and branching out from its base there are raised ornamental scrolls, leaves, and flowers on a roughened ground.

The covers B B have a circular base, and the main portion of their sides is an octagonal truncated pyramid. The lower corners of the pyramid are cut off as they merge into the circular base, so that each side forms a sixsided figure, as shown. These eight six-sided sides are bordered each by a raised ledge, the space inclosed thereby being provided with a raised ornamental figure on a roughened ground. Above the truncated pyramid is a circular neck surmounted by a cone.

I claim as my invention—

1. In an inkstand, the design for the covers B B, having a circular base and pyramidal octagon sides, substantially in the manner above described.

2. In an inkstand, the design for the base C, of the contour described, having two inkwell depressions and match-receptacle in the top of said base, substantially in the manner described.

- 3. In an inkstand, the design for the legs a, ornamented by a raised border upon their sides and base, and at the top by a row of circular elevations, and fluted surface inclosed by said border and elevations, substantially in the manner above described.
- 4. In an inkstand, the design for the matchreceptacle cover D, ornamented by the border of intersecting straight lines, the central handle, and branching raised ornaments on a roughened ground, substantially in the manner above described.
