DESIGN FOR A BADGE.

Specification forming part of Design No. 10,054, dated June 12, 1877; application filed May 14, 1877. [Term of Patent 14 years.]

To all whom it may concern:

Be it known that I, Rosto O. Wood, of Buffalo, in the county of Erie and State of New York, have originated and designed an Emblem; and I do hereby declare that the following description of my said invention, taken in connection with the accompanying sheet of drawings, forms a full, clear, and exact specification, which will enable others skilled in the art to which it appertains to make and use the same.

This design refers to a badge adapted to be used by the members of the Ancient Order of United Workmen; and it consists of an escutcheon or shield, whose chief points are covered by a ribbon or band, within which are inscribed the initial letters "A. O. U. W.," divided by the head of an outspread pair of compasses into two portions. This pair of compasses, whose head is in the middle chief point of the shield, rests with its points upon the two extremities of a square whose angle is in the middle base-point of said shield. From the chief point rays of light are flowing downward, and upon a heart occupying the honor-point, within which are inscribed the initial letters "C. H. P.," and the pictorial representation of an anchor.

The heart-point is occupied by a level, and the navel-point by a plumb, while in the dexter and sinister sides are placed an ax and a trowel, respectively, all these various tools being the symbolic working-tools of the order. The lower half of the escutcheon is striped to represent the national colors of the Union. This, however, as well as the particular location of the various symbolic implements, may be varied at pleasure, and the stripes omitted, if desired, without changing the nature of my invention.

The design is to be produced of either precious or inferior metal, in the form of a pin, a watch-chain charm, or other jewelry, as worn by persons in various customary manners, or it is imprinted or otherwise wrought into or upon a ribbon to be worn as a badge, which latter form I have illustrated in the accompanying sheet of drawings.

Having thus fully described my invention, I desire to secure to me by Letters Patent of

the United States-

The design for a badge, consisting, essentially, of a shield, within which are inscribed the initial letters "A.O.U.W.," a compass, square, a heart with the letters "C.H.P.," and an anchor and an ax, a trowel, spirit-level, and plumb, the whole arranged substantially in the manner described and shown.
