

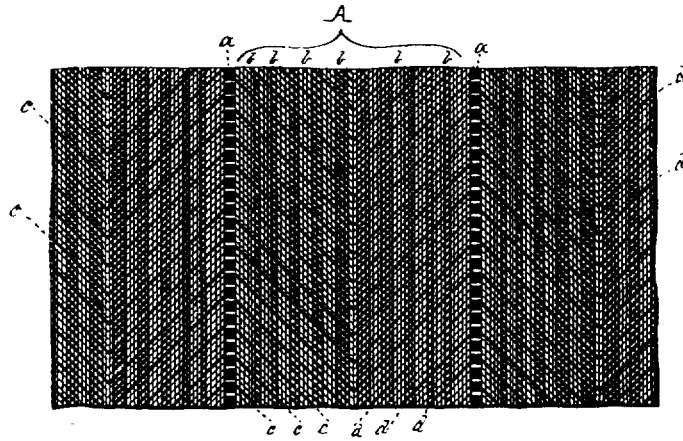

## DESIGN FOR FANCY CASSIMERES.

Specification forming part of Design No. **10,058**, dated June 19, 1877; application filed June 5, 1877.  
[Term of Patent 14 years.]

*To all whom it may concern:*

Be it known that I, PATRICK MCGEE, of Blackstone, in Worcester county and State of Massachusetts, have invented a new Design for Fancy Cassimeres; and I do hereby declare that the following specification, taken in connection with the drawing forming a part of the same, is a full, clear, and exact description of my said design.

The distinctive peculiarity of my design for fancy cassimeres consists in the novel composition of a complex longitudinal stripe.

Referring to the drawings, A denotes the complex stripe, bounded on each side by a solid line or stripe, *a*, composed, preferably, of worsted or silk, and tied into the fabric at short intervals. This stripe may be of a color contrasting with the color of the body of the fabric, or it may be of the same color, and a contrasting effect will be afforded by reason of the shading due to the glossy surface of the material employed therein. Between the boundary-stripes are a series of lighter stripes, as at *b*, which, preferably, are graduated in width from the sides inward, the inner stripes being somewhat wider than those next the boundary-stripes *a*. These intermediate stripes are diagonally crossed by two separate series of diagonal lines or stripes, as at *c* and *d*,

which, in each instance, extend from the boundary-stripe toward the center of the complex stripe, at which point each diagonal line *c* intersects with the opposite diagonal line *d*.

The optical effect produced by the combination of these several lines or stripes is maintained by me with variety in coloring and in weaving, and my design is brought out with more or less distinctness to suit the varied tastes of the trade.

The particular fabric in which my design will be generally embodied will be woven in accordance with a novel mode of weaving, which I believe to be new, and which will constitute the subject of separate application for Letters Patent.

I claim as my invention, and desire to secure by Letters Patent—

The design for fancy cassimeres embodied in the complex stripe A, composed of the longitudinal boundary lines or stripes *a*, the intermediate longitudinal stripes *b*, and the two series of diagonal lines *c* and *d*, substantially as shown and described.
