DESIGN FOR PARLOR-TABLES.

Specification forming part of Design No. 10,092, dated July 10, 1877; application filed June 16, 1877. [Term of Patent 3; years.]

To all whom it may concern:

Be it known that I, PHILIP P. KUEHBORTH, of the city of Buffalo, in the county of Erie and State of New York, have originated a new Design for Parlor-Tables, of which the following is a full, clear, and exact description, reference being had to the accompanying engraving, making part of the specification.

My design consists of the ornamentation of the top, and the configuration and ornamentation of the legs and connecting parts, of a parlor-table, as will be hereinafter fully set forth.

A represents the top of the frame, made of rectangular form with blunt corners, and B the slab covering the same. The sides and ends of the top A are provided at the center with a depending band or festoon, a, embellished with a row of angular or pointed ornaments, as clearly shown. The spaces above the festoon a, and between the latter and the corners of the top A, are provided with engraved or sunken ornaments, and the blunt corners have an eight-leaved ornament, b, the leaves of which are disposed in an oblong form, as clearly shown.

C represents the legs of the table, having their upper portions made perpendicular, and their lower portions inclining outwardly. D is a rectangular tablet or platform, connecting the legs C at the points where the perpendicular portions thereof join their lower inclined portions. It is provided on its sides with angular or pointed ornaments, similar to the ornaments on the festoons a. d are inclined

bars, arranged on the rear side of each leg C, and connecting by means of their upper round ends with an inwardly-projecting protuberance of each leg, while the lower ends of the bars d terminate in foliage overlapping the sides of the legs C, as clearly shown. e is an upwardly-projecting scroll-shaped ornament, arranged in the angle formed by the inclined bar d and tablet D, and provided at its upper end with a depending bell-shaped flower or ornament, f. The legs C, inclined bars d, and scrolls e, are provided with engraved or sunken ornaments in an ordinary manner.

What I claim as my invention is-

1. The design for the top A, having the festoons or depending bands a, provided with pointed ornaments, and the corner ornaments b, substantially as shown and described.

2. The design for the legs C, having their upper portions made perpendicular, and their lower portions inclining outwardly, and provided on their rear side with inclined bars d and scrolls e, substantially as shown and described.

3. The design for a parlor-table composed of the top A, provided with festoons a and corner ornaments b, the legs C, provided with inclined bars d and scrolls e, and the tablet D, arranged and ornamented substantially as shown and described.
