

#### DESIGN FOR CLOCK-CASES.

Specification forming part of Design No. 10,094, dated July 10, 1877; application filed May 21, 1877. [Term of Patent 7 years.]

To all whom it may concern:

Beitknown that I, HERMANN J. MÜLLER, of the city, county, and State of New York, have invented a Design for a Clock-Case, of which the following is a specification:

The nature of my design is fully represented in the accompanying photographic illustration, to which reference is made.

Similar letters of reference indicate corre-

spouding parts.

A represents the base of the case, which inclines to the rearward, and has offsets formed in it at the corners of the door-frame. Above the base A is a shoulder, B, and a narrow vertical part, C. Above the part C is formed a projecting portion, D, which, for about twothirds of its height, inclines forward, and for the other third inclines rearward. Above the portion D is a shoulder and a narrow vertical portion, E, above which the portion F projects and inclines to the rearward, becomes narrower, and extends up to the cornice G. which projects and is made up of curved and inclined surfaces and shoulders. Above the cornice G the part H of the case is curved to the rearward to the top, upon which stands a hunter in the position of rapid walking, with his body bent forward and looking earnestly into the distance. The legs and upper part of the body of the hunter are naked, the skin

of an animal is tied around his waist, and his hair hangs down upon his shoulders. The left arm is bent upward and forward, and the hand grasps a bow and arrow. The right hand rests upon the neck of a dog. The dog is in the position of rapid walking, has his ears erect, and is looking watchfully into the distance. The door of the case is square in its lower part, has its upper part arched and scalloped, and has a circle of sunken armaments around the face of the clock. The si le and base parts of the door, the side parts of the case, and the cornice are ornamented with sunken and raised ornaments. The side parts of the case incline to the rearward laterally, giving the case the appearance of an octagonal pedestal, with a clock standing in front of its forward side.

Having thus fully described my invention, I claim as new and desire to secure by Letters Patent-

The combination of the inclined base A, parts B C D, portions E F, cornice G, and surmounting part H, all constructed and arranged as shown and described, to form a new design in clock-cases.
