DESIGN FOR COOKING-RANGE.

Specification forming part of Design No. 10,248, dated September 11, 1877; application filed August 1, 1877.

[Term of Patent 7 years.]

To all whom it may concern:

Be it known that we, NICHOLAS S. VEDDER, of the city of Troy, county of Rensselaer, and State of New York, and Tobias S. Heister, of the village of Lansingburg, same State and county, have invented a new and Improved Design for the Ornamentation of a Cooking-Range, of which the following is a specification:

The nature of our invention of a design consists in the form and ornamentation of the several parts of a cooking-range, as we illustrate and describe them, separately considered; and, also, in the aggregation of these elements to form a design for a cooking-range in their combination.

These separate elements and features of invention consist of—

First. The ornamentation employed, as shown in the annexed illustration, upon the doors and panels of a range, and as designated at D D D D D, and with detailed reference, as to composition, at D" and D", and composed of the beveled band-molding, oval molding, and intermediate fillet formed upon the edge of the door, as shown at a; the bordering flat molding, ornamented with chain-work, and having quatre-foil figures where the links connect, and a fringed horizontal cross within the chain-links, and a Maltese cross at the corners, inclosed within a square, with a bar finish at the side of each of the chain-links; the projecting molding c, bordering a relief-panel formed upon the door and inside of the chainornamentation; the line p, traced upon the edge of the relief-panel, and parallel to the molding which incloses it, with the line fretted at the corners; and a halberd figure placed in the notched corner angles of the line, the latter being looped at the sides, as shown at D", or, as shown at D", without the side loops and halberd figure in the corner notches.

Second. As a separate feature, our invention also consists of the ornamental medallion displayed upon the oven-door, as shown at C, and this is composed of a circular beaded molding inclosing a plain field, and upon which is constructed, in relief, the figure of a lion rampant, and with a wreath grasped in the paw of the animal so shown. While we have

shown this as applied to the oven-door of the range, the same figure may be applied to any other panel or part of a stove or range to produce the same ornamental effect.

Third. Our invention also consists of another separate feature, as illustrated in the curved and mitered molding which separates the warming-closet section from the oven-section, as shown at F, and as curved underneath the reservoir-bracket at F", mitered and curved around, and at the corners F". This molding is formed by the two obtuse sections of band, with intermediate and bottom fillet.

Fourth. Our invention of a design also consists, as a separate feature, in the ornamentation of the front hearth upon its upper surface. This is composed of the arabesque tracery at each end of the hearth and the intervening display of the trade-name of the range, "The Steward," as shown at A A, although any other name may be displayed in the same style and associate ornamentation to produce the same effect.

Fifth. Our invention also consists, separately considered, of the ornamental form and surface ornamentation of the feet of the range; and this is composed of the fronting ogeomolding, mitered so as to produce three faces obtusely angular to each other, each of which faces is bordered by a line parallel to the miter-lines at the sides and to the molding at the top and bottom. Upon the middle face there is displayed an initial letter, the whole as arranged being shown at E.

Sixth. Our invention of a design also consists, in combination, of the ornamentation of the door-panels, as shown at D, D", and D""; the ornamental medallion C upon the ovendoor; the curved and mitered molding F, F", and F", and the ornamentation of the feet, (shown at E,) as the same are shown as applied to a cooking-range in the annexed illustration.

Having thus described our invention of a design, and the separate elements of which it is composed, what we claim, and desire to secure by Letters Patent, is—

tion a, the molding c, and the bordering fretted line upon the panel, as shown at D", and as herein described.

2. The design for the ornamentation of a stove or range oven door, consisting of the medallion center and lion, as the same is designated at C, and as herein described.

- 3. The design for the curved, mitered, double-beveled, and filleted molding which divides the oven-section from the warming-closet section, as shown at F F" F", and as herein described.
- 4. The design for the ornamentation of the front hearth of a cooking-range, and composed of the arabesque ornamentation at the ends and the intervening display of the trade-name of the stove, as shown at A A, and as herein described.
- 5. The design for the ornamental form and ornamentation of the feet of a stove or range, and composed of the obtusely-mitered ogee

front and surface ornamentation, with a letter displayed upon the front surface of the mitered exterior, as shown at E E, and as herein described.

6. The design for the ornamentation of a cooking-range, consisting of the ornamentation of the doors D D" D", the ornamental medallion C upon the oven-door, the curved and mitered double-beveled molding F, the ornamentation of the front hearth A A, and the ornamental form and ornamentation of the feet E E, arranged as herein shown and described.
