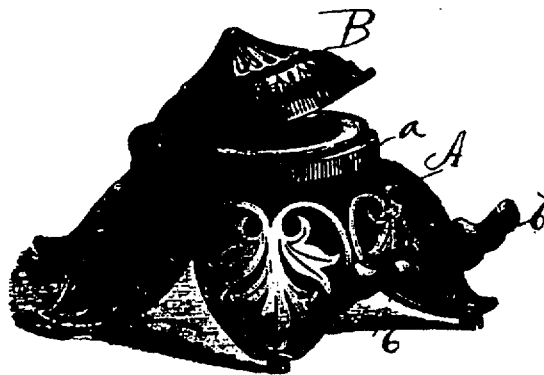

## DESIGN FOR INKSTANDS.

Specification forming part of Design No. **10,397**, dated January 8, 1878; application filed December 6, 1877.  
[Term of Patent 7 years.]

*To all whom it may concern:*

Be it known that I, OTTO F. FOGELSTRAND, of New Britain, in the county of Hartford and State of Connecticut, have originated and produced a new and original Design for an Inkstand, of which the following is a full, clear, and exact description, reference being had to the accompanying engraving, making a part of this specification.

A designates the body of the inkstand, and B the cover. Surrounding the well is an annular band, *a*, with fluted sides, as shown. Below said band the body A is in spherical form for a short distance, from which it is divided by segments of a sphere or pointed extensions, giving it the appearance of an expanded burr. Each of these divisions or pointed extensions is bordered by a plain raised ledge, which ledge also extends upward on the undivided portion of the body, and curves inward on each side, so as to form a heart-shaped figure, inside of which there are numerous raised leaflets with sunken veins.

The lower ends of the pointed extensions are rolled over outward and slightly upward, and are supported or mounted on short legs placed under the curved portion of the extension-lips, as shown. The ground of the body above the heart-shaped figures is roughened, as shown.

On each side of one of the pointed extensions curved arms *b b* are placed, at the junction of said extension and those on each side of it. The contour of the arms *b b* is clearly shown, and their sides are ornamented with depressed ornaments, as shown.

The general design for the body, consisting of an expanded burr, may be followed without following the peculiar ornamentation herein described.

The base of the cover B has a fluted edge,

and a profile of one side, above its base, consists, first, of a quarter-round, second, a narrow band, and, third, a core, the latter reaching the middle of the cover, so that all sides form a pointed top, the sides of which are fluted and its base scalloped. The narrow band also has fluted sides, and the quarter-round is cut out near its base, so as to leave raised and pointed ornaments, above which are depressed ovals and arrow-heads pointing upward.

I claim as my invention—

1. In an inkstand, the design for the body, consisting, essentially, of a spherical body divided by pointed extensions in the form of an expanded burr, substantially as described.

2. In an inkstand, the design for the base of the body and legs, consisting of the tips of the pointed extensions turned outward and upward, and mounted on the short legs, substantially as shown and described.

3. In an inkstand, the design for the face of the pointed extensions, consisting of the raised ledge in the form of a heart inclosing raised leaflets, substantially as described.

4. In an inkstand, the design consisting of the annular band *a*, with fluted sides, the body with its roughened ground, the pointed extension with heart-shaped border and raised ornaments, and the curved bars *b b*, one on each side of one of the pointed extensions, all substantially as described.

5. In an inkstand, the design for the cover B, with its pointed and fluted top, fluted narrow band, and fluted base, substantially as described.
