DESIGN FOR AN UMBRELLA-HANDLE.

Specification forming part of Design No. 10,783, dated August 20, 1878; application filed July 3, 1878. [Term of patent 31 years.]

To all whom it may concern:

Be it known that I, AMASA LYON, of the city, county, and State of New York, have originated a new Design for Handles of Umbrellas and Parasols, of which the following is a full, clear, and exact description, reference being had to the accompanying photographic illustration, making part of this specification.

A represents the handle of an umbrella or parasol; and B, a pug's head, carved out thereon, to form an ornamental knob at the extrem-

ity thereof.

This design of a pug dog's head is carved out of a piece of fine white wood, to serve as the end of the handle. The ears of the dog are represented as closely cropped. The eyes are of glass, properly secured in the sockets. The ears are lined, and the face, jaws, top of head, back of neck, and a mole, C, on one cheek, are shaded a tawny or brown color by slightly burning or charring the white surface of the wood. The whole effect of the dusky tint of the shading, in contrast with the delicate tint of the wood and the brilliancy of the glass eyes, is natural and artistic, and the design applied as set forth to the purpose named is very attractive and ornamental.

A neat finish is given to the head, and the beauty of the design is enhanced by the addition of a neat silver, silvered, or other metallic collar, D, fitted with a ring, E, and bell

F, and properly secured in place about the neck of the pug, as shown in the accompany-

ing illustration.

I am aware that it has long been customary to make handles of umbrellas and parasols in the forms of animal's heads of various kinds, and hence my present application for Letters Patent relates solely to a design of special form and character, substantially as herein set forth.

I claim as my invention—

1. The design for an umbrella or parasol handle consisting of a representation of a pug dog's head, having eyes and cropped cars, and shaded in contrasting colors, substantially as described, and shown in the accompanying illustration.

2. The design for an umbrella or parasol handle consisting of a representation of a pug dog's head, with a metallic band or collar, D, substantially as described, and shown in the

accompanying illustration.

3. The design for an umbrella or parasol handle consisting of a representation of a pug dog's head, having upon the cheek the mole C, substantially as described, and shown in the accompanying illustration.
