

DESIGN FOR HEATING-STOVES.

Specification forming part of Design No. 10,923, dated November 26, 1878; application filed November 2, 1878, [Term of patent 7 years.]

To all whom it may concern:

Be it known that I, CHAUNCEY H. CASTLE, of Quincy, in the county of Adams and State of Illinois, have invented and produced certain new, useful, and original Designs for the Manufacture of Stoves, of which the following is a specification:

In the accompanying cut is shown, in perspective, a stove embodying the novel points or features in the present design.

This stove is of that class well known to

the trade and in the market as the "Todd stove."

The stove is mounted on four legs, a, each of which has a generally—that is, slightly—curved shape or outline, and on the face, near the top, has a prominent ornamental design or figure, a. These legs are placed under the base-plate b about at the corners of the stove-body. The edges of this base-plate are beveled, and may be nickel-plated or ornamented. On the hearth part is the draft-plate c, which is suitably ornamented in lines and designs to correspond in style with those on the other

parts of the stove.

The front and rear vertical plates d and e of the stove are of a generally semi-elliptical shape, and each carries on its apex an ornament, f. Near the outer edge of the front plate d is a molding, and within this a series of ornamental designs and figures. The door g corresponds in style and shape to the front plate d. The edge of this door is beveled, and above this bevel is a line of bead-and-rope ornamentation. The mica-frame on the face of the door g has proper designs on it to conform to the general style of the other figures and ornaments on the stove.

The side plates h are somewhat curved to conform to the shapes of the front and rear plates. All around the border are raised lines, and within these is another series having its inner edge decorated, and between these two series of lines are suitable figures and ornaments. On the field inside the inner series,

and at the corners thereof, are ornaments in spray and scroll work. Centrally on this field is an ornamental shield or boss, i, having the word "Style" upon it. Above the upper edge of this plate h is an inclined horizontal band or strip, k, having at its base a strip, k', in serrated ornament. At the top of this band kis the flat upper plate of the stove, on which stands, about midway between the front plate and the stove-collar, the urn l. This urn has a broad base, and its upper part or cup has handles on its sides. The base and whole exterior of the urn is suitably ornamented in unison with the decoration of the other parts of the stove. The cover of this urn is of ornamental shape, and in harmony with the body of the arn.

Having thus set out and explained the novel designs and ornamentation of this stove, what I wish to cover and protect by Letters Patent is—

1. The design for the front plate d, of the shape described and shown, and having designs and ornamentations, as set out and explained.

2. The design for the front plate d, with ornament f, in combination with the design for door g and draft-plate c, as shown and described.

3. The design for the plate h, with the decoration and ornamentation, as shown.

4. The side plate h, ornamented as shown, and having the central shield or boss bearing the ornamental word "Style," as shown and described.

5. The design, as shown and described, for this stove as an entirety.
