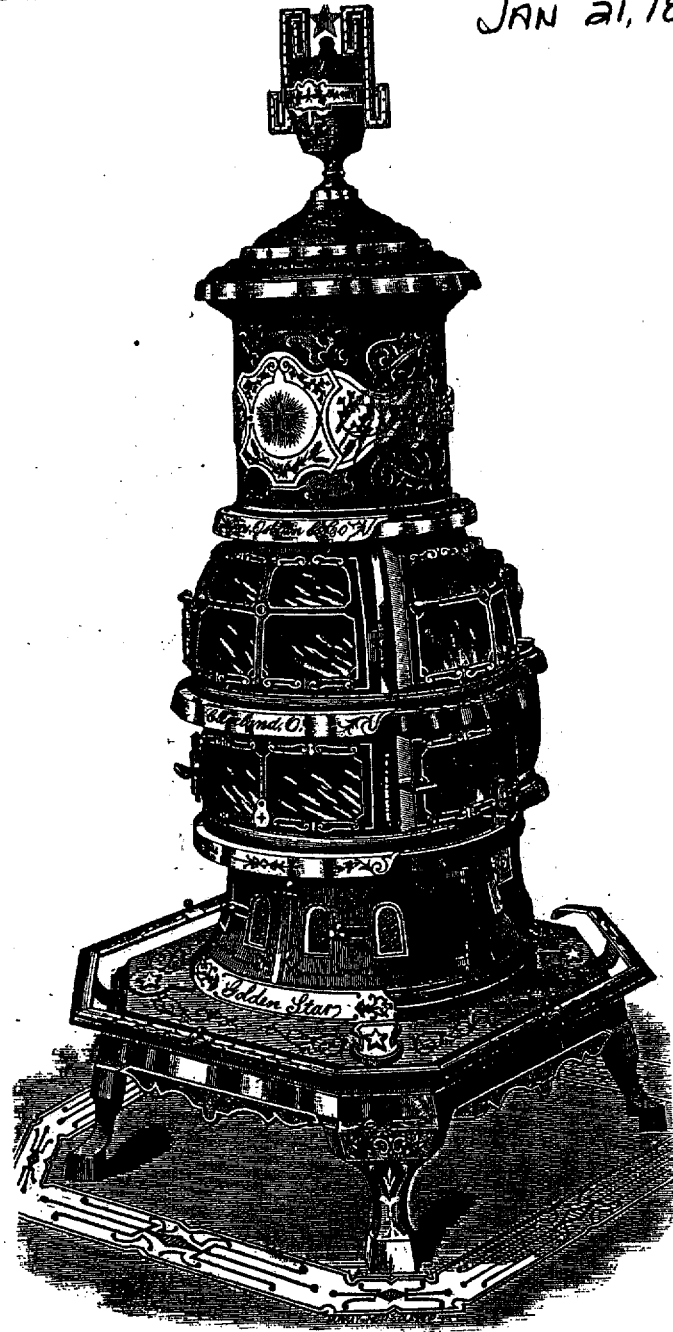

## DESIGN FOR STOVES.

Specification forming part of Design No. **10,985**, dated January 21, 1879; application filed November 23, 1878.  
[Term of patent 7 years.]

*To all whom it may concern:*

Be it known that I, JOHN VAN BUSKIRK CARTER, of Cleveland, in the county of Cuyahoga and State of Ohio, have originated and designed a new Fashion for Stoves, of which the following is a full, clear, and exact description, reference being had to the accompanying illustration, making part of this specification.

A is the body of the stove, around which is formed, or in any manner placed, a belt or zone, B. This belt or zone may or may not be an independent structure; but I prefer that it should be given that appearance. Its shape or configuration is substantially such as shown in the drawing, the front or central portion of the belt being in the form of a shield, while the sides are of less width, and each in the form of a band, with a central portion thereof of greater width than the parts on either side of the same. This belt or zone is of a much lighter color than the body of the stove about which it is placed, and is thus designed to give a brighter appearance, and hence a more attractive aspect, to the stove. The same is ornamented by figures and fancy work of a darker color. Said figures and fancy work consist of leaves formed on each side of a central design, which latter is in the front portion of the belt, and is itself provided with leaves formed above and below a star occupying the central and prominent position thereon, the light groundwork of the belt or zone constituting, in connection with the ornamental figures wrought thereon, a very at-

tractive design. This star C is of a gilded or golden appearance, and may be omitted from the zone or belt, if so desired. Said belt or zone may encircle the body of the stove either partially or wholly at any suitable portion thereof.

I also prefer ornamenting the body of the stove upon which the belt B is placed with a series of scrolls, D, the surface of each of which has parallel lines or corrugations running at different angular inclination relatively to the lines of the surrounding scroll. The reflection of light, respectively, from the several scrolls thus designed will be relatively different and varying, thereby giving an attractive appearance. The groundwork upon which said scrolls are formed may be made smooth or faced with parallel corrugations.

What I claim as my design is—

1. A design for a stove in which the band or zone B, either partially or entirely surrounding the body of the stove, and of a lighter color than the same, is shaped and formed as shown and described.

2. A design for a stove in which the belt or zone B, formed as described, is provided with one or more stars of a golden or gilded appearance, substantially as set forth.
