DESIGN FOR CARPET.

Specification forming part of Design No. **11,061**, dated March 11, 1879; application filed February 12, 1879.
[Term of patent $3\frac{1}{2}$ years.]

To all whom it may concern:

Be it known that, HENRY HORAN, of East Orange, in the county of Essex and State of New Jersey, have originated and designed a Pattern for Carpets and other Fabrics, of which the following is a full, clear, and exact description, reference being had to the accompanying photographic illustration, making part of this specification.

The accompanying photographic illustration represents a face view of my new design.

This invention relates to a new and original design for carpets, oil-cloths, and similar fabrics.

It consists of the new ornamentation and arrangement of parts hereinafter more fully pointed out.

a b are two large oblong rectangular figures arranged diagonally opposite each other, and made preferably of the same ground color. Between these figures is arranged another smaller oblong figure, *d*, which partly overlaps the figures *a b*. Two other nearly rectangular figures, *e* and *f*, are arranged at two opposite corners of the figure *a*, partly overlapping such corners.

g is an irregular shield-shaped figure, formed between every pair of figures *b* and *a*, and overlapping the edges of such figures. The outline of the shield *g* is defined by two bouquets of flowers and leaves, *h i*, which begin at the bottom of the figure *g*, extend around the sides of the same, and join at the top. These bouquets extend also partly into the figures *a b*.

Another bouquet extends through the figure *a*, and a fourth bouquet ornaments the oblong figure *d*.

The oblong figure *e* is, by an oblique line, divided into two fields, and is also decorated by floral design, while the oblong figure *f* has a border, *j*, at one side, and contains likewise representations of flowers and leaves.

The background *A* of the carpet is made up of small geometrical patterns with leaves and flowers interspersed.

The figures *a b* also contain and are composed of small geometrical figures, as shown.

I claim—

1. The design for a carpet, consisting of the two rectangular figures *a b* and the oblongum *d*, the latter being placed between the figures *a b*, and partly overlapping the same, substantially as shown.

2. The design for a carpet, consisting of the figures *a b d* and of the irregular shield-shaped figure *g*, substantially as shown.

3. The design for a carpet, consisting of the rectangular figure *a* and of the oblong figures *e f*, the latter figures being arranged at two opposite corners of the figure *a*, partly overlapping such corners, substantially as shown.

4. The design for a carpet, consisting of the figures *a, b, d, and g*, and of the two bouquets *h i*, which partly define the figure *g*, substantially as shown.

5. The design for a carpet, consisting of the figures *a, b, d, e, f, and g*, and of floral decorations on such figures, substantially as shown.
