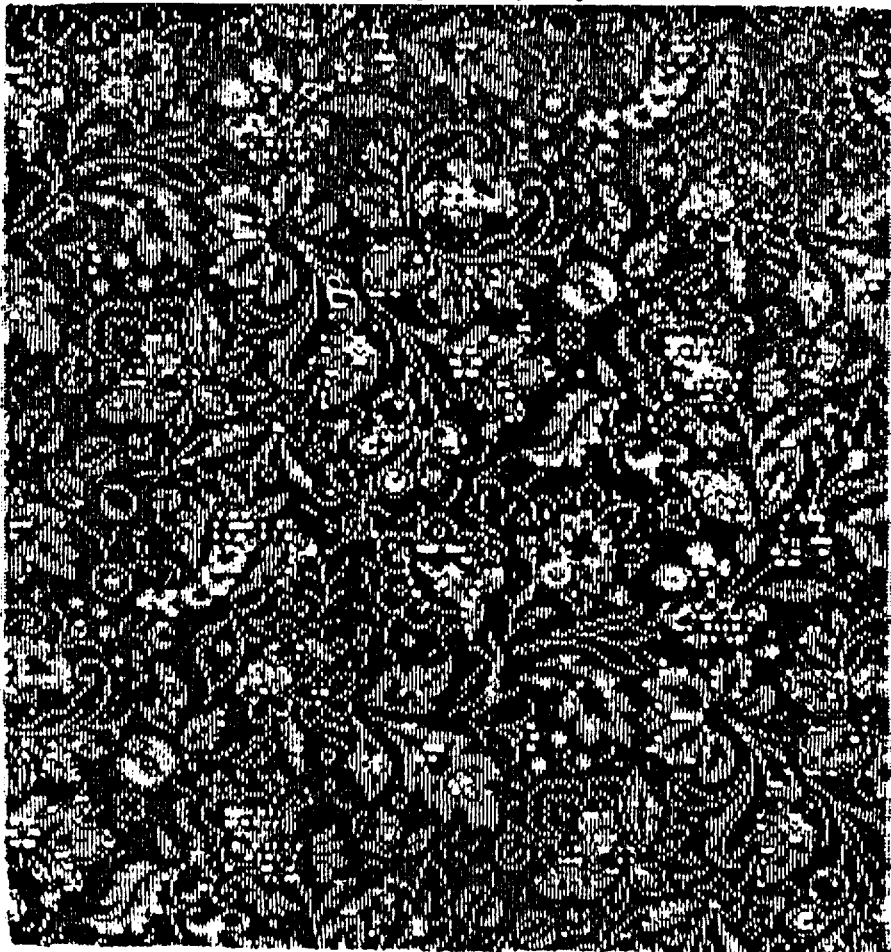

DESIGN FOR CARPET.

Specification forming part of Design No. **11,079**, dated March 18, 1879; application filed February 12, 1879.
[Term of patent 3½ years.]

To all whom it may concern:

Be it known that I, HENRY HORAN, of East Orange, in the county of Essex and State of New Jersey, have originated and designed a Pattern for Carpets and other Fabrics, of which the following is a full, clear, and exact description, reference being had to the accompanying photographic illustration, making part of this specification.

The accompanying photographic illustration represents a face view of my new design.

This invention relates to a new and original design for a carpet, an oil-cloth, or similar fabric.

It consists in the new arrangement and ornamentation of parts hereinafter more fully pointed out.

This design consists more particularly of three floral groups or branches, *a*, *b*, and *d*, hereinafter more fully described, and of which the groups *b* and *d* are arranged above the group *a*, and diverge at their upper ends.

Each of the groups *a*, *b*, and *d* is composed of ornamental leaves and flowers, and of other fanciful figures.

The group or branch *a* contains, aside of the leaves, two clusters, *e* and *f*, of which *e* is approximately pear-shaped, and *f* approximately fan-shaped.

The group or branch *b* has at its lower part a small rosette of leaves or calyx, *g*, and contains in conjunction therewith smaller minor ornamentations and a larger terminal cluster, *h*.

The group or branch *d* has likewise a rosette of leaves or calyx, *i*, and contains a cluster of buds, *j*, a fanciful fruit, *k*, and a fanciful flower, *m*. Between the groups or branches *b* and *d* is a large bowl-shaped ornament, *l*, surrounded by leaves and inclosing a shield.

The entire design is represented in suitable colors upon the background, and is of a rich appearance.

I claim—

1. The design for a carpet, consisting of the groups or branches *a*, *b*, and *d*, substantially as shown.
2. The design for a carpet, consisting of the group or branch *b*, rosette of leaves *g*, and terminal cluster *h*, substantially as shown.
3. The design for a carpet, consisting of the group or branch *d*, rosette *i* of leaves, cluster of buds *j*, fruit *k*, and flower *m*, substantially as shown.
4. The design for a carpet, consisting of the bowl-shaped figure, leaves, and shield, the leaves surrounding the figure *l*, and the shield being inclosed therein, substantially as shown.
5. The design for a carpet, consisting of the groups or branches *a*, *b*, and *d* and bowl-shaped figure *l*, substantially as shown.
