



Dear Judge Kotelly:

I have known Emerson Briggs for over ten years. He is married to my sister Linda Briggs. He is known as Uncle Rusty to my three children. He has been a part of our family since 1999 when he and my sister married.

Rusty has spent time with my wife, my children, and me as part of our family gatherings and holiday celebrations, birthdays, and other family occasions throughout the years. I recognize that some families only get together once or twice a year, but our family has always gotten together many times during the year, and Rusty has joined us on essentially all of these gatherings throughout his years of marriage to Linda. Additionally, Linda and Rusty have attended several religious events for our children, including First Communion and and Confirmations. They've always been a willing part of family celebrations. for birthdays, graduations, anniversaries and holidays.

In addition, he and my sister have occasionally taken them on special outings to celebrate birthdays, etc. My daughter now 18, has been to several sporting events with them, including professional baseball and soccer games, for example. My son now 20, has snow skied with them several times. They took my youngest daughter now 14, to a water park for one of her birthdays. All three have enjoyed visiting and playing in Linda and Rusty's backyard pool as well as boating, jet skiing and other recreational activities.

Throughout all this time, my wife and I have never had a concern for their safety or well-being while in their care. After we learned of the legal situation, we spoke with all three children separately, and all three affirmed that Uncle Rusty never did anything that was inappropriate. They continue to support him, and they say they wish to continue to be in communication with him, even if that means visiting him in a faraway prison. They love him, and they are willing to forgive him, believing that he has the strength of character to rehabilitate himself.
