1. Purpose. To approve relocating subject shore activity detachment per reference (a).

2. Background. Center for Security Forces (CENSECFOR) Detachment, on board Naval Air Station, Brunswick, ME, is relocating to existing facilities on Portsmouth Naval Shipyard, Kittery, ME. The detachment runs the Navy Survival, Evasion, Resistance and Escape (SERE) School and the administrative and academic training functions of the school are the portions relocating. Relocation to Kittery is due to NAS Brunswick being closed per direction of Base Realignment and Closure 2005.
