- ACTION
- 1. (U//FOUO) PER THE DIRECTOR OF INFORMATION ASSURANCE, THIS MESSAGE MUST BE SHARED WITH ALL HOLDERS OF THE STU-III AND SECURE TERMINAL EQUIPMENT (STE), AND ALL ASSOCIATED COMSEC CUSTODIANS.
- 2. (U//FOUO) NSA HAS RECENTLY RECEIVED A SIGNIFICANT NUMBER OF REPORTED COMPROMISES. AS A RESULT, IT IS IMPERATIVE THAT NSA DISSEMINATES UPDATED COMPROMISE INFORMATION TO THE ENTIRE STU-III AND STE USER COMMUNITY VIA THE PROPAGATION OF AN UPDATED COMPROMISED KEY LIST (CKL). THIS WILL BE ACCOMPLISHED VIA THE BLECTRONIC RE-KEY OF ALL STU-III AND STE TERMINALS (STU-III SIDE ONLY) WITH THE CENTRAL FACILITY (CF).

- 3. (U//FOUO) UPON RECEIPT OF THIS NOTICE, PLEASE ENSURE THAT ALL STU-IIIS (REGARDLESS OF MAKE OR MODEL) AND STE'S (STU-III SIDE ONLY) UNDER YOUR PURVIEW ARE ELECTRONICALLY RE-KEYED BY 19 OCT 2007. PLEASE ENSURE THAT TERMINALS DEPLOYED IN RESIDENCES AND OTHER REMOTE LOCATIONS ARE RE-KEYED AS WELL.
- 4. (U//FOUO) BE AWARE THAT BECAUSE A LARGE NUMBER OF RE-KEY CALLS WILL BE OCCURRING WITHIN THE NEXT THREE WEEKS, CALL HOLDING AND ELECTRONIC RE-KEY TIME MAY INCREASE, PLEASE STAGGER RE-KEY CALLS ACROSS YOUR ORGANIZATION, AND WHEN POSSIBLE, PLACE RE-KEY CALLS DURING OFF-PEAK HOURS (1800-0600 EDT WEEKDAYS AND ALL HOURS ON WEEKENDS), ADDITIONALLY, IT MAY HELP EASE CALL VOLUME IF CUSTOMERS ON THE EAST COAST RE-KEY EARLY IN THE MORNING AND CUSTOMERS ON THE WEST COAST RE-KEY LATER IN THE DAY. PLEASE NOTE THE RE-KEY SYSTEM WILL BE UNAVAILABLE FOR 30 MINUTES FROM 0600-0630 EDT ON MONDAYS, WEDNESDAYS AND FRIDAYS DURING THIS 3-WEEK PERIOD FOR SYSTEM MAINTENANCE. FROM 1 OCT 2007 THROUGH 19 OCT 2007, THE KEY SUPPORT CENTER (KSC), PREVIOUSLY KNOWN AS THE TECHNICAL ASSISTANCE CENTER (TAC), WILL EXPAND HOURS TO ACCOMMODATE INCREASED CALL VOLUME.
