Privacy Policy

Teach Me Law Enforcement is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Teach Me Law Enforcement Web site and governs data collection and usage. By using the Teach Me Law Enforcement website, you consent to the data practices described in this statement.

Collection of your Personal Information

Teach Me Law Enforcement collects personally identifiable information, such as your e-mail address, name, home or work address or telephone number. Teach Me Law Enforcement also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Teach Me Law Enforcement. This information can include: your IP address, browser type, domain names, access times and referring Web site addresses. Use of your Personal Information

Teach Me Law Enforcement collects and uses your personal information to operate the Teach Me Law Enforcement Web site and deliver the services you have requested. Teach Me Law Enforcement also uses your personally identifiable information to inform you of other products or services available from Teach Me Law Enforcement and its affiliates. Teach Me Law Enforcement may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Teach Me Law Enforcement does not sell, rent or lease its customer lists to third parties. Teach Me Law Enforcement may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is not transferred to the third

party. Teach Me Law Enforcement does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Teach Me Law Enforcement keeps track of the Web sites and pages our customers visit within Teach Me Law Enforcement, in order to determine what Teach Me Law Enforcement services are the most popular. This data is used to deliver customized content and advertising within Teach Me Law Enforcement to customers whose behavior indicates that they are interested in a particular subject area.

Teach Me Law Enforcement Web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Teach Me Law Enforcement or the site; (b) protect and defend the rights or property of Teach Me Law Enforcement; and, (c) act under exigent circumstances to protect the personal safety of users of Teach Me Law Enforcement, or the public.

Use of Cookies

The Teach Me Law Enforcement Web site use "cookies" to help you personalize your online

experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. For example, if you personalize Teach Me Law Enforcement pages, or register with Teach Me Law Enforcement site or services, a cookie helps Teach Me Law Enforcement to recall your specific information on subsequent visits.
