**NOTICE OF INTENT TO USE FOREIGN INTELLIGENCE
SURVEILLANCE ACT INFORMATION**

The United States of America, by and through its undersigned counsel, hereby provides notice to the Court and defendants, WALTER KENDALL MYERS and GWENDOLYN STEINGRABER MYERS, pursuant to Title 50, United States Code, Section 1806(c) and 1825(d), that the United States intends to offer into evidence, or otherwise use or disclose at pre-trial hearings, trial, and at other proceedings in this case, information obtained and derived from electronic surveillance and physical searches conducted pursuant to the Foreign Intelligence Surveillance Act of 1978 (FISA), as amended, 50 U.S.C. §§ 1801-1812 and §§ 1821-1829.

The United States will produce the discoverable FISA information to the defendant pursuant to a protective order that the United States will seek from the Court.
