References:

- a. Your Freedom of Information Act (FOIA) request of March 29, 2001, for records concerning Somalia Intelligence Services, ZF400104W. Your request was received in this office on April 18, 2001.
- b. Our letter of April 20, 2001, informing you that additional time was needed to review the records and we were unable to comply to the 20-day statutory time limit in processing your request.

We have conducted checks of the automated Defense Clearance and Investigations Index and a search of the Investigative Records Repository to determine the existence of Army intelligence investigative records responsive to your request.

We have located the enclosed records pertaining to Somalia Intelligence Services, ZF400104W. We have completed a mandatory declassification review in accordance with Executive Order 12958. As a result of this review, it has been determined that the Armyoriginated information no longer warrants security classification protection and is partially releasable to you. The records are enclosed for your use. Fees for processing this request are waived.

Since the release of the information deleted from the records would result in an unwarranted invasion of the privacy right of the individuals concerned, this information is exempt from the public disclosure provisions of the FOIA per Title 5 U.S. Code 552 (b)(7)(C).

In addition, since the release of the information would reveal the identity of confidential sources, it is exempt from public disclosure pursuant to Title 5 U.S. Code 552 (b)(7)(D) of the FOIA. The significant and legitimate governmental purpose to be served by withholding is that a viable and effective intelligence investigative capability is dependent upon protection of confidential sources.

The withholding of information by this office is a partial denial of your request. This denial is made on behalf of Brigadier General Keith B. Alexander, the Commanding General, U.S. Army Intelligence and Security Command, who is the Initial Denial Authority for Army intelligence investigative and security records under the FOIA. You may appeal this decision to the Secretary of the Army. If you wish to file an appeal, you should forward it to this office. Your appeal must be postmarked no later than 60 calendar days from the date of this letter. After the 60 day period, the case may be considered closed; however, such closure does not preclude you filing litigation in the courts.

We are continuing to process your request for records regarding other titles and will respond to you by separate correspondence when our action is complete.







Unidentified male (UM) was allegedly an English teacher but had poor command of the English language. A relationship ensued between - and UM for 1) stay in Somalia which ended on 5 September 1982. the duration of met UM on 31 August 1982, when _ _ brought VM to their quarters, a three bedroom house provided by the US Embassy, which was shared by the five team members. Source observed and overheard > describing to UM, in great detail, his travels for the US Government in the Middle East; his 2300-0100 hours. Members of the team advised 💆 📑 against fraternizing to closely with UM but he disregarded the advice and continued his association until his departure on 5 September 1982. guard, who was employed by the US Embassy, instructions to allow UM entry into the house. The guard told Source in broken English that UM was "Bad man- Ethiopian". On 6 September 1982, after _ _ had departed the country, UM again returned to the house and demanded all photographs Source had taken and money to get the film developed. Source said that \subseteq \supset had promised UM that he would provide all the photographs source had taken. Source told UM to return the next day, 7 September 1982, and he would give him the film. Prior to UM's return, Source exposed a new roll of film, rewound it into the cannister and gave it to UM, thereby retaining the actual film used to photograph suspect and other job-related photographs. Source had no additional contact with UM and departed the country on 8 September 1982. Source related that () has shallow technical expertise, was very immature, naive, and took everything as a big joke. Source felt that Z was not competent nor responsible enough to represent the US Government with other foreign governments. Source indicated that $\overline{\mathcal{L}}$ was scheduled for another foreign trip representing TACOM in the near future. Source is of the opinion that (I can substantiate Source's observations of) activities.

However, failure to disclose necessary and relevant information which impedes the investigation may have an adverse impact on your security clearance, if you possess or are being considered for one, or your employment, if you are a military member or employee of the Department of the Army.




PRIVACY ACT OF 1974

ADVISEMENT STATEMENT

The United States Army Intelligence Agency (USAINTA) is conducting an investigation or screening regarding you at the request of a Department of Defense or Department of the Army activity or command. The Privacy Act requires that each individual asked to provide personal information be advised of the following four points:

- a. AUTHORITY. Department of the Army (DA) is authorized to conduct counterintelligence investigations in satisfaction of investigative requirements posed by Executive Order 10450, "Security Requirements for Government Employees," and Title 10, United States Code, Section 3012. DA Regulation 381-20, "US Army Counterintelligence (CI) Activities," constitutes the basic implementing authority for the conduct of such investigations and sets forth pertinent DA policies and procedures.
- b. PRINCIPAL PURPOSES. This inquiry is being conducted by the Army to produce information of such a nature, form and reliability that the responsible commander may determine the nature and extent of action, if any, necessary to insure the security of his command. The principal objectives in collecting this information are:
- (1) To detect and neutralize acts of sabotage, espionage, treason, sedition, criminal subversion or disaffection directed against the United States.

- c. ROUTINE USES. The information obtained will become an official DA record to be evaluated by U.S. Federal officials in determining your eligibility for special programs or duties and/or in ascertaining whether or not allegations made relative to your disloyalty to the United States or unsuitability for employment with the Department of Defense or Department of Army were founded in credible fact and whether or not criminal and/or adverse administrative action is warranted against you.
- d. VOLUNTARY NATURE OF DISCLOSURE. The disclosure of personal information to USAINTA is voluntary. However, if you do not desire to furnish complete or partial information, USAINTA will be unable to conduct a complete investigation and adjudicating officials may not be able to make a determination as to the truth of allegations regarding your disloyalty to the United States and/or suitability for access to classified defense information, or performance of sensitive duties, or eligibility for assignment to sensitive duties within the Department of Defense or Department of the Army and thus impact adversely on your military employment/career.







THE WARNING

- 1. WARNING Inform the suspect/accused of:
 - a. Your official position.
 - b. Nature of offense(s).
 - c. The fact that he/she is a suspect/accused.
- 2 RIGHTS Advise the suspect/accused of his/her rights as follows:

"Before I ask you any questions, you must understand your rights.'

- "You do not have to answer my questions or say anything,
- b. "Anything you say or do can be used as evidence against you in a criminal trial.
- c. (For personnel subject to the UCMJ) "You have the right to talk privately to a lawyer before, during, and after questioning and to have a lawyer present with you during

questioning. This lawyer can be a civilian you arrange for at no expense to the Government or a military lawyer detailed for you at no expense to you, or both.

(For civilians not subject to the UCMJ) "You have the right to talk privately to a lawyer before, during, and after questioning and to have a lawyer present with you during questioning. However, you must make your own arrangements to obtain a lawyer and this will be at no expense to the Government. If you cannot afford to pay for a lawyer, one may be appointed to represent you.'

d. "If you are now willing to discuss the offense(s) under investigation, with or without a lawyer present, you have a right to stop answering questions at any time, or speak privately with a lawyer before answering further, even if you sign a waiver certificate.

Make certain the suspect/accused fully understands his/her rights.

THE WAIVER

"Do you understand your rights?" (If the suspect/accused says "no," determine what is not understood, and if necessary repeat the appropriate rights advisement. If the suspect/accused says "yes," ask the following question.)

"Do you want a lawyer at this time?"

(If the suspect/accused says "yes," stop the questioning until he/she has a lawyer. If the suspect/accused says "no," ask him/her the following question.)

'At this time, are you willing to discuss the offense(s) under investigation and make a statement without talking to a lawyer and without having a lawyer present with you?"
(If the suspect/accused says "no," stop the interview and have him/her read and sign the non-waiver section of the waiver

certificate on the other side of this form. If the suspect says 'yes," have him/her read and sign the waiver section of the waiver certificate on the other side of this form.)

SPECIAL INSTRUCTIONS

WHEN SUSPECT/ACCUSED REFUSES TO SIGN WAIVER CERTIFICATE: If the suspect/accused orally waives his/her rights but refuses to sign the waiver certificate, you may proceed with the questioning. Make notations on the waiver certificate to the effect that he/she has stated that he/she understands his/her rights, does not want a lawyer, wants to discuss the offense(s) under investigation, and refuses to sign the waiver certificate.

IF WAIVER CERTIFICATE CANNOT BE COMPLETED IMMEDIATELY: In all cases the waiver certificate must be completed as soon as possible. Every effort should be made to complete the waiver certificate before any questioning begins. If the waiver certificate cannot be completed at once, as in the case of street interrogation, completion may be temporarily postponed. Notes should be kept on the circumstances.

PRIOR INCRIMINATING STATEMENTS:

- If the suspect/accused has made spontaneous incriminating statements before being properly advised of his/her rights, he/she should be told that such statements do not obligate him/her to answer further questions.
- If the suspect/accused was questioned as such either without being advised of his/her rights or some question exists as to the propriety of the first statement, the accused must be so advised. The office of the serving Staff Judge Advocate should be contacted for assistance in drafting the proper rights advisal.

NOTE: If (1) or (2) apply, the fact that the suspect/accused was advised accordingly should be noted in the comment section on the waiver certificate and initialed by the suspect/accused.
