Dear Mr. Young:

This responds to your request to the U.S. Army Intelligence and Security Command (USA INSCOM) under the Freedom of Information Act, dated 29 March 2001. Therein you requested records concerning Yugoslavia Intelligence Service personalities. In processing your request, the USA INSCOM located two documents which originated with the DIA and referred them for our review and direct response to you.

Upon review, it has been determined that some portions of the documents are not releasable. The portions withheld are exempt from release pursuant to 5 U.S.C. 552 (b)(6), Freedom of Information Act. Subsection (b)(6) applies to information which if released would constitute an unwarranted invasion of the personal privacy of other individuals. All reasonably segregable portions of the documents are attached hereto.

You are advised that a requester may appeal, within 60 days, an initial decision to withhold a record or part thereof. Should you wish to exercise this right, you may do so by referring to case #0627-02 and addressing your appeal to:

- 1. Fursuant to authority contained in message DA 999949, Office of the Deputy Chief of Staff for Military Operations, Department of the Army, and with the concurrence of the W.S. Army Attache, American Embassy, Delgrade, Yugoslavla, the individual listed above, member of the Yugoslav Peoples Army, is authorized and invited to proceed on or about 15 April 1966 from his present station to the United States for further travel to Washington, D.C. and Fort Leavenworth, Kansas for the purpose of attending the Command and General Staff College, Course No. 250-A-C2, at Fort Leavenworth, Emsas; reporting 21-23 June 1965, ending (subject to change) 10 June 1966. Upon completion of this training, he will return to proper station.
- 2. It is understood that the Government of Yugoslavia will furnish all travel to and from the Command and General Staff Cellege, Fort Leavenworth, Kansas, by whatever mode of transportation is deemed necessary and appropriate. Travel in or outside of the United States at the expense of the United States Government is not authorized.
- 3. Student should inform the Commandant of the Command and General Staff College, Fort Leavensorth, Kansas, forty-eight (48) hours in advance of his expected arrival by telegram giving time and date of arrival and made of transportation in order that proper reception may be accomplished.
- 4. If the individual listed herein encounters any difficulties in arranging transportation to his destination after arrival in the United States, he will contact the appropriate United States Port of Embarkation, location and telephone number as listed below:

- 6. Prior to departure from his present station, Lt Colonel RAEUSOVIC will obtain a medical certificate to the effect he in physically sound with no communicable diseases and has required immunizations for entry into the United States. The individual concerned will be provided sufficient funds in American dollar instruments to meet all expenses while enroate to, during attendance at, and return to station, from the school. Adequate uniforms as well as appropriate civilian clothing for off-duty wear should be taken. United States work (fatigue) uniforms less insignia may be purchased at his own expense when required for field wear or technical work.
- 7. The United States will relieve from attendance at schools and request their return to the country of their origin, students who visinte regulations or who otherwise are a detriment to the class as a whole. The Deputy Chief of Staff for Military Operations. Department of the Army, will be informed when such action is contemplated.
- 6. Request for leave upon completion of course will be submitted direct by the individual to his Embassy. Written approval in English from the Embassy to the individual will constitute approval for leave.
- 9. The mailing address of the individual indicated herein will be in core of the installation to which he is attached.
- 10. No training other than that specified in paragraph 1 above will be comducted on the basis of these orders. If additional training is desired, the individual concerned will submit requests therefor directly to appropriate representatives of his government.
