EXPLANATION OF EXEMPTIONS

SUBSECTIONS OF TITLE 5, UNITED STATES CODE, SECTION 552

- (b)(1) (A) specifically authorized under criteria established by an Executive order to be kept secret in the interest of national defense or foreign policy and (B) are in fact properly classified to such Executive order;
- (b)(2) related solely to the internal personnel rules and practices of an agency;
- (b)(3) specifically exempted from disclosure by statute (other than section 552b of this title), provided that such statute(A) requires that the matters be withheld from the public in such a manner as to leave no discretion on issue, or (B) establishes particular criteria for withholding or refers to particular types of matters to be withheld;
- (b)(4) trade secrets and commercial or financial information obtained from a person and privileged or confidential;
- (b)(5) inter-agency or intra-agency memorandums or letters which would not be available by law to a party other than an agency in litigation with the agency;
- (b)(6) personnel and medical files and similar files the disclosure of which would constitute a clearly unwarranted invasion of personal privacy;
- (b)(7) records or information compiled for law enforcement purposes, but only to the extent that the production of such law enforcement records or information (A) could be reasonably be expected to interfere with enforcement proceedings, (B) would deprive a person of a right to a fair trial or an impartial adjudication, (C) could be reasonably expected to constitute an unwarranted invasion of personal privacy, (D) could reasonably be expected to disclose the identity of confidential source, including a State, local, or foreign agency or authority or any private institution which furnished information on a confidential basis, and, in the case of record or information compiled by a criminal law enforcement authority in the course of a criminal investigation, or by an agency conducting a lawful national security intelligence investigation, information furnished by a confidential source, (E) would disclose techniques and procedures for law enforcement investigations or prosecutions, or would disclose guidelines for law enforcement investigations or prosecutions if such disclosure could reasonably be expected to risk circumvention of the law, or (F) could reasonably be expected to endanger the life or physical safety of any individual;
- (b)(8) contained in or related to examination, operating, or condition reports prepared by, on behalf of, or for the use of an agency responsible for the regulation or supervision of financial institutions; or
- (b)(9) geological and geophysical information and data, including maps, concerning wells.

- (d)(5) information compiled in reasonable anticipation of a civil action proceeding;
- (j)(2) material reporting investigative efforts pertaining to the enforcement of criminal law including efforts to prevent, control, or reduce crime or apprehend criminals;
- (k)(1) information which is currently and properly classified pursuant to an Executive order in the interest of the national defense or foreign policy, for example, information involving intelligence sources or methods;
- (k)(2) investigatory material compiled for law enforcement purposes, other than criminal, which did not result in loss of a right, benefit or privilege under Federal programs, or which would identify a source who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(3) material maintained in connection with providing protective services to the President of the United States or any other individual pursuant to the authority of Title 18, United States Code, Section 3056;
- (k)(4) required by statute to be maintained and used solely as statistical records;
- (k)(5) investigatory material compiled solely for the purpose of determining suitability, eligibility, or qualifications for Federal civilian employment or for access to classified information, the disclosure of which would reveal the identity of the person who furnished information pursuant to a promise that his/her identity would be held in confidence;
- (k)(6) testing or examination material used to determine individual qualifications for appointment or promotion in Federal Government service the release of which would compromise the testing or examination process;
- (k)(7) material used to determine potential for promotion in the armed services, the disclosure of which would reveal the identity of the person who furnished the material pursuant to a promise that his/her identity would be held in confidence.

When he observed the second photograph, he immediately stated that [redacted] strongly resembled the unknown subject in this case. He stated, however, that he could not be one hundred per cent certain the [redacted] was identical with the unknown subject.

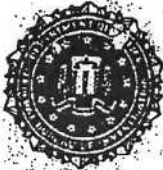

A reliable source in Canada has recently furnished the following information which was received from a highly confidential and sensitive informant.

[Redacted] has expressed a desire to communicate by mail with a civilian employee of the United States Army *[Redacted]*. No identifying data is known concerning this civilian employee; however, it is believed that correspondence to this person would be sent in care of an Army Post Office at New York City.

[Redacted] is reliably reported to have been a Communist for the past 10 years and during this period he is known to have been in contact with individuals who have been tentatively identified as Soviet espionage agents. During 1951 *[Redacted]*

Our source in this matter has requested that the utmost discretion be used in the event an investigation is undertaken to identify the unknown subject. You are therefore requested to make no dissemination of this information outside of your Agency.

In the event you are able to identify the unknown subject or develop any pertinent information in this matter we will appreciate being advised.

early return to United States, no further contact had by [redacted] with [redacted] in Mexico. Upon arrival [redacted] [redacted] advised him [redacted] had recently telephoned numerous times for him. Sometime mid or late [redacted] received telephone call from man who identified himself as [redacted] who inquired if [redacted] still interested in [redacted] met this [redacted] in [redacted]. This [redacted] not identical with the [redacted] whom [redacted] met in Mexico. Subsequently met with [redacted] on [redacted] additional occasions, [redacted] area. DETAILS:

On [redacted] 1959, [redacted] advised that he [redacted] until [redacted]. He was a [redacted] engaged as [redacted] While in [redacted] he was [redacted] and subsequently with the [redacted] and served in that capacity in [redacted] [redacted] at [redacted] Arlington, Virginia. [redacted] stated that he learned [redacted] while in [redacted]. He stated that he had also been a student at [redacted] College in [redacted].

He explained that sometime during the winter of [redacted] he attended a party at the apartment of [redacted] (PH) located on [redacted] New York. At this party [redacted] had occasion to meet several young men whose names he could not recall. The discussion at the time concerned [redacted] which were being offered by the University of Mexico for learning in foreign countries under some kind of an exchange program. He was very interested in [redacted] as he had never [redacted].

In [redacted] 1958, [redacted] went to [redacted] with a friend of his by the name of [redacted] who is originally from [redacted] while in [redacted] had occasion to attend various parties during which the matter of [redacted] being offered by the University of Mexico was discussed. He understood it was possible to [redacted] to the University of Moscow.

After returning to the United States, [redacted] to the [redacted] regarding [redacted] possibilities. He returned for the [redacted] time to Mexico in [redacted] and remained there until [redacted]. During this period he was [redacted].

While in Mexico he became acquainted with [redacted] and understood that the latter was endeavoring to obtain employment at the [redacted] in [redacted].

In the early part of [redacted] 1959, he met an individual outside of the [redacted] Embassy in Mexico City and by chance struck up a conversation with this man who identified himself only as [redacted].

At their first meeting [] and [] spoke [] during which conversation [] mentioned that he was extremely interested in obtaining []. He inquired of [] if [] to the University of [] was possible. At this initial meeting [] made an appointment to meet [] p.m., on the same day in front of the [] in Mexico City. [] stated that it was his opinion that [] may have been [] stationed at the [] in Mexico.

[] met [] p.m., in front of the [] and [] invited him to a picnic, stating that they could best discuss the possibility of [] for [] during an outing.

Within a matter of a few days [] accompanied [] and another individual identified only as [] who drove the car, to a picnic grounds located some [] miles outside of Mexico City. During the course of the picnic, [] told [] that he knew that the latter had worked for the []. [] was able to converse in perfect English. During the course of the picnic [] explained the details of obtaining []. He told [] that it would first be necessary for him to fill out forms recording his background, education, and residence of parents. [] stated that the forms did not call for the identification of any of his close or distant relatives who might be residing in foreign countries. During the picnic, [] obtained [].

On the day of the picnic, [] told [] that he desired to meet him again the following day at 7:00 p.m. in front of the [] in Mexico City. [] stated that he recalled that this meeting at 7:00 p.m., was held [] that [] took place in Mexico as a result of which two persons believed to be Communists and responsible for this strike were put in prison.

During this second meeting with [] inquired of [] if he was really interested in seeing to it that the United States kept the peace in the present cold war. [] stated at that time that he was afraid the United States was interested in starting a war. During this meeting [] let

[redacted] know that he was cognizant of the code names used for [redacted] names of [redacted] inquired as to the code but [redacted] stated he told [redacted] utilized by the [redacted] he did not know these names. At the completion of the second meeting, [redacted] told [redacted] to return to the United States and that he would write to him in care of [redacted] address in [redacted] regarding the matter of [redacted] obtaining [redacted] at the University of [redacted] stated that [redacted] made it clear to him that before he could obtain any such [redacted] he would have to do something special for [redacted] did not explain to [redacted] what he meant by "special".

[redacted] returned to the United States during the first week in [redacted] with [redacted] and for one month thereafter resided with his brother-in-law in [redacted] Upon his return, [redacted] learned from his parents that an individual identified only as [redacted] had been endeavoring to contact him at his parents' home.

Approximately one and one-half weeks after [redacted] had returned to [redacted] he received a telephone call from an individual with [redacted] accent who identified himself as [redacted] advised that this [redacted] was not identical with the person known to him as [redacted] in Mexico City. At the time of the first telephone call [redacted] asked [redacted] to meet him in front of the [redacted] in [redacted] Massachusetts, between 1:00 and 2:00 p.m. [redacted] met [redacted] as requested. [redacted] expressed a keen interest in having [redacted] seek employment as a civilian with [redacted]. [redacted] pointed out to him that in view of [redacted] experience as [redacted] he should have no difficulty in obtaining re-employment with that Agency [redacted] claimed that he told [redacted] that in view of the fact that he had [redacted] he could not possibly obtain employment with [redacted].

Approximately mid-June, [redacted] again telephonically contacted [redacted] at the latter's home and asked [redacted] to meet him between 1:00 and 2:00 p.m., in front of the [redacted] in [redacted]. [redacted] at this second meeting again tried to convince [redacted] that he should seek re-employment with [redacted].

[redacted] asserted that he told [redacted] that he did not want anything further to do with him and that he was becoming ill and extremely nervous because of their past association. [redacted] endeavored to explain to [redacted] that he should take it easy and not worry about anything. At this second meeting [redacted] requested [redacted] to meet him henceforth at different designated locations such as [redacted] in the [redacted] New York, and the [redacted] in [redacted], New York. During their conversation at this second meeting, [redacted] told [redacted] that he wanted to meet another [redacted] which meeting could be arranged at the [redacted] in Washington, D. C. He told [redacted] that if he saw fit to keep such an appointment in Washington, D. C., that as a means of identification, he should carry [redacted] in his pocket [redacted] explained that he never made any of the meetings outside of [redacted]

[redacted] stated that as a result of his not keeping appointments with [redacted] at the above described locations, [redacted] telephonically contacted him again in June and they met in isolated locations in the [redacted] area. [redacted] recalled that on one occasion, [redacted] requested him to drive to [redacted] a hilly location between [redacted]

[redacted] pointed out that whenever he met with [redacted] the latter always requested that they drive in [redacted] automobile. During the course of travel, there would never be any conversation on the part of [redacted]. The conversation would take place only after they had left the automobile and were in an open location or in a location where [redacted] was sure no one could overhear. [redacted] advised that [redacted] came to [redacted] to see him once during the month of [redacted]

The last time [redacted] came to [redacted] was on [redacted] 1959. On that date, [redacted] again telephoned [redacted] and asked him to meet him in front of the [redacted] at 4:00 p.m. [redacted] met him and at [redacted] suggestion, they drove in [redacted] car to [redacted] in [redacted] Massachusetts. They sat in the back room of the tavern where no one could hear the conversation. They discussed the matter of the United States maintaining peace in the world [redacted] expressed a fear that it was not the intention of the United States to keep the peace. He asked [redacted] if he did not desire to see that peace

was maintained and pointed out that if [] would cooperate with him, [] would thereby be strengthening peace in the world.

In the [] 1959 meeting, [] asked [] to go to Washington, D.C. with [] and arrange to have a party with former friends and employees. [] advised that he did not agree to go to Washington, D.C.

At the completion of the meeting on [] 1959, [] asked [] to meet him on [] 1959 at 2:00 p.m. in front of the [] in [] Massachusetts. He asked [] to bring with him drawings and diagrams pertaining to the [] used by the American government as he recalled them from memory. [] stated that he did not expressly tell [] that he would not meet him [] 1959.

[] asserted that he had never furnished any information to either the [] he met in Mexico or the [] who was contacting him at []. He claimed that as a result of his meetings with these people, he had become very nervous and at times ill over worry as to the consequences of his association with [] representatives. He added, however, that he was willing to cooperate with the Federal Bureau of Investigation (FBI) in the matter of his contacts [].

He said that one Sunday, in the latter part of [redacted] 1959, at approximately 3:00 p.m., he received a phone call at his [redacted] house. The caller said that his name was [redacted] and that he wanted to talk to him about [redacted] in Mexico City. [redacted] asked him to meet him some place. He invited [redacted] to come to his [redacted] home. [redacted] declined to do this, and suggested that they meet at the [redacted] in the center of [redacted]. He drove to [redacted] in his own car and parked in front and got out. As he approached the front of the [redacted] an individual came right up to him and introduced himself only as [redacted]. He acknowledged this greeting, whereupon [redacted] asked him if he would like to discuss [redacted]. He told [redacted] he was not sure since he was now [redacted] and that this changed the picture. However, he agreed to discuss the matter further. [redacted] then got into his car, and they proceeded to [redacted] located in [redacted] Massachusetts, a town adjacent to [redacted]. Upon entering [redacted] [redacted] went in first and picked a booth in the rear of the tavern. He opened the conversation by discussing the [redacted] and the Ukrainian people. [redacted] thereafter touched upon his work [redacted]. [redacted] asked him if he didn't desire to do something for the cause of peace since present world conditions were in such a turmoil due to the United States' attitude in fostering a cold war. He indicated to [redacted] that he desired to discuss [redacted]. [redacted] ignored this subject, and again asked him if he did not think he could do something for his country, meaning the [redacted]. [redacted] said that he was still considered a [redacted] because of his father's birth there. [redacted] reiterated that he could do something for the cause of peace throughout the world, and stated that he very much wanted him to go to [redacted] in the [redacted] opposite [redacted] to meet some people and talk to them on the following Saturday at 1:00 p.m. [redacted] said that they would have many things to discuss. He told [redacted] that he would try to make it. [redacted] then proceeded to give him all kinds of instructions as to how to proceed to the meeting. He told him to drive down by car, park his car in [redacted] and then take a subway to the [redacted] Station in the [redacted] where he was to leave the subway and walk to [redacted].

He was to enter the park and there be met by [] or some other man. [] stated that the man would approach and say, [] and he was to reply. [] and then give any [] on. He explained that [] asked him to repeat these instructions which he did to the best of his ability. He stated that he then promptly forgot most of them because he did not intend to meet [] in the []

He related that his second meeting with [] took place in [] on [] 1959, at which time he received a phone call at his own residence at approximately 1:30 p.m. It was [] who asked him to come again to the [] in []. He told [] that he was sick. [] stated that his visit would only take approximately five minutes. He then drove down in his car, and parked it near [] where he saw [] standing in front. [] greeted him, and they proceeded to walk around the block. [] inquired as to why he did not come to New York to the designated meeting. He told [] he just couldn't make it at that time. During the walk [] continually kept asking him to attempt to get a job with []. He told [] it would not be possible since []

During this meeting [] gave him a new place to contact him. This was the [] New York City. Contact could be made the [] of any month at 7:00 p.m. At the conclusion of the meeting he saw [] in the vicinity of the [] driving [] Pontiac car with [] on the driver's side. He believed it was a [] model. He said the third meeting took place on [] 1959, when [] received a telephone call at approximately 2:30 p.m. at their residence. [] again asked him to meet in front of the []. He drove to the [] in his own car and met [] who was standing in front. [] got into the car and asked him to drive to [] which is located in [] Massachusetts, approximately [] miles from []. They drove to the [] en route to the [] little or no conversation took place. [redacted] suggested that he visit the Russian exhibition [redacted] in New York City with [redacted] for which he would pay the expenses. [redacted] also told him that he should go down to [redacted] in pursuit of employment [redacted] and look up old friends from that [redacted] suggested that he arranged to have a party at a motel or hotel for these friends for which [redacted] would provide funds. He stated that in connection with [redacted] request that he go to [redacted] to try to get employment [redacted] asked him to give up his current job. He told [redacted] he could not do that because he had to support [redacted] They then had a long conversation concerning world conditions and [redacted] again reminded him that he was and always will be [redacted] played upon his sympathy for the [redacted] people, and asked him if he was not willing to do something to maintain peace in the world. He said that he could not accurately recall the details of this conversation.

After leaving the [redacted] they stopped at a roadside restaurant on Highway Route [redacted] known as [redacted]. They had some refreshments for which [redacted] paid. He then drove [redacted] to the vicinity of the [redacted] Airport on Route [redacted] Massachusetts, where [redacted] left the car. Upon leaving the car, [redacted] placed a white envelope in the glove compartment, stating that it contained something for him. He claimed that he did not open the envelope until he got home, at which time he found it contained [redacted] dollar bills. He said he spent this money for gasoline.

He stated that on [redacted] 1959 a fourth meeting with [redacted] occurred after [redacted] telephoned him at his residence at approximately 5:00 p.m. He said he informed [redacted] he had a virus and would not be able to meet him. [redacted] insisted that he come down for a very brief period. He consented and drove down in his car and met [redacted] who was standing in front of the [redacted]. They went to [redacted] in [redacted] where they had two beers. [redacted] again said that he wanted him to go down to [redacted] obtain employment [redacted]

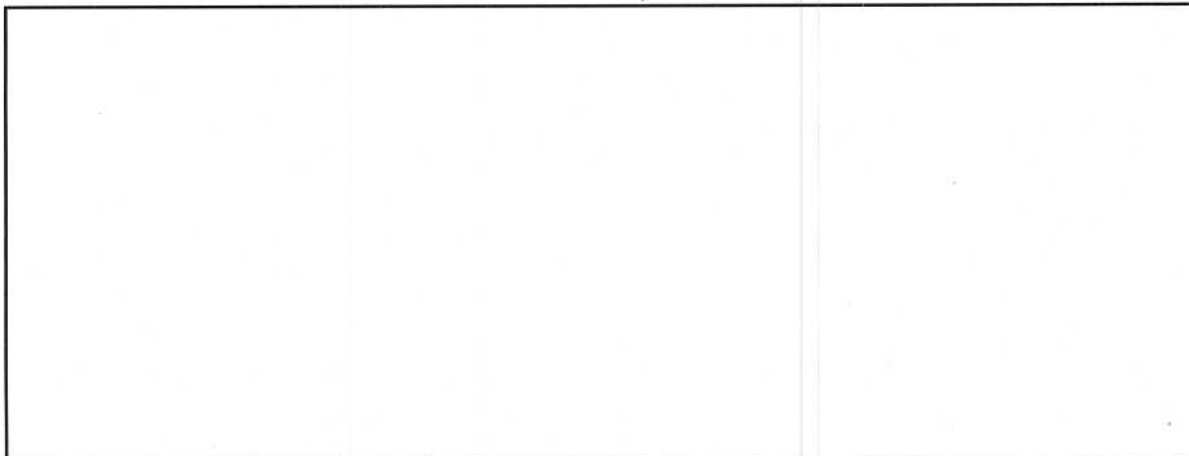

He again voiced his objection to [redacted] that [redacted] which would prevent him from getting the job and that he did not desire to leave his present employment. [redacted] again suggested that he and [redacted] visit [redacted] and have a party to which he should invite some friends. [redacted] said that he would be willing to pay all expenses for this party. [redacted] suggested that he should try and convince [redacted] that his best opportunities would be in Washington, D.C. They then discussed world conditions, and [redacted] indicated to him that he did not think that the United States had any intention of keeping the peace. [redacted] wanted to know if he wasn't interested in seeing what he could do to help preserve the peace. He told [redacted] that he was interested in seeing that there was peace in the world. [redacted] then said that he could do something to further this worthy aim. He asked him to obtain a spiral notebook, and to the best of his knowledge write in this notebook his knowledge of [redacted] [redacted] and draw diagrams of the appearances [redacted] asked him to bring this to the front of [redacted] in [redacted] Massachusetts at 4:00 p.m. on [redacted] 1959. [redacted] told him that if he was not there on that day he would be there the same time on [redacted] 1959. He said that he did not give a definite answer to [redacted] as to whether or not he would comply with this request, claiming that he informed [redacted] he did not know too much about these [redacted] told him to think it over. He said that prior to setting a date for the meeting [redacted] consulted a small datebook which he carried in his coat pocket. He drove [redacted] back to the vicinity of the [redacted] where [redacted] left the car. During the interview of [redacted] 1959 several photographs of [redacted] were displayed to him. He positively identified the photograph of [redacted] as being identical with the person known to him as [redacted] with whom he met in [redacted], Massachusetts.

During the interview of [redacted] 1959 he stated he had informed [redacted] his [redacted] and his [redacted] of the above-mentioned activities. He claimed that somewhere along the line in his meetings with [redacted] he became suspicious that [redacted] was interested in obtaining something from him rather than helping him to obtain [redacted]. He said he had become worried to the extent that it had affected his health. He had [redacted] which he thought were [redacted] so he went to the family doctor and had [redacted] examination.

On [redacted], 1959 he was again interviewed at the [redacted] in [redacted]. This interview was concluded early [redacted] 1959. His story of his association with the Russians was re-examined in detail. He explained his inability to furnish accurate and detailed information as being caused by his tremendous concern for the personal welfare of himself, his [redacted] members of his family and unknown relatives in the [redacted]. The interviewing agents emphatically pointed out to him that he could be liable for prosecution for furnishing false information to the United States Government. He stated he was well aware of this and that he would, if necessary, testify under oath to these events even if it meant going before a Grand Jury. He said in answer to a question as to why he had so many meetings with [redacted] that he thought at first that he would eventually obtain the [redacted] he so ardently desired. He became leery of obtaining success in this endeavor when he met [redacted] for the third time, and [redacted] persisted in his efforts to get him to take a job [redacted]. The [redacted] 1959 meeting convinced him that the Russians were trying to get him to do something against the United States. He became agitated and worried after the [redacted] 1959 meeting that some type of injury might befall himself and his family if he didn't cooperate with the Russians. He discussed his association with [redacted] with [redacted] and [redacted] who offered him no solution to the problem. His [redacted] told him that it was his own problem, and that he should solve it by himself. He finally arrived at the decision to tell his story to the FBI. On [redacted] 1959 he took the day off from his job, and went to the [redacted] Resident Agency of the FBI to unburden himself. He said that the information furnished by him on [redacted] 1959 undoubtedly contained many inaccuracies because he was confused, excited and extremely nervous at the time.

In connection with the payment of [] to him by [] at the conclusion of the [] meeting, he stated that he and [] had discussed the Russian exhibition in New York City while they were in the woods. [] extended the invitation to him at the second meeting and further discussed it at [] the third meeting. [] urged him to go and to take [] He told [] that he would like to see the exhibition. When [] was leaving the car in the vicinity of the airport he placed a plain white envelope in the glove compartment and told him that it contained something to cover his expenses to the [] exhibition. He opened the envelope when he got home and found that it contained []-dollar bills. He left the envelope and money in the glove compartment of the car and did not immediately tell [] A week after obtaining the money he attended the exhibition [] accompanied by [] parents and [] They traveled in his car, and he used the money received from [] to pay the expenses for the trip. He stayed at the [] Hotel [] He claimed that it was at this hotel that he first told [] about receiving the money from [] He stated that he does not know what disposition he made of the white envelope but that he is positive that it is no longer in his possession. He claimed that he never at any other time received money from [] He did not see [] at the [] exposition. He insisted that nothing was done for [] to receive a [] payment.

At the [] meeting [] told him that if he actually held a party for acquaintances [] in [] that in addition to the expenses for the party [] would pay him the cost of bringing himself and [] from [] to the United States. He stated that he believes this offer was made by [] because he had given [] as one of his reasons for not going to [] the fact that he [] to leave his current position. He explained to [] that he [] which he had lent him for [] for himself [] to the United States. He also recalled that in discussion with [] at [] that [] told him that if any money was given to him that he should not put it in a bank because the bank would become suspicious and possibly inquire as to the source of his outside income. [] told him to hide the money.

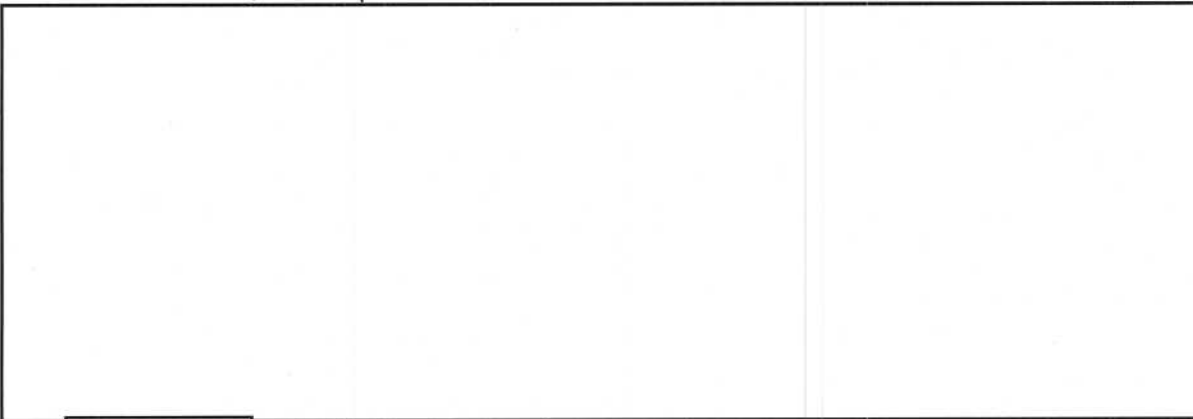
He also recalled that during the [redacted] meeting [redacted] told him that if he went to [redacted] and obtained a job he should go the [redacted] of each month to [redacted] Restaurant at 7:00 p.m. He should carry [redacted] in his right suit coat pocket. A man would approach him in the restaurant and say, [redacted] to which he was to reply, [redacted] and then add any year from [redacted]

He said that the only live relative in [redacted] known to him is [redacted] who is approximately [redacted] years of age, identity unknown. She is the only person, to his knowledge, with whom any member of his family corresponds. This correspondence is handled on [redacted] basis by one of his [redacted]. He said that he does not believe [redacted] ever mentioned [redacted] association in her letters because she is not aware of the details of his [redacted]. He learned that recently his [redacted] had requested [redacted] type or otherwise of all or any members of his family. I finally decided that I was involved in something serious and that I should tell the FBI about my associations with [redacted] which I first did on [redacted] 1959.

"Special Agents [redacted] and [redacted] have shown me numerous photographs of men which they identified as being [redacted]. I have identified one of these photographs as being that of [redacted] who met me four times in [redacted].

On [redacted] 1959, he identified a photograph of a [redacted] as the [redacted] who had met with him in [redacted] by writing on the back of the photograph the following:

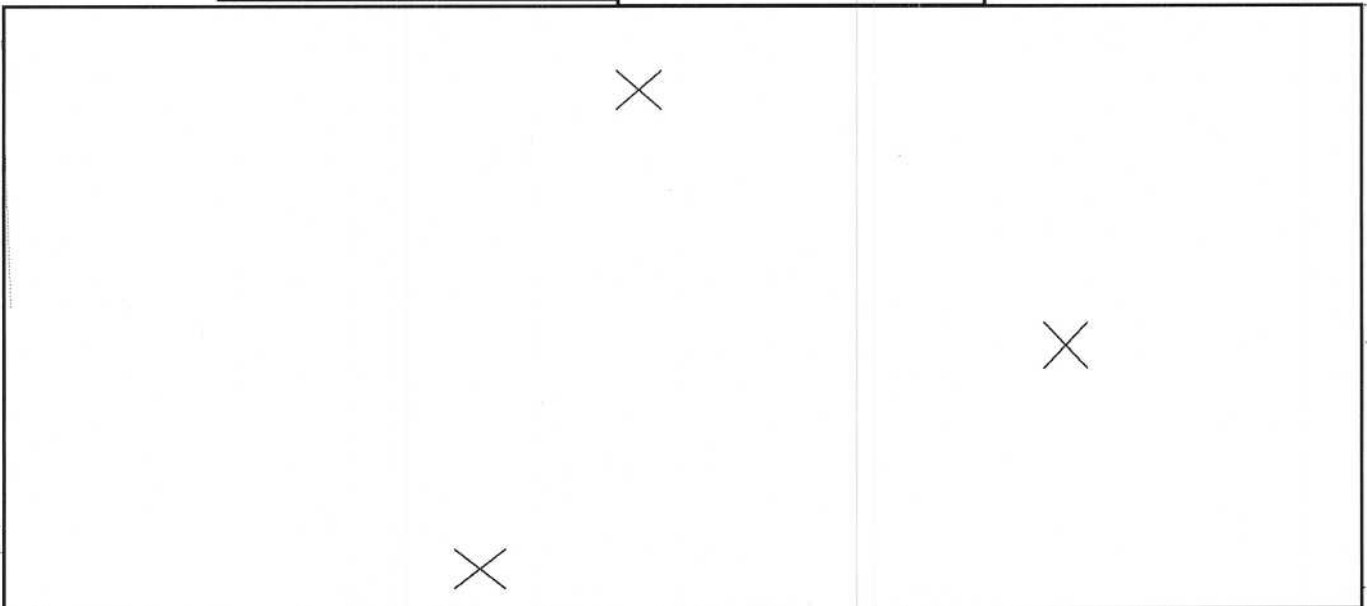
