According to everything started approximately two years ago when Gawker published an article regarding Scientology. A hacker group known as 4Chan/Anonymous then attacked the Scientology website claiming that the Internet was bigger than the Scientology group. Many thought this action was in response to the Gawker article and that Gawker and 4Chan/Anonymous were now "friends." Then, a number of critical articles about 4Chan regarding DDOS hacks were published by Gawker. Subsequently, Gawker and 4Chan/Anonymous were no longer "friends." During the summer of 2010, a writer for Gawker referred to 4Chan as "idiotic" in an article. In August 2010, a hole was found in Minify, Gawker's open source script. 




