Enhanced Coverage Support for Referenced Models

The previous release introduced coverage support for referenced models, but only by means of functions that you invoke programmatically. This release includes the following enhancements to coverage support for referenced models:

Requirement Links Checking

- The requirements document path does not match your preferred path type (i.e., absolute or relative).

Support for New Location Types

In previous releases, each document type had a single way of identifying locations. In this release, you can choose from several ways of identifying a location based on the type of document. For example, you can specify a line number location or a unique string location for a text file. You select the location type using a drop-down menu in the Requirements dialog box. For backward compatibility, the default location type is the same as previous releases.

PDF Document Support

PDF requirement documents are supported in this release. You can specify either a page number location or a named destination location within a document.

Custom Requirements Documents

Custom requirement documents let you extend the requirement interface to new document types by supplying the M-code that is invoked to navigate to the document. For more information, see Linking to Custom Types of Requirements Documents in the *Simulink Verification and Validation User's Guide*.

Selection-Based Linking

Selection-based linking lets you create links to the currently selected text in a Word document, active cell in an Excel[®] workbook, or last selected object in Telelogic[®] DOORS[®] software without using the Requirements dialog box. This is the recommended way to establish requirement links to these documents.

When you use selection-based linking, the active Word document or Excel workbook is modified to include a new bookmark or named cell that uniquely identifies the location in the document. You can optionally modify the document to provide an icon for navigating from the requirement to the Simulink object. For more information, see Selection-Based Linking in the Simulink Verification and Validation User's Guide.

Navigation from Requirements Documents Using ActiveX and Persistent Identifiers

The Simulink Verification and Validation software supplies an ActiveX[®] control to enable navigation from a requirements document to an object in a Simulink model. The ActiveX control is automatically inserted into Microsoft Word and Excel documents when you use selection-based linking.

You can use the ActiveX control in other applications to support custom interfaces between documents and Simulink models.

The Requirements Management Interface automatically creates unique identifiers for external navigation whenever you add a requirement link to a model object. The unique identifiers ensure that the correct item will be found after its name has been modified. The identifier is embedded in the property of the ActiveX control.

System Requirements Block for Displaying Requirements in a Diagram

The System Requirements block in the new Simulink Verification and Validation block library lets you view the requirements for a subsystem or model directly on the block diagram for convenience, printing, and easy navigation.

When you place the System Requirements block in a diagram, it automatically updates the requirements list as you add, modify, or delete requirements for the model or subsystem. Double-clicking a requirement label in the System Requirements block navigates to the requirements document. For more information, see the System Requirements block reference page in the Simulink Verification and Validation User's Guide.

DOORS Links Without a Surrogate

In this release, you can establish requirement links directly to items in a Telelogic DOORS formal module without using a surrogate module. You can combine DOORS[®] links with links to other document types and add them before or after the optional synchronization.

DOORS Synchronization Changes

Telelogic DOORS software synchronization is now an optional process that is needed only if you want to enable further analysis within the DOORS software, use various tracking tools that are built on top of the DOORS software, or use the DOORS software as an alternative to storing requirements information in the model.

Synchronization Settings

Several synchronization settings are available to control the way the surrogate module is created and managed. You can configure these settings by using the DOORS settings dialog box, which is automatically opened whenever you start synchronization. The synchronization settings are saved with the model.

Control over Model Detail

You can control the objects that are inserted into the DOORS surrogate module. In prior releases, all the model objects were inserted into the surrogate, resulting in extremely large and detailed surrogate modules and long synchronization times. Now you can specify that only the items with DOORS requirement links are placed in the surrogate, or you can choose a desired detail level to make the surrogate better reflect the model.

Synchronization of Link Information

By default, links between DOORS surrogate items and DOORS requirement items are imported into the Simulink software during synchronization. Similarly, links between model objects and DOORS requirement items are exported to the DOORS software during synchronization. You can disable these options by using the DOORS settings dialog box. When both options are enabled, link information is merged between the Simulink model and the DOORS surrogate modules so that each representation has complete linking information.

Ability to Specify Surrogate Path

You can choose the surrogate module arbitrarily by browsing the hierarchy in the DOORS software. It is identified uniquely with its creation number that is stored in the model. It is no longer necessary to ensure that the DOORS software is started in a particular project.

Menu Additions

In this release, the Simulink Verification and Validation software provides some additional menu items to improve usability and simplify the workflow.

The Simulink **Tools** menu now contains a **Requirements** item that provides access to several commonly used utilities.

- Link settings Opens the Selection-based linking dialog box, which lets you open the external applications and specify preferences for selection-based linking.
- **Generate Report** Generates a report on all the requirements associated with the model and its blocks.
- **Highlight model** Highlights all the blocks in the Simulink diagram that have requirements associated with them.
- **Synchronize with DOORS** Synchronizes the Simulink model with a formal module in a Telelogic DOORS project.

When you right-click a Simulink or Stateflow object and select **Requirements** from the resulting pop-up menu, you see a list of requirement links for the selected object and some additional menu items.

- Add link to Word selection Makes a selection-based link to a Microsoft Word document.
- Add link to active Excel cell Makes a selection-based link to a Microsoft Excel document.

- Add link to current DOORS object Makes a selection-based link to a Telelogic DOORS object.
- Edit/Add links Opens the Requirements dialog box.
- Link settings Opens the Selection-based linking dialog box, which lets you open the external applications and specify preferences for selection-based linking.

Improved Requirements Management Interface

The user interface for requirements management has been updated and integrated with Model Explorer. The new interface includes requirement descriptions and links to Microsoft Word (.doc), Microsoft Excel (.xls), and HTML documents, which are mapped directly to Simulink and Stateflow model elements. The new requirements management interface is fully compatible with models that already map requirements using the earlier interface. New Verification Manager

The GUI interface for the Signal Builder block now includes a new Verification Manager to manage the verification blocks in a model. From this central location, you can construct configurations of verification blocks to accompany each test group. Each of these configurations enables, disables, and override enables individual verification blocks to assert during testing. New Model Coverage Features

Signal Range Analysis Report

This new feature provides a report at the bottom of the standard Model Coverage report with the maximum and minimum signal values at each block in the model measured during simulation.

N-Dimensional Lookup Table Report

This report section displays an interactive chart that summarizes the extent to which elements of a lookup table are accessed. The report contains up to ntwo-dimensional tables representing the elements of the lookup table. Each cell contains a shade of the color green representing the number of execution counts for its lookup value. If you click an individual table cell, you receive a dialog that displays the index location of the cell and the exact number of execution counts generated for it during testing.

Colored Simulink Diagram Coverage Display

Model coverage displays results for individual blocks directly in Simulink diagrams as follows:

- Highlights (colors) blocks that have received model coverage during simulation.

Problems with Objects Not Synchronizing

In many cases, Simulink blocks and especially Stateflow objects (states, junctions, transitions, and so on) did not synchronize and appear in the DOORS synchronized module. This has been fixed by the new Requirements Management Interface.

Problems with the Navigator

Numerous bugs have been reported with the Requirements Navigator GUI. This GUI has been deprecated in favor of integrating requirements directly into Simulink models with the new Requirements Management Interface.

Problems with Navigating to Requirements

Numerous bugs have been reported with navigation to text, HTML, and Excel files requirements documents through the old Requirements Management Interface Navigator. These issues have been fixed in the new Requirements Management Interface.
