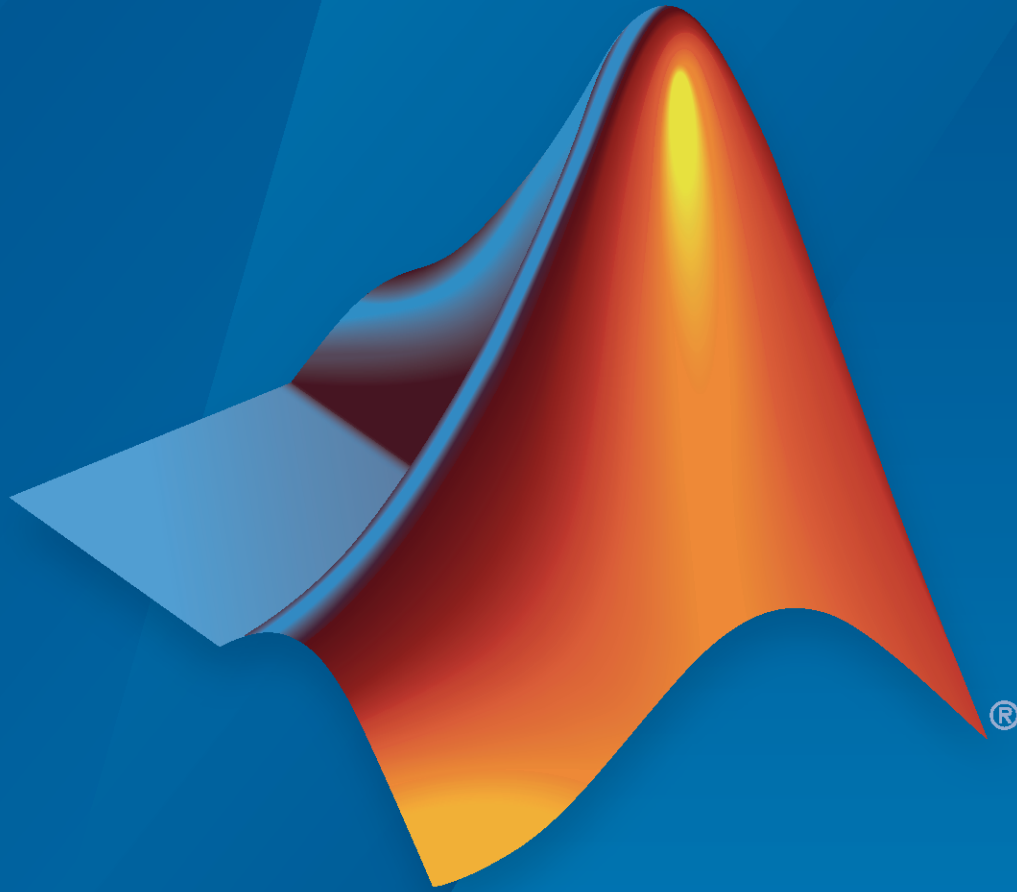

Transient Calibration: Faster optimization for Simulink models with first-order transient systems

Transient calibration includes enhanced support for Simulink® models with first-order transient systems. CAGE includes blocks that create a single top-level feature for the first-order transient system, which improves the optimization performance. Use the first-order system to estimate time constants and gains specified by lookup tables or scalars in CAGE.

Previously, if your Simulink model contained a feedback loop, the CAGE implementation resulted in slow feature evaluation. In R2022a, CAGE provides a 30% to 50% increase in evaluating features with feedback loops.

Transient Calibration: Faster optimization for feature fills with many lookup tables

Transient calibration includes an optimization algorithm for feature fills with many lookup tables to fill. To use the algorithm, set **Algorithm** to **Eigenvalue analysis-based optimization scheme**. Consider this option for feature fills with many lookup tables to fill when the default ADAM algorithm has poor convergence and the **Nonlinear least squares** algorithm is slow.

Previously, you could select only ADAM or **Nonlinear least squares** optimization algorithms.

Transient Calibration: Optimize ECU lookup tables using spline interpolation

During transient calibration, you can optimize engine control unit (ECU) lookup tables using spline interpolation, linear interpolation, or Chebyshev polynomials. Previously, you could only use Chebyshev polynomials as an alternative to linear interpolation of lookup tables.

Battery Calibration: Characterize an Equivalent Circuit Battery

Using MathWorks® tools, estimation techniques, and measured lithium-ion or lead acid battery data, you can use CAGE to characterize a resistor-capacitor (RC) circuit battery with open circuit voltage, series resistance, and 1 through N RC pairs. Transient Calibration: Simplified workflow and robust algorithms for large-scale optimizations

Transient calibration includes robust algorithms for large-scale optimizations. The feature fill allows you to:

- Select either adaptive moment estimation (ADAM) or nonlinear least squares for the optimization **Algorithm** parameter. Previously, the least squares algorithm was the only available large-scale optimization algorithm.
 - **ADAM (default)** - Algorithm that is typically more robust in the initial search for an optimization solution. Use for large optimization problems with large data sets and many parameters. Use in deep learning applications. For more information, see Deep Learning Toolbox Applications (Deep Learning Toolbox).
 - **Least squares** - Algorithm that has faster convergence. Use when the table values are close to the optimal values.
- Use the **Data comparison** parameter to compare `all values` or the `final value` in the data set to a reference signal. Previously, the Feature Fill wizard had a check box to use only the final value for the comparison.
- Specify a **Learning rate** parameter for the ADAM algorithm. If you select the least squares algorithm, the **Learning rate** parameter corresponds to the step size.
- For Least squares optimizations, select **Optimize simultaneously** to account for lookup table couplings. Selecting this option might produce more accurate optimizations but slow performance.

R2021b includes a simplified transient calibration workflow. When you optimize transient calibrations using large-scale feature fill, you can:

- Use optimization weights from a previous optimization.
- Update the lookup table breakpoints if the test data covers less than half the table data.
- Monitor the change in parameter values on a Fill Progress window.

If you import a Simulink model with a transient block, CAGE prompts you to select if you want to create a transient or steady-state feature fill.

Transient Calibration: Simplified workflow for production calibration using calibration parameter files

CAGE provides a simplified workflow for dynamic production calibration of vehicle components such as throttle and EGR control. Specifically, CAGE simplifies the workflow for working with calibration data. You can:

- Use a calibration data file to optimize and initialize all lookup tables and scalars for a feature fill. You can specify lookup tables and scalars that you want to adjust when you use feature filling. Previously, you had to manually adjust the tables and scalars. For more information, see Optimize Calibrations with Transient Controllers.
- Import or export a calibration to a `INCA CSV file` data file. For more information, see Import and Export Calibrations.

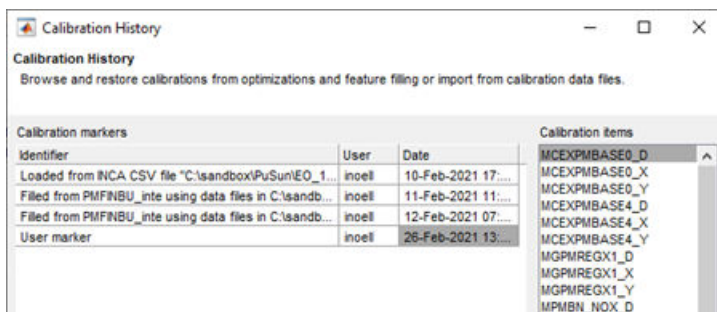
- Automatically export the calibration data after an optimization. For more information, see Optimize Calibrations with Transient Controllers.

Calibration History: Restore previous calibrations, including lookup tables, normalizers, and scalars

CAGE allows you to restore previous calibrations and calibrations items, including tables, normalizers, and scalars. You can restore previous calibrations from:

- Optimizations
- Feature fills
- Imported calibration data files

To restore a previous calibration in CAGE, select **Tools > Calibration History**. Use the dialog box to select the calibration and calibration items.

Transient Calibration: Optimize calibrations of dynamic systems like DPF and NOx controllers and OBD estimators

Use CAGE to optimize calibrations with transient controllers, which enables calibration of dynamic systems like diesel particulate filter (DPF) and nitric oxide and nitrogen dioxide (NOx) emission controllers, and on-board diagnostics (OBD) estimators. Specifically, CAGE can optimize calibrations for features that:

- Include delays, discrete integrators and filters, and feedback loops.
- Contain many (> 50) lookup tables that require estimation.
- Have multiple test data files to tune the feature.
- Require analytic derivatives to perform large-scale optimizations.

Automatic Differentiation in Feature Fills: Use analytic derivatives to provide faster, more reliable optimizations

Feature fills use automatic differentiation (AD) to automatically calculate gradients of objective expressions. These automatic gradients can provide faster, more reliable optimizations than the previous default, finite-difference, approximations. When it is possible to determine the analytic derivatives, CAGE uses AD for all feature fills.

- Large-scale optimization methods introduced in R2021a for transient calibration require AD.
- When it is not possible to determine an analytic derivative, for example, when differentiating a non-smooth expression, the feature fills revert to a finite-difference approach to determine the approximate derivative.

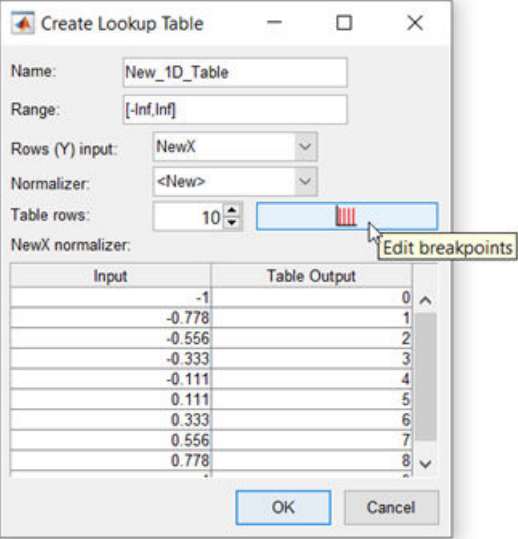
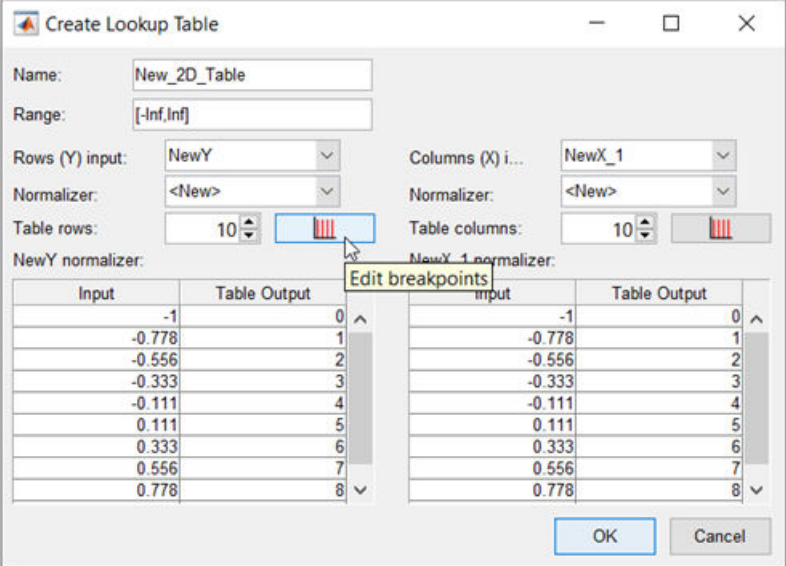

Lookup Tables: Simplified workflow for setting breakpoints and viewing 1D optimization results

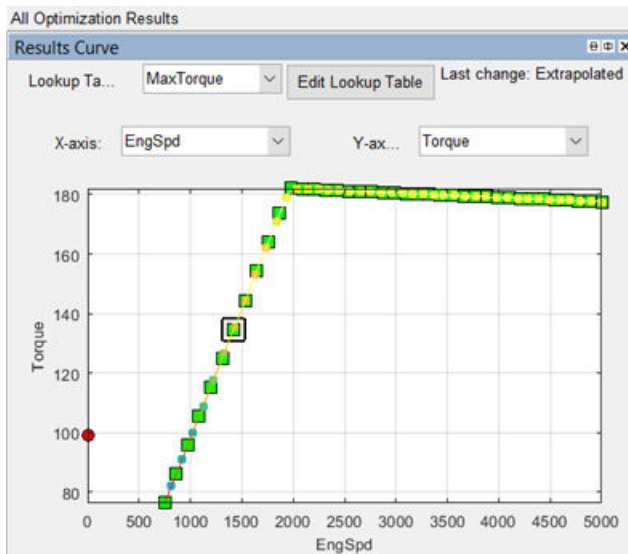
To simplify the workflow for creating lookup tables, CAGE allows you to set breakpoints and normalizers when you create the table. Previously, to set the breakpoints, you had to create the table and then use the **Breakpoint Fill** option.

Select **File > New > File > 1D Lookup Table** or **2D Lookup Table**. Use the Create Lookup Table dialog box to specify the following:

- Name
- Range
- Rows
- Normalizer
- Breakpoints with the **Edit breakpoints** option

When you view optimization results for a 1D lookup table, the Optimization Results view shows a 1D plot. Previously, the view showed a surface view.

Feature Fill: Performance improvements when filling a single lookup table

CAGE uses automatic differentiation to calculate the analytic derivatives during feature fill, resulting in performance improvements when filling a single table. The automatic differentiation applies during transient and non-transient feature fills. For more information, see [Fill Feature Lookup Tables](#).

Feature Fill: View, edit, and optimize calibration constants

To streamline feature filling, the CAGE browser view allows control of the calibration constants. Previously, you could only view, edit, and optimize calibration constants in the Calibration Manager. To edit the calibration constants, in the CAGE Feature Filling view, select the **Calibration Constants** tab. You can review and edit the calibration constants for the feature.

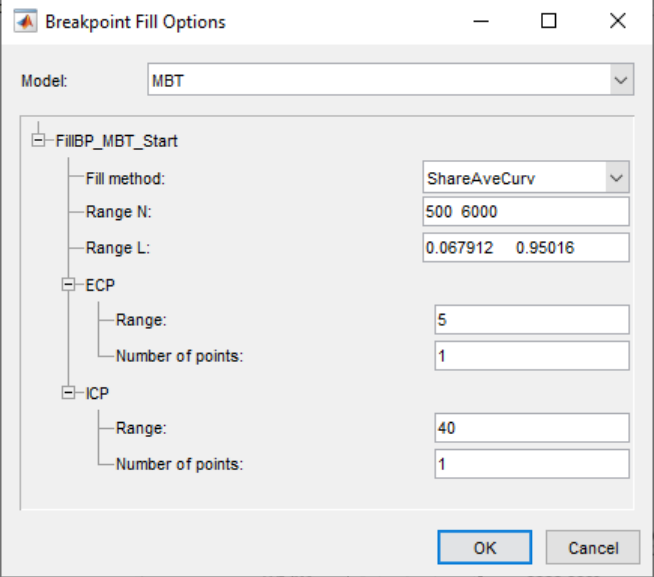

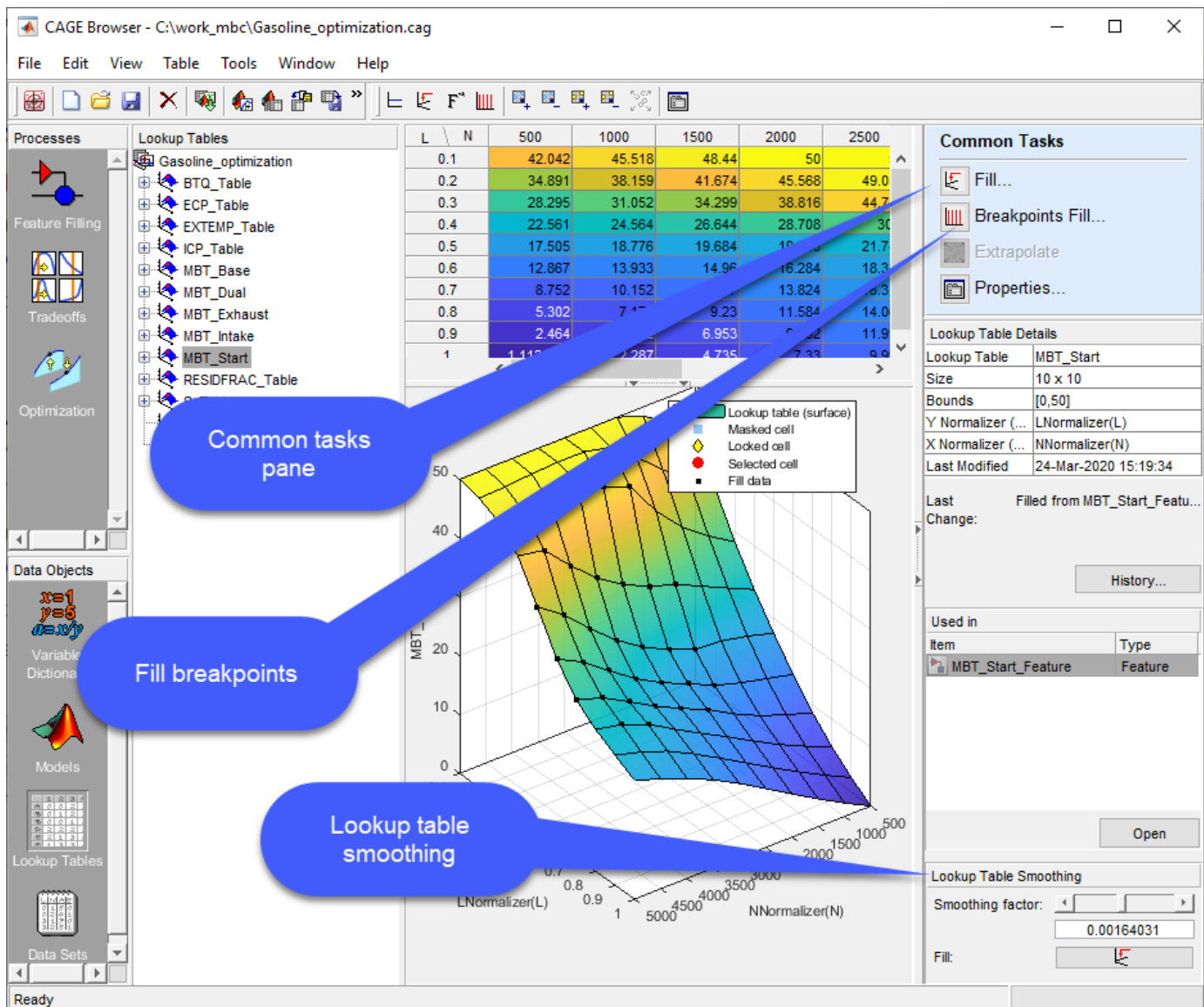

Model-Based Calibration Toolbox now includes simplified workflows for filling lookup table breakpoints, smoothing data, and accessing common tasks in CAGE.

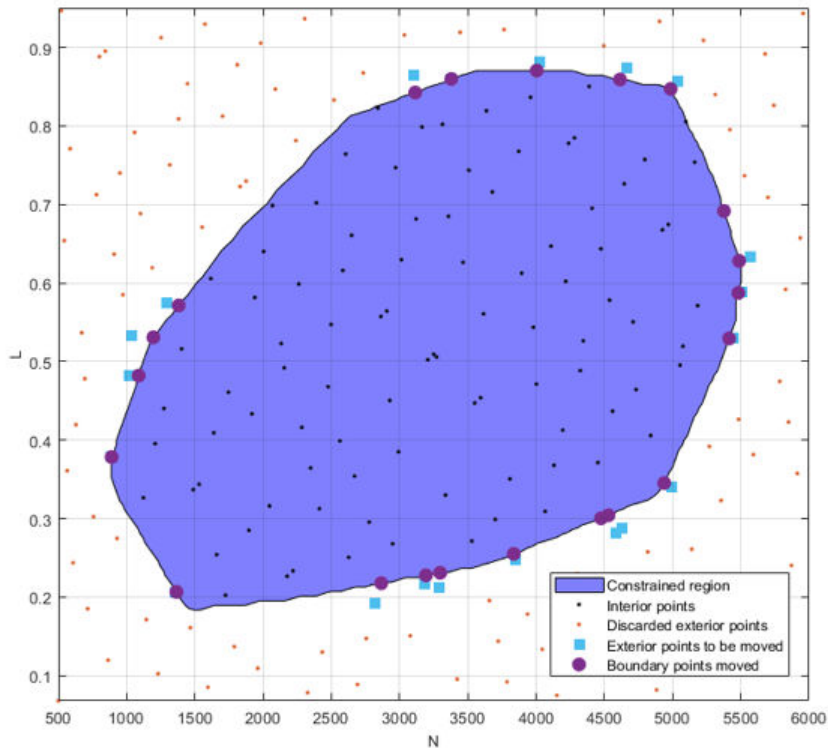

Design of Experiments: Add points for engine calibrations at operating boundary

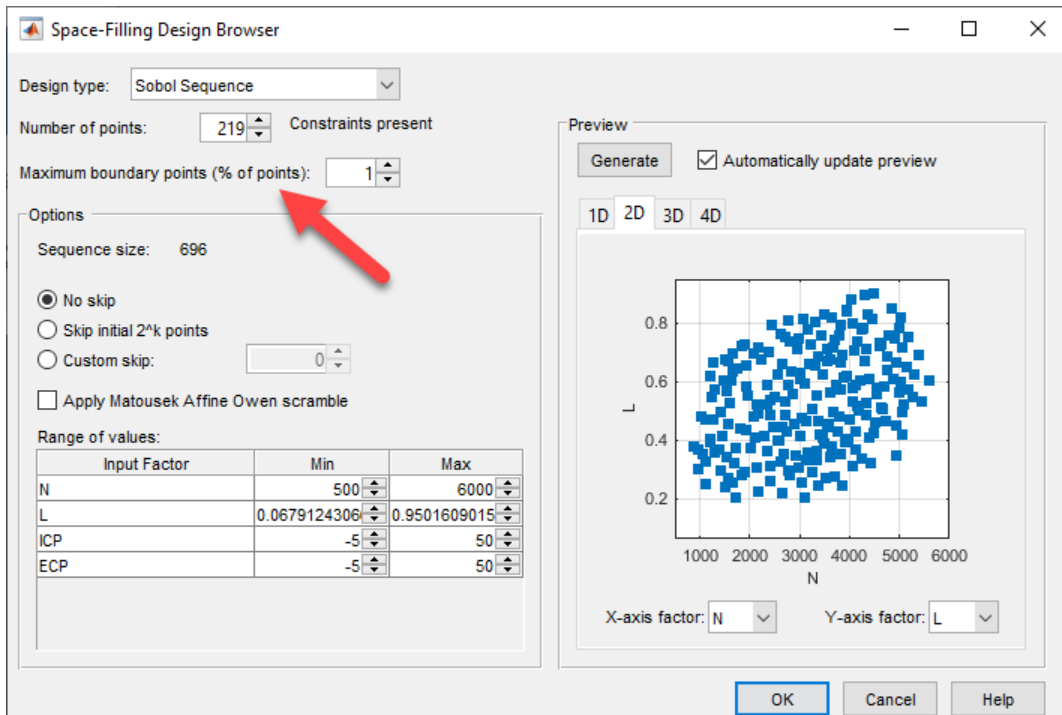
The Space-Filling Design browser has an option to add points at engine operating boundaries, creating more accurate engine calibrations. In the browser, when you specify a value for **Maximum**

boundary points (% of points), Model-Based Calibration Toolbox identifies operating points that are near the constraint boundary and exterior to the constrained operating region. In the illustration, the *Exterior points to be moved* are light blue. The software moves the identified points to the constraint boundary and includes them in the constrained region. In the illustration, the *Boundary points moved* are purple.



The **Maximum boundary points (% of points)** option limits the maximum number of boundary points as a percentage of the total number of design of experiment (DoE) points. The total number of DoE points is equal to the number of interior points plus boundary points. For example:

- If you set **Maximum boundary points (% of points)** to 100, Model-Based Calibration Toolbox projects all *Discarded exterior points* onto the constraint boundary.
- If you set **Maximum boundary points (% of points)** to 10 and the total number of DoE points is 100, the DoE will have 90 interior points and 10 boundary points. The exact number of boundary points might be less than 10% if the software finds a sufficient number of interior points.

Model-Based Calibration Toolbox sets advanced optimization options that depend on the number of optimization variables and constraints.

Optimization Solutions: Use soft constraints to find feasible optimization solutions

When you specify a soft constraint, Model-Based Calibration Toolbox does not require that the optimization satisfies the constraint. Instead, Model-Based Calibration Toolbox allows for some slack around the constraint. During the optimization, the algorithm satisfies the soft constraint by minimizing the slack and optimizing the objective. Consider specifying soft constraints when the:

- Constraint bounds are not well understood.
- Optimization has difficulty finding feasible solutions with hard constraints.

To specify a soft constraint, in CAGE, on the **Constraints** pane, select **Soft Constraint**.

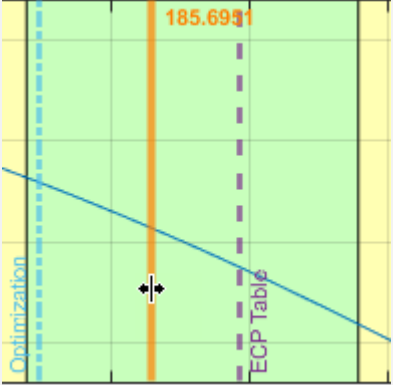

Response Models: Use parallel processing to fit data with one-stage and point-by-point models

By default, Model-Based Calibration Toolbox runs one-stage and point-by-point response model fits in parallel if you have Parallel Computing Toolbox™. Running the response model fits in parallel significantly reduces the computation time for large data sets.

When you fit the model with the data, Model-Based Calibration Toolbox calls `parpool` to open the parallel pool, if necessary. You see progress messages until the fitting completes. For more

information about parallel processing, see Specify Your Parallel Preferences (Parallel Computing Toolbox).

Data Outliers: Save time when you remove and restore data outliers from all response models

After you fit your data with a statistical model, you can quickly remove and restore data outliers from all response models. In the Model Browser, after you select a response model, select **Outliers > Apply to All Response Models**. After you select the option, these actions apply to all response models:

- **Remove Outliers**
- **Restore Removed Data**

Model-Based Calibration Toolbox updates the response and boundary model fits with the updated data. For more information, see Remove and Restore Outliers.

Previously, for large data sets, Model-Based Calibration Toolbox used the `fmincon` optimization algorithm. The LBFGS algorithm improves the optimization performance. You can use surface plots, data plots, and other plots to assess and compare models. You can use the RMSE plot to identify and navigate to problem tests.

Alternative model fits are now saved so it is faster to switch models and select a different model as best. If you open existing projects, you are prompted to refit the alternative models to store.

Point-by-point models are now immediately below the test plan node in the model tree, instead of reusing the local model node.

Automatic parallel execution of optimizations using Parallel Computing Toolbox

Optimizations automatically use Parallel Computing Toolbox when it is available. Previously you had to manually select parallel optimization.

Improved performance for parallel optimizations

Optimization speed when using Parallel Computing Toolbox is significantly faster because of improved transfer of data to the workers.

Changed Optimization Default Algorithm

New optimizations use the interior-point algorithm for `fmincon`. This is the default in Optimization Toolbox™.

Existing projects are not affected by the change in algorithm. New optimizations will use the new default algorithm. Usually, the new algorithm is faster and more robust. You can still select the previous default algorithm (`active-set`) if desired. This change affects: `foptcon`, `NBI`, and `Model` optimizations.

Faster Default Models for Large Data Sets

When you fit models to data and the data set is larger than a threshold, the toolbox uses new default models and boundary models.

New Gasoline Case Study Example

Common Tasks pane for fitting statistical models to data

If you want to load data and fit models, the Model Browser provides new tools to create models quickly. When you open the Model Browser, you can click common tasks to import data or fit models.

Importing data is simplified. You can click the common task to load data from a file or the workspace before opening the Data Editor. You can now import table objects from the workspace. You can also load data during the model fitting task.

When you click the Fit Models task, new dialog boxes help you select data and responses to model. The toolbox fits responses using the new default model type, Hybrid radial basis functions. Input names and ranges are taken from the data set. The toolbox also fits boundary models for you. Optionally, you can select a subset of your data for validation, and the Model Browser plots validation data with your model plots.

After fitting models, the Model Browser shows the next common tasks in the test plan view, to guide you on the next step in the workflow. You can click the common tasks list to generate a calibration or export models to Simulink.

The workflow is simplified compared to previous releases, when creating test plans was the first step for both fitting data and creating designs. Separating these workflows helps you get started with fewer options to choose. If you only want to load data and fit models, many fewer steps are required and the toolbox creates models using better defaults. You no longer have to interact with the test plan diagram to set up your models. You no longer need to match signal names, decide to copy data ranges, or choose model settings unless you want to.

Design Experiment dialog box for specifying input factors

To create a design when you open the Model Browser, click the Design Experiment task. A new dialog box guides you through specifying inputs and ranges for your design.

The workflow is simplified compared to previous releases. You no longer have to interact with the test plan diagram to set up your inputs. After you create your design and collect data, the Model Browser common task options Import Data and Fit Models guide you through the next steps. The new default model type, Hybrid radial basis functions, can produce better fits.

Genetic algorithm for global optimization of multiobjective drive cycle problems

You can use the new `gamultiobj` optimization algorithm in the CAGE browser. This algorithm is only available if you have Global Optimization Toolbox installed.

The `gamultiobj` algorithm is good for multiobjective optimizations with more than two objectives or those that are not smooth. Such problems can work better with `gamultiobj` than with the previous option for multiobjective optimizations, the NBI algorithm.

Analyzing results from these problems is easier with improved Pareto plots. The Pareto plot displays solution status highlighting of successful and unsuccessful solutions (Pareto, dominated, or

infeasible). Pairs of objectives are plotted against each other, so you see three plots for three objectives. Repeated axes and empty diagonal plots have been removed.

Code generation of exported models with Simulink Coder, by exporting using MATLAB Function blocks

All model types are exported to Simulink using MATLAB Function blocks. This enables code generation for deploying, sharing, and executing Model-Based Calibration statistical models using C code.

In R2014a, only polynomial models could be deployed. In previous releases, exported models contained S-functions instead of MATLAB Function blocks.

To deploy a model, ensure the **Inline parameters** option is on. The option is on by default when you export to Simulink. If you copy a block to another system, then set the option before building the exported block into an S-function.

Changed model defaults and automatic boundary model creation can produce better fits

The Model Browser new default models are Hybrid radial-basis functions (RBFs), which can usually produce a good fit the first time. The Model Browser also automatically creates boundary models for your global inputs using the convex hull type.

Hybrid RBF and RBF models have some new defaults and new parameters to produce better fits. These new settings work better for larger data sets, to choose more centers in a better distribution. The fitting algorithm selects up to 50% of the data as centers. Limits start to apply to data sets with >2000 observations. New parameters improve regularization and center selection to reduce overfitting.

You no longer need to interact with the test plan diagram to set up model types or open the Boundary Editor to create boundary models.

Import of table objects from the MATLAB workspace

In R2014b, the Model Browser provides the following improvements to data handling:

- You can import table objects from the MATLAB workspace.
- You can select **Data > Import Data from Workspace** in the project view when you open the Model Browser. This simplifies importing data, because you no longer need to open the Data Editor before loading data.
- You can create test filters for records within tests as well as whole tests. For example, `abs(SPK-mean(SPK)) < 10` keeps all records where SPK is within 10 of the test mean.
- You no longer need to reconfigure Data Editor views because it remembers layouts for each data set.

In CAGE, you can import and export between the workspace and CAGE data sets, including table objects. Export creates a table object.

Table information now displays size, bounds, normalizers, inputs and history in a single place. The Table Information pane provides easier access to the table history to revert to previous values.

Improved zoom capability in tradeoff plots allows you to set the axes limits to the constraint boundary. This reduces the y axis scale as the plots do not include regions where the model is extrapolating.

Import of more Math Operation Simulink blocks and subsystem hierarchy, enabling more complex calibration strategies

In R2013a, the CAGE Browser includes new and improved features for importing Simulink models into CAGE for feature calibration with reference to statistical models. New features include:

- Import strategies with multiple out ports.
- Import a strategy hierarchy by creating subfeatures for each subsystem. This makes it easier to understand how the model strategy corresponds to the features in CAGE.
- Reuse tables when importing strategies. CAGE reuses existing tables if they have the same inputs. If tables with the same name use different inputs, CAGE asks what you want.
- Switch blocks now support all operators. Previously CAGE could only parse $>=$.

Case study example showing calibrating a multi-injection diesel engine

R2013a includes new example files showing how to systematically develop a set of optimal steady-state calibration tables for a diesel multi-injection engine using Model-Based Calibration Toolbox.

The engine to be calibrated is a 3.1L multi-injection combustion ignition engine with common rail, variable-geometry turbocharger (VGT), and cooled exhaust gas recirculation (EGR).

The aim of the calibration is to minimize Brake Specific Fuel Consumption (BSFC) at specific speed/load operating points across the engine's operating range, and meet the following constraints:

- Limit total NOx emissions.
- Limit maximum turbocharger speed.
- Limit calibration table gradients for smoothness.

The analysis produces optimal calibration tables in speed and torque for:

- Best main start of injection timing
- Best total injected fuel mass per cylinder per cycle
- Best pilot injection timing relative to main timing
- Best pilot injection fuel mass fraction of total injection mass
- Best exhaust gas recirculation (EGR) position
- Best variable geometry turbocharger (VGT) vane position
- Best fuel rail pressure relative to nominal pressure vs. engine speed

Use model ranges from point-by-point models as optimization bounds

In R2013a, the CAGE Browser uses model ranges from point-by-point models instead of data variable ranges. Providing more precise bounds can help optimizations to converge quicker. For point-by-point models, the variable ranges can be much larger than the bounds for a particular operating point.

In previous releases, CAGE used data variable ranges instead of model ranges. If the data ranges for operating points differ widely across model operating points, this could cause optimizations to run more slowly or fail to converge. The data range often contains large infeasible parts of the space between the bounds that are outside the boundary model constraint. Using more precise model ranges can help the optimization find a feasible result.

Table filling from optimization results, when optimization operating point inputs are different from table inputs

For some optimization problems, you want to optimize at operating points in different variables to the tables you want to fill, and use response models as normalizer inputs to tables. For example, if your problem requires running an optimization at torque and speed operating points, but you want to fill lookup tables on axes of `mainfuel` (a response model) and speed.

Previously, it required many manual steps to create and fill such tables from your optimization results. The toolbox now provides tools to quickly create tables with response models as normalizer inputs, and select such tables to fill with your optimization results. Now you can use your optimization results to fill lookup tables with different inputs to your optimization operating point inputs.

CAGE and Model Browser file sizes are reduced by up to 95% for point-by-point projects, enabling easier file sharing.

More Efficient Boundary Modeling

More efficient boundary modeling contributes to reducing file sizes. Identical boundaries are shared between response model fits instead of duplicated.

The convex hull model is simplified for more efficient boundary modeling. In a typical example, using 8 factors and 70 points results in a convex hull with around 35,000 faces. By default, the boundary model now keeps only the most useful facets and can discard around 30% of the facets because they contribute only a small amount to the boundary. The new method is more efficient and includes all data points within the boundary, with the total volume increasing by around 1%. If you want the minimal volume at the expense of a much larger number of facets, you can select a new option, **Keep All Facets**.

Stored Feature Filling Settings

CAGE projects now store last-used settings for tables, models, data, and optimizations for feature filling. The Feature Filling Wizard can require many steps to set up and you might need to repeat this process many times. You can remove saved fill settings using a new menu item, **Feature > Reset Fill Settings**.

If you have Global Optimization Toolbox you can now use the MultiStart algorithm in CAGE. This algorithm tries to identify local optima to help you create smoother tables. Multiple local optimal solutions are often found because of the flat nature of engine responses. The difference in performance between these different solutions can be small and result in tables that are not smooth enough. The new MultiStart algorithm tries to identify multiple optimal solutions for each operating point. You can select the solutions that meet your table smoothness constraints based on the entire table.

Tradeoff Tool Plots Local Model Ranges

New Composite Models for Multiple Operating Modes

Version 4 of Model-Based Calibration Toolbox enables you to produce optimal calibrations for engines with multiple operating modes. You can use the new *composite* model type to combine a number of models to represent engine responses under different operating modes. You can use the composite model in CAGE to produce optimal calibrations for engines with multiple operating modes. Use for calibration problems where the goal is to fill a single table for all modes or to fill a table for each mode.

You can create a composite model by either:

- Importing to CAGE from the Model Browser
- Combining existing models in CAGE

The composite model consists of a collection of models with an extra mode input. The mode input is an index into the list of models. The component models can have different sets of inputs.

Update Models with Additional Data

You can now update test plans in the Model Browser with new data points while retaining boundary models and validation data.

Previously, when you updated test plan data, the toolbox deleted boundary models and validation data. The toolbox retained local fits, including your outlier selections, if their test data was unchanged after adding new test plan data.

In R2010a, when you update test plan data, the toolbox refits boundary models and retains validation data. Thus, you have less rework to do when fitting models as you collect more data.

The test plan data update functionality is particularly important for building two-stage or point-by-point models. You can load local models into the Model Browser as you collect the data. The update functionality ensures that you do not lose current work when you load data for new tests. The update functionality is also useful when you augment a one-stage design because you need more data to build an accurate model.

Input signal names need to match when update test plan data. The toolbox deletes boundary models and validation data if the input signal names change.

New Optimization Algorithm for Multiple Operating Modes

Version 4 of Model-Based Calibration Toolbox enables you to produce optimal calibrations for engines with multiple operating modes. You can use the new Modal optimization algorithm to select optimal operating modes for such calibrations. This algorithm helps you choose the best operating mode for each operating point. The algorithm can optimize an objective for each operating mode and select the best solution automatically. You must use a composite model for these optimizations.

This release also introduces enhanced optimization output views to help you view the solutions and decide which mode you want to use for each operating point. The enhanced views make it easier to see which solution is selected and to change the selection. These features are also useful for selecting solutions for multiple objective optimizations such as NBI.

You can only use modal optimization for point optimization problems. When you have selected the best mode for each operating point, you can create a sum optimization from your modal optimization results. The toolbox automatically creates a sum optimization for you with your selected best mode for each operating point. For more information see `Set Up Modal Optimizations` in the CAGE documentation.

New example projects are provided to illustrate using the new features to produce optimal calibrations for diesel and gasoline engines with multiple operating modes. See `Example Composite Models` and `Modal Optimizations`.

Table Gradient Constraints of Models

With R2010a you can apply table gradient constraints to models to restrict optimal solutions to smooth responses. Previously, you could only constrain the table gradients of variables. Optimal calibrations need constraints on both model responses and variables. You can now specify a maximum gradient for engine responses as well as control inputs.

Sometimes the inputs for testing differ from the inputs for tables. In such cases, engineers often use a model to derive the table input. To constrain the table gradient you need to define a gradient constraint for models. You can also define a constraint on the smoothness of the engine response for drivability.

You can define a table gradient constraint for any free variable in your optimization or any model that has a free variable as an input. The Edit Constraint dialog box for the table gradient constraint has been rearranged to simplify workflow.

You can only use table gradient constraints for sum optimizations because the toolbox needs multiple operating points to estimate the table. If you require filling rules to select part of the optimization results for filling, then use the table gradient constraints in combination with application point sets. In particular, if your goal is to fill different tables for each mode, then define application point sets for each mode. For an example, see

Composite Model Example with Separate Tables for Each Mode in the Getting Started documentation.

Filter Rules for Table Filling

You can now apply filter rules to select part of the optimization results for table filling. You can specify an operating mode or any valid expression as a filter when using the Table Filling wizard.

The filter rules are important for modal optimizations. Composite models can require the ability to select part of the optimization results to fill a particular table. For example, you need to discard solutions for other modes when filling a table with an input that is not used for all modes.

- Use filter rules when your goal is to fill a different table for each mode.
- Specify a filter rule with a logical expression using any input or model available for use in table filling.
- The Table Filling from Optimization Results wizard automatically sets up filter rules for you if some inputs are not used for all modes in your composite model.

For an example, see Filling Tables for Operating Modes in the CAGE documentation.

Incremental Table Filling

New settings in the table filling wizard enable you to incrementally fill lookup tables from the results of multiple optimizations with smooth interpolation through existing table values. CAGE can extrapolate the optimization results to pass smoothly through table masks and locked cells. Use these features when you want to use separate optimizations to fill different regions of a lookup table.

Use the new check boxes in the Table Filling from Optimization Results wizard to specify when you want to:

- Use locked table values in extrapolation.

If your calibration tables have fixed values for some table cells, use locked cells for the table cells with fixed values. Such cells often appear on the edge of a table.

Select this check box and CAGE smoothly fills the table between fixed table values and optimization results.

- Use existing extrapolation mask in fill.

Select this check box when you want to fill the same table from multiple optimizations that provide solutions at different operating points. Complex calibration problems can require different optimizations for different regions of a table. The toolbox automatically adds filled cells to the table mask.

Select this check box for subsequent table filling. CAGE smoothly fills the table between the values in the mask (from previous table filling) and the current optimization results.

The toolbox now supports ATI VISION Version 3.5.1.

You can import and export calibrations directly from/to ATI Vision (via a live link or .mat files). See Importing and Exporting Calibrations in the CAGE documentation.

New Optimization Parameters

A new setting in the Optimization Parameters dialog box for the `foptcon` algorithm allows you to choose one of the `fmincon` function algorithms: `active-set`, `sqp`, `interior-point`. First try the default, `active-set`, the only option in previous releases. If you have sum optimizations which are slow or have problems converging, you can try the new `sqp` or `interior-point` options. For details of `sqp` see New `fmincon` Algorithm in the Optimization Toolbox release notes.

To use the new options in CAGE, see the **Constraint optimization algorithm** setting described in Edit Optimization Parameters in the CAGE documentation.

New Example Projects for Calibrating Engines with Multiple Operating Modes

Version 4 of Model-Based Calibration Toolbox enables you to produce optimal calibrations for engines with multiple operating modes. Examples of applications include: multi-injection diesel engine; inclusion of startup conditions in drive cycles; rich and stoich regions for engines.

Command-Line Interface to the Model-Based Calibration Toolbox Software

The command-line interface to the Model-Based Calibration Toolbox software enables the modeling process to be automated using MATLAB commands. In this way, you can simplify the modeling process for technicians and engineers who might not have extensive background and training in this area. You can also access modeling functionality from test bed automation tools.

Improved CAGE Setup

The CAGE Import Tool allows easier reusability of CAGE sessions. You can use the CAGE Import Tool to import models, data sets, optimizations and features from any Model-Based Calibration Toolbox project file produced in CAGE or the Model Browser (.mat or .cag). This feature can greatly simplify the application of proven feature filling and optimization processes to new engine variants.

Optimization

Optimization in CAGE has had major updates:

- Significant speed improvements
- New optimization parameters that help avoid local minima by specifying multiple start points, and running only from feasible start points
- Automatic scaling of objective and constraint values improves numerical stability of algorithms
- Enhanced table filling from optimization results now allows more flexible filling methods: you can exclude infeasible solutions, choose whether to extrapolate, use selected solutions, and apply custom fill algorithms
- Enhanced API for user-defined optimization scripts
- Improved results visualization for drive-cycle optimizations and multiobjective optimizations
- Improved constraint display for non-model constraints (1-D and 2-D tables, ellipsoid, etc.)

Version History

Some existing user-defined optimization scripts may require a call to the function `setRunInterfaceVersion` to fix incompatibilities. You can also do this in the CAGE Browser GUI in the Optimization Parameters dialog box.

If you want to use the new `foptcon` optimization parameters (multiple start points and run only from feasible start points) with existing optimizations, you must use the menu item **Optimization > Reset Parameters**.

Calibration Tool Interface

New links to standard industry tools allow import and export of calibrations directly from/to ATI Vision (via a live link or .mat files) and ETAS INCA (via .dcm files).

Boundary Modeling

You can model boundaries using convex hulls. You can create boundary models for subsets of inputs, which simplifies the boundary identification process for complex engines. Improved visualization tools

in the Boundary Editor help you construct accurate constraints. Boundary constraints can now be imported into the Design Editor and exported to Simulink.

Feature Filling

The Feature Fill Wizard uses new algorithms to fill and optimize table values with reference to a model. You can fill multiple tables simultaneously using the wizard, extending the range of calibration problems that CAGE can solve. You can impose gradient and smoothing penalties, and fill lookup tables on a region-by-region basis.

Surface Viewer Movie

The Surface Viewer now has a movie mode that is faster and easier to use, with an interactive progress bar.
