# Percentile plots add time point binning as an option to compute summary statistics

The percentile plot in the **SimBiology Model Analyzer** app computes time-varying summary statistics for measurement data and simulated model responses. Previously, the percentile plot interpolated measurements and simulated responses onto a common time vector to compute the summary statistics. You now have the additional option to bin the measurements and responses by their corresponding time points and compute the summary statistics for each bin. Specifically, the percentile plot allows you to:

- Choose whether to use the time point binning or interpolation over time to calculate summary statistics of measurement data. You can change this option in the corresponding data source settings of a percentile plot in the Property Editor > (Data1) Settings > Data aggregation method > interpolation or binning.
- If you select **binning**, you can:
  - Use an automatic time point binning algorithm by selecting **Binning method** > **auto**.
  - Specify the number of time point bins or bin edges by selecting **Binning method** > **specify number of bins** or **specify bin edges**, respectively.

For details, see "Percentile Plot".

#### Access fit data stored in fit results objects

Use the Data property of a fit results object (OptimResults, NLINResults, and NLMEResults) to retrieve the data that was used for fitting.

In most cases, this Data property contains a copy of groupedData specified as the input data in the sbiofit or sbiofitmixed call, or the Data property of a fitproblem object. One exception is that for unpooled fits using sbiofit or fitproblem.FitFunction = "sbiofit", you get a vector of fit results objects, representing one results object per group. The Data property of any of such fit results object contains only the subset of rows that corresponds to the group used for that fit (instead of every row the original fit data had).

#### Functionality being removed or changed

#### groupedData does not allow math operations supported by table

Previously, groupedData has supported every function of table. However, the new table math operations that are introduced starting in R2023a are not supported by groupedData. Examples of such math operations include +, -, /, min, max, and mean.

# Refresh comparison results and select different models from SBPROJ files in Comparison Tool

The Comparison Tool for SimBiology models lets you select which models to compare from input SBPROJ files if the files contain multiple models. Use the **Models** button in the **Comparison** section of the toolstrip. You can also refresh the comparison results of two models shown in the tool using the **Refresh** button. For details, see Compare SimBiology Models.



#### Specify solver and output time points in Simulation step

For **SimBiology Model Analyzer** programs with the **Simulation** step, the step now lets you specify solver and output times in addition to the simulation stop time. The solver times are the time points used by the ODE solver during model simulation. The output times are the specific time points that you want to include in the simulation. Specifying output times can be useful to log simulation responses at specific times of interest or to log fewer time points to reduce the size of simulation data, for example, from large parameter scans.

#### Local Sensitivity Analysis supports abs, min, and max

SimBiology local sensitivity analysis (LSA) now supports models that contain expressions referencing abs, min, and max functions. SimBiology now has a replacement for each of these functions to make them compatible with the complex-step approximation used by LSA. For details, see simbio.complexstep.abs, simbio.complexstep.max, and simbio.complexstep.min.

SimBiology automatically uses these replacement functions whenever:

- You calculate local sensitivities using sbiosimulate, a SimFunctionSensitivity object, or the **Calculate Sensitivities** program.
- **sbiofit** or **fitproblem** uses local sensitivity analysis to determine the gradients of the objective function during parameter estimation.

#### **Compatibility Considerations**

To calculate local sensitivities of a model that references a custom function that uses abs, min, or max as part of the function definition, you need to update the custom function to replace abs, min, and max functions with simbio.complexstep.abs, simbio.complexstep.min, and simbio.complexstep.max, respectively.

For instance, your custom function customFunc calls abs as part of the function definition, and some model expressions (such as reactions, rules, or events) reference customFunc. To calculate local sensitivities of such a model, you need to edit customFunc and replace all instances of abs with simbio.complexstep.abs. For an example, see Use Replacements for abs, min, and max in Custom Functions for SimBiology Local Sensitivity Analysis.

#### Specify GSA plot colors using color names or hexadecimal color codes

For plots of GSA results (SimBiology.gsa.Sobol, SimBiology.gsa.ElementaryEffects, SimBiology.gsa.MPGSA), you can now specify the plot colors using color names (or short names) or hexadecimal color codes, in addition to RGB triplets. For details on valid color names and corresponding triplets and hexadecimal codes, see Specify Plot Colors.

#### Functionality being removed or changed

#### **Duplicate model component names will not be allowed in a future release** *Warns*

- SimBiology issues a warning if multiple model components (model, compartment, species, parameter, reaction, rule, event, observable, dose, and variant) have the same name. In a future release, within a single model, these components will be required to have unique names even when they are of different types with the following two exceptions:
  - Species in different compartments can have the same name.
  - Parameters can have the same name if they are scoped to different parents. Specifically, you can use the same name for a model-scoped parameter and reaction-scoped parameters, where each reaction-scoped parameter belongs to a different reaction.

The purpose of this naming restriction is to ensure that every model component can be unambiguously referenced by its unique name within a model. For details on how to reference model component names in expressions, see Guidelines for Referencing Names in Expressions.

- To disambiguate duplicate names from your model, use the updateDuplicateNames function at the command line. The function takes in a SimBiology model as an input and updates the component names as necessary. You can also specify optional outputs, such as a logical flag to check whether any update occurred, a list of model changes, and a copy of the original model before any updates were made.
- The updateDuplicateNames function disambiguates the duplicate names by adding a suffix "\_N", where N is the first positive integer that results in a unique name. If there is an existing suffix, N will be incremented from that suffix. For example, if there are two model components named x\_3, the function updates one of the names to x\_4. If the existing suffix has leading zeros, the function omits the zeros in the new name. For instance, if x\_003 is a duplicate name, it gets renamed to x\_4. However, the function assumes that names with leading zeros and without leading zeros are different. For instance, x 005 and x 5 are considered to be different names.

**Tip** To get a list of model components with the same name, do one of the following:

- At the command line, enter sbioselect(model, Name="dupName"), where model is your SimBiology model and dupName is the duplicate name.
- In **SimBiology Model Builder**, you can filter the components by entering the duplicate name in the **Browser** pane.

## sbiosampleparameters accepts groupedData and no longer requires group column for covariate data

Behavior change

For sbiosampleparameters, you can now use a groupedData object as an input for fixed effects (thetas), the covariance matrix of random effects (omega), and covariate data (ds). For the covariate data, it no longer requires a group column that specifies the group labels.

#### plotData shows median response instead of mean response by default

Behavior change

The plotData function of GSA result objects now shows the median model response instead of the mean model response by default. Use the name-value arguments ShowMedian or ShowMean to plot either the mean or median response. To preserve the behavior prior to R2022b, specify:

plotData(gsaResults,ShowMean=true,ShowMedian=false);

# For percentile plots in Model Analyzer, data options are now shown separately for each data source

Behavior change

**SimBiology Model Analyzer** now shows the **Time vector**, **Interpolation method**, and **Show raw data fraction (%)** options for each data source in the **Property Editor** pane for percentile plots. You can change these options independently of one another. For example, the following figure shows these options for each data source (simulation data from the program **Program2:SimDataI** and experimental data **Data1**). #### week has been added as a built-in unit

Behavior change

You can now use week as a built-in unit and no longer have to create your own custom week unit. However, suppose that you have added a custom week unit to the user-defined (custom) library in a previous release (R2022a or earlier), installed the new version of MATLAB (R2022b or later), and your preferences from the previous release was imported (automatically by MATLAB or manually by you). When you interact with SimBiology for the first time in your latest MATLAB, SimBiology:

- **1** Switches to use the built-in week unit.
- 2 Renames the custom unit to week\_N, where N is a positive integer.
- 3 Shows a one-time warning message indicating that your custom week unit has been renamed.

Use sbioremovefromlibrary at the command line or go to **Home** > **Libraries** from the **SimBiology Model Builder** app to remove the custom unit if it is no longer needed.

#### Tip

- Check the model component properties, namely, Notes, Tag, and UserData, to see if the custom unit is being referenced by these properties before removing the unit.
- Update references to use the new name (week\_N) if the built-in week unit is not sufficient for your use case.

#### Compare SimBiology models and diagram information

Use sbiodiff to compare two SimBiology models and generate a list of differences between them. If models contain diagram information, then the function also compares and reports the diagram (graphical) differences.

To view the comparison results graphically in the Comparison Tool, do one of the following:

- At the command line, call visdiff(*diffResults*), where *diffResults* is the SimBiology.DiffResults object returned by sbiodiff.
- At the command line, call visdiff with two SBPROJ files as inputs.
- On the Home tab of the MATLAB® desktop, click Compare, and select two SBPROJ files.
- Select two SBPROJ files in the **Current Folder** panel of the MATLAB desktop. Right-click and select **Compare Selected Files/Folders**.

The feature also has MATLAB Git  $^{\text{m}}$  integration. You can compare SBPROJ files that are in a Git repository from within MATLAB.

#### Simulate different groups, doses, and variants from data set

Simulate different groups from your data set using the **Group Simulation** program in the **SimBiology Model Analyzer** app. The program also lets you apply any group-specific doses and variants defined in your data. To open the program, select **Program** > Group Simulation. For a workflow example, see Simulate Groups Using Doses and Variants from Data Set.

#### View and run generated MATLAB code by Model Builder app

**SimBiology Model Builder** can generate MATLAB code of various modeling actions that you perform in the app. The generated code shows, for example, how to add model components, configure block properties in the diagram, and change simulation settings at the MATLAB command line. You can save the generated code as a script and run it at the command line.

To view the generated code, go to the Model Tools panel below the Browser panel and select Code.

Note that if the generated code contains diagram (graphical) changes, the app needs to be open. The app can selectively generate code for only model component changes (object code), only graphical changes (diagram code), or both model and diagram changes. To generate code only for the model component changes or graphical changes, select **Capture object and diagram code** > Object code or Diagram code, respectively. To save the generated code as a script, click **Save**.

#### Import and export variants and doses from spreadsheets

In the **SimBiology Model Builder** app, you can now export and import variants and doses to and from Excel<sup>®</sup> spreadsheets. To export, select **Export** > Export Model Components to Excel. To import, select **Model** > Import Model Components from Excel. You can also import from and export to multiple sheets in an Excel file. For details, see Import and Export Variants and Doses from Excel to SimBiology Model Builder.

#### Use different sampling options in Model Analyzer programs

The **Generate Samples** step in the relevant programs of the app lets you specify additional options for the following sampling methods.

• latin hypercube sampling with rank correlation matrix

- sobol sampling with rank correlation matrix
- halton sampling with rank correlation matrix

The next figure shows an example of additional options, such as **Skip** and **Leap**, for **sobol** sampling with rank correlation matrix.

#### Perform global sensitivity analysis in SimBiology Model Analyzer

**SimBiology Model Analyzer** now has the Global Sensitivity Analysis program. The program lets you calculate Sobol indices, perform multiparametric global sensitivity analysis (MPGSA), or compute elementary effects. To open the program, select **Program** > Global Sensitivity Analysis.

For a workflow example, see Find Important Parameters with Global Sensitivity Analysis Using SimBiology Model Analyzer.

#### **SUNDIALS version update**

SimBiology now uses the SUNDIALS Solvers version 5.7.0. Previously (from R2018b to R2021b), SimBiology used 3.1.0.

#### SimData: Improved performance when creating many SimData objects

The SimData object shows improved performance when creating many SimData objects. For example, the following code is about:

- 1.4x faster when creating SimData from a SimFunction object
- 7x faster when creating SimData with addobservable
- 10x faster when creating SimData with removebyname

#### Compartment blocks can no longer be hidden

Behavior change

In **SimBiology Model Builder**, you can no longer hide the compartment blocks in the diagram. Starting in R2022a, if you load an older project with hidden compartments, they become visible.

For compartment blocks, simbio.diagram.setBlock no longer accepts "Visible" as one of the properties that you can change, and it is always set to 1.

#### delete function of SimData has been removed

Errors

### plotData shows median response instead of mean response *Warns*

The plotData function of GSA result objects now shows the median model response instead of the mean model response by default. Use the name-value arguments ShowMedian or ShowMean to plot either the mean or median response. To preserve the behavior prior to R2022a, specify:

plotData(gsaResults,ShowMean=true,ShowMedian=false);

#### sbmlimport: support for URL protocols other than HTTP and HTTPS has been removed Errors

Support for passing in a URL that is not HTTP or HTTPS as an input to sbmlimport has been removed. Download the file locally first and then use the file name as an input instead.

#### Naming restriction on SimBiology model components

Behavior change in future release

In a future release, there will be a naming restriction on the following model component types: model, compartment, species, parameter, reaction, rule, event, observable, dose, and variant. The restriction is that within a single model, these components will be required to have unique names even when they are of different types with the following two exceptions:

- Species in different parent compartments can have the same name.
- Parameters with different parents can have the same name. Specifically, you can use the same name for a model-scoped parameter and reaction-scoped parameters, where each reaction-scoped parameter belongs to a different reaction.

#### Specify different parameter values for different groups during fitting

You can specify predefined group-specific parameters during parameter estimation. At the command line, you can do so by using a matrix of variants or cell vector of variants. In the **SimBiology Model Analyzer** app, you can do so by populating the **Variant and Dose Setup** table in the **Fit Data** program.

At the command line, for a fitproblem object (new in R2021b), you can use group-specific parameters by setting its Variants property to a variant matrix or cell vector of variants.

For sbiofit and sbiofitmixed, use the 'Variants' name-value argument to specify such information. You can do the same for the predict and random methods of the LeastSquaresResults and NLMEResults objects.

If you are using a variant matrix, the number of rows must either be one or equal to the number of groups in your data. Each row is applied to a separate group. If there are multiple columns, the variants are applied in order from the first column to the last. If using a cell vector of variants, it must have one entry per group, where each cell entry is a vector of variants that are applied to a separate group, in the same order as the groups appear in your data. To facilitate creating such variants from your data, the groupedData object now has the createVariants function.

For the **Fit Data** program in the **Model Analyzer** app, you can specify the group-specific variants and doses in the **Variant and Dose Setup** table. The variants are applied from right to left. You can change the order by using the arrows on the top right of the table. To add a group-specific dose or variant column, click the corresponding icon at the bottom of the table. To remove a group-specific dose or variant column, select any cell in the column and click the cross icon on the top right. To remove a baseline dose or variant column, clear the corresponding check box from the preceding **Baseline Doses** or **Base Variants** table. To remove a dose or variant column from data, clear the corresponding check box from the **Data Map** table.

#### Generate reports for model and program results

You can generate customizable reports containing a summary of model information and results from analysis programs.

Use **SimBiology Model Builder** app to generate a report of your model information, such as model diagram, equations, doses, and variants. Select **Export** > Generate Model Report on the **Home** tab. To export just the diagram, select **Export** > Export Diagram. For details, see Generate SimBiology Model Report.

Use **SimBiology Model Analyzer** to generate a report for each program result. To generate a report, first run the program. Then, in the **Browser** pane, on the **Project** tab, right-click the **LastRun** folder or any saved folder under the program and select **Generate Report**. By default, the app saves a copy of the model and data information used in each program run so that such information can be included in the report for that specific run. Consequently, the project file can increase in size. For details, see Generate Report for SimBiology Program Results.

#### **Compatibility Considerations**

Previous Export Model as HTML and Export Model Equations as HTML options in the Model Builder app have been combined into one option: Generate Model Report.

#### Model simulation tool

From within the **SimBiology Model Builder** app, you can use the **Model Simulation** tool, which provides a convenient way to visualize the model behavior by simulating it (without having to open the **Model Analyzer** app and run a simulation program). The tool appears on the right-hand side of the app beneath the **Property Editor** pane. Using the tool, you can simulate and visualize time courses for model quantities or observables and check the corresponding time plots. To plot a

quantity or observable, right-click it in the **Diagram** or **Browser** and select **Plot State**. If you already have a plot open in the tool, you can enter the name of the state in the legend table. The legend drop-down menu lists all possible states and observables. The **Options** menu lets you specify the simulation stop time, variants, and doses to use during simulation.



The legend table has an action menu that lets you remove plots, change the *x*- and *y*-scales, and export the plots. To see the action menu, point to the legend table and click the icon on the top right corner.

#### **Percentile plots**

The new percentile plot in the **SimBiology Model Analyzer** app shows the percentile curves over time for an array of time courses from parameter scans, scenario simulations, or experimental data.
The plot can also show other statistics such as mean, standard deviation, maximum, and minimum values. For details, see Percentile Plot.

To get a percentile plot, click a data source that contains time courses in the **Browser** pane, then select **percentile** in the **Plot** section of the **Home** tab. By default, the plot shows the 5th and 95th percentiles, and you can customize them as needed. You can drag and drop multiple data sources on to the same plot. An example of a percentile plot is shown in the following figure. For a workflow example, see Visualize Simulation Statistics and Overlay Experimental Data Using Percentile Plot.



### **Plotting improvements**

The SimBiology Model Analyzer app has the following plotting improvements:

• Improved binning for continuous data variables — You can bin (or group) time courses of responses using different associated variables such as group IDs, scanned parameter values, dose amounts, or weight. The algorithm to detect the bin boundaries for continuous variables, such as weight, has been updated so that the variable values are distributed evenly across bins. The following plot shows an example of time courses from 59 patients binned by the continuous data variable WEIGHT.



• Axes limits — You can now set custom axes limits for plots. Go to the **Plot Settings** tab of the **Property Editor**. In the **Configure Axes** section, you can enter XLim and YLim values.

### Hide or show grid lines from diagram

You can hide or show grid lines in the **Diagram** tab of the **SimBiology Model Builder** app. Rightclick anywhere in the diagram, and select **Hide Grid Lines** or **Show Grid Lines**.

# Integration-based profile likelihood support for parameter confidence intervals in SimBiology Model Analyzer

For parameter confidence interval calculations in the app, you can now use the integration-based profile likelihood method. Set **Method** to profileLikelihood and set **UseIntegration** to true in the **Parameter Confidence Intervals** section as shown in the following figure.



This method was introduced to the command line function sbioparameterci in R2021a, and it is now available to use from within the app. The method is based on integrating differential equations derived from the Lagrange equations. For details, see Profile Likelihood Confidence Interval Calculation.

# Perform global sensitivity analysis using elementary effects (Morris Method)

sbioelementaryeffects lets you compute elementary effects to assess the global sensitivity of a
model response with respect to variations in model parameters. You can choose between the Morris
method (by setting 'PointSelection' to "chain") [1] or the Sohier method (by setting
'PointSelection' to "radial") [2] to compute elementary effects. It is a global sensitivity
analysis (GSA) function in addition to the existing sbiosobol and sbiompgsa. For details, enter
help sbioelementaryeffects.

# Support for nonuniform sampling in sbiosobol and sbiompgsa

sbiosobol and sbiompgsa now support nonuniformly distributed parameter samples. You can specify such samples by passing in a SimBiology.Scenarios object as the second input argument or by specifying the 'Distributions' name-value argument with a vector of probability distribution objects as its value.

## Sampling options for SimBiology.Scenarios and GSA functions

SimBiology.Scenarios, sbiosobol, and sbiompgsa now have the new name-value argument
'SamplingOptions' to specify options for different sampling methods including 'sobol',
'halton', and 'lhs'.

### fitproblem object for parameter estimation

The fitproblem object lets you set up a parameter estimation problem and provides an alternative workflow to the existing sbiofit and sbiofitmixed functions. The object mitigates the complexity of various input arguments to these functions. It facilitates the reuse of the problem setup for various fitting workflows by letting you switch models, data, and optimization functions. Using the same object, you can perform either nonlinear regression or nonlinear mixed-effects (NLME) modeling.

### Create variants from grouped data

You can now create variants using data variables from a groupedData object. For details, see createVariants.

# Refer to reaction-scoped parameters by the corresponding reaction names

Behavior change

Since R2020b, the name of a reaction must not be empty, and you must specify a nonempty name. You must also refer to the reaction-scoped parameters using the reaction name. Previously, a reaction was automatically named as  $UnnamedReaction_N$  if the name was empty, and you were able to refer to a reaction-scoped parameter as  $UnnamedReaction_1.k1$ . You now must refer to such a parameter by prequalifying with the given reaction name such as TumorGrowthRxn.k1, where TumorGrowthRxn is the name of the reaction where the parameter k1 is scoped to.

#### **Fit plots from LeastSquaresResults and NLMEResults have updated appearances** *Behavior change*

The plots for fit results generated by the various plotting methods of the LeastSquaresResults object and NLMEResults object have been updated to look the same as the ones generated by the **SimBiology Model Analyzer** app. The plots now have updated line colors and legends. If there are multiple responses, each of them is now shown on a separate axes. The residual distribution plot

now has the corresponding histograms. For reference, this example shows the updated plots from the plotting methods of LeastSquaresResults.

#### plotData will show median response instead of mean response

Behavior change in future release

The plotData function of GSA result objects currently shows the mean model response by default. In a future release, it will show the median model response instead. Use the name-value arguments ShowMedian or ShowMean to plot either the mean or median response.

#### **More flexible dosing: Input dose matrix for fitting now has fewer constraints** *Behavior change*

The input dose matrix for the fitting functions (sbiofit, sbiofitmixed, predict and random methods of LeastSquaresResults and NLMEResults objects) is now more flexible. Doses in the columns are no longer required to have the same configuration. If you previously created default (dummy) doses to fill in the columns, these default doses have no effect and indicate no dosing. In addition to a dose matrix, you can now specify a cell vector of dose objects and apply different doses to different groups.

You can adjust the properties of blocks and lines shown in the diagram of the **SimBiology Model Builder** app programmatically. ### Integration-based profile likelihood confidence intervals

In addition to the existing optimization-based profile likelihood confidence interval method, sbioparameterci lets you compute the profile likelihood confidence intervals using a new, integration-based approach. This new approach is based on integrating differential equations derived from the Lagrange equations. To use the integration-based method, set 'Type' to 'profileLikelihood' and 'UseIntegration' to true.

### SimBiology Model Analyzer: Improved plotting performance

The **Model Analyzer** app now generates plots faster than before. The improved performance has been verified in various cases including:

- plotting time courses of numerous states from a single simulation
- plotting a single response from a scan over numerous parameter values

#### **SimBiology Model Analyzer: Automatic creation of datasheet after program run** *Behavior change*

After you run the **Fit Data** program or **Non-Compartmental Analysis** program, the app automatically creates and opens a datasheet with the results.

#### SimBiology Model Analyzer: Enable and disable program warnings

Behavior change

The app shows all enabled warnings in the **Messages** section of a program. To disable a warning, first right-click the warning and select **Copy Command to Turn Off Warning**. Then go back to the MATLAB command line and paste the command.

For example, the copied command could look like:

warning('off', 'SimBiology:DimAnalysisNotDone\_MatlabFcn\_Dimensionless')

To enable the same warning, enter the following.

When you specify four output arguments when calling sbioshowunits, the function no longer returns the offset information as the fourth output. The fourth output is now a logical vector that is true for each built-in unit.

Behavior change

If the SimBiology Model Builder or SimBiology Model Analyzer app is open, you cannot load a project or model from the command line using the simBiologyModelBuilder, simBiologyModelAnalyzer, or simbiology functions. Load the project or model from the app directly.

#### Changes to 'cubic' method of resample

Behavior change

The resample function of a SimData object provides different interpolation methods. 'cubic', one of these interpolation methods, now performs cubic convolution. Previously, 'cubic' was the same as 'pchip'. For details, see interp1 (MATLAB).

### sbiosobol and sbiompgsa: Perform global sensitivity analysis (GSA)

You can now perform global sensitivity analysis (GSA) on a SimBiology model to explore the effects of variations in model parameters, species, or compartments on the model response. GSA can help you detect which parameters are influential on the model output. Use the following functions to perform GSA.

- sbiosobol Compute the first and total order Sobol indices. The Sobol method is based on the decomposition of the variance of the model output with respect to contributions from varying model quantities. For more details about the function and results object, see sbiosobol and SimBiology.gsa.Sobol.
- sbiompgsa Perform multiparametric GSA for decision-making based on the sensitivity of a model response with respect to variations in model quantities. For more details about the function and results object, sbiompgsa and SimBiology.gsa.MPGSA.

### **Observables: Perform post-simulation calculations**

You can perform post-simulation calculations by defining and evaluating custom expressions—for instance, to calculate the fraction of ligand that is bound to a receptor at each time step. These expressions are called *observables*. You can add observable expressions to a SimBiology model or SimData object.

#### Add to model

When you add an observable expression to a model object using addobservable(model), the function returns a new object called Observable and adds the object to the model. The expression is evaluated after every model simulation and the results are stored in the returned SimData object. You can access the model observable property by typing m1.Observables at the command line, where m1 is a SimBiology model.

The new observable object has the following properties.

- Name Object name.
- Expression Observable expression.
- Active Flag indicating whether to evaluate the observable expression during model simulation. By default, this property is set to true.
- Units Observable unit.
- Notes Description of the object.
- Parent Parent object for the observable object.
- Tag Label to associate with the object.
- Type Object type.
- UserData Data associated with the object.

#### Add to SimData object

When you add an observable expression to a SimData object using addobservable(SimData), the function returns a new SimData object with the calculated values for the added observable expressions. You can also use the following functions when you work with observables: updateobservable and renameobservable.

The SimData object has the following new and updated properties to support observables. These updates also apply to the SimData object returned by sbiosimulate or SimFunction after you simulate a model that has observable expressions.

- Data The property contains the calculated values for observable expressions as columns in the data matrix. Scalar observables are repeated so that the same value appears in every row.
- DataCount The property includes observables in the count. This is equal to the number of columns in the Data property or the number of elements in the DataInfo property.
- DataInfo The property includes entries for observables. Each entry is a cell array containing a structure with these fields:
  - Scalar Flag to indicate if the observable expression is scalar-valued.
  - Expression Observable expression
  - Type 'observable'
  - Name Name of the observable expression
  - Units Observable expression unit
- DataNames The property includes the names of added observable expressions in the same order as the columns of the Data property.
- ScalarObservables This new property contains a table of all scalar-valued observables. The table variable names show the names of scalar observables in the same order as they appear in the Data property (and the DataNames property).
- VectorObservables This new property contains a table of all vector-valued observables. The table variable names show the names of vector observables in the same order as they appear in the Data property (and the DataNames property).

The following SimData object functions have also been updated to support the observable expression results.

- getdata The second output (x) contains the calculated results from observables. It is identical to SimData.Data.The third output (names) is identical to SimData.DataNames. If you specify the 'nummetadata' format, the output names is identical to SimData.DataInfo.
- **resample** The function interpolates the observable results in the same way as it interpolates other results.
- select The function supports selection by using the type observable.
- selectbyname The function supports selecting observables by name.

#### **Specify Observables as responses**

You can specify observables as responses (model outputs) when you simulate the model using a SimFunction object, fit the model using sbiofit or sbiofitmixed, or perform global sensitivity analysis using sbiosobol or sbiompgsa.

## Functionality being removed or changed

#### **Changes to support observable expressions in SimBiology Model Analyzer app** *Behavior change*

To allow adding, editing, and evaluating observable expressions, **SimBiology Model Analyzer** has been updated as follows.

#### **Changes to Postprocessing: Calculate Statistics Step**

- The step has been renamed **Postprocessing: Calculate Observables**.
- The **Observables** (previously known as **Statistics**) table has a new **Units** column. You can pick an existing observable from the model or add a new observable expression to the table. If you add a new observable expression to the table, the expression is also added to the model as a new observable object automatically.
- The name of an observable must be unique across the model, that is, the name must be different from other model component names. An observable name cannot be an empty text, null, time, or contain the characters ->, <->, [, or ].
- When **Unit Conversion** is on, any observable expression added to the step (or datasheet) must have units defined. Otherwise, the program throws an error and the results are returned as NaN values for the observables.
- The **Use** check box controls which observable expressions are evaluated when you run the program. The check box does not change the Active property of the observable object on the model.
- Deleting a row from the table (by either using the delete key or the context menu option) does not delete the corresponding observable object from the model. To delete an observable object from the model, right-click on the row and select **Delete Observable from Model**.
- The **Run this program step** button and the default plot generation button have been removed from the **Postprocessing: Calculate Observables** step. To evaluate the observable expressions, run the whole program or run the simulation step of the program. Use the plot generation button of the simulation step to plot the observable results by default or not.

#### **Changes to Calculate Statistics Program**

- The program has been renamed **Calculate Observables**. This program lets you evaluate a series of observable expressions on an existing simulation data and plot the results.
- The program returns results in a SimData (simulation data) format instead of a table format.

#### **Changes to Datasheet**

- If you add an observable expression to a datasheet (containing simulation data **SimData**) from the **LastRun** folder, the expression is added to the model as an observable object automatically. Similarly, if you make changes to expressions of existing observables in a datasheet in **LastRun**, the changes are saved on the corresponding observable objects in the model automatically.
- If you add an observable expression to a datasheet in a *saved* folder instead of the **LastRun** folder, the expression is added to the corresponding simulation data SimData object, but not to the model.
- When a scalar observable object (shown as 1x1 in the **Size** column in the **Browser**) is dragged onto a datasheet with other vector-valued observables, time, or state columns, the scalar observable column is filled with the same value across all the rows (scalar expanded).

#### **Changes to Observables Folder in Worskspace**

- In the Workspace of the Browser, the Observables folder is now removed.
- The vector-valued observables are listed together with other SimData states under **results**. However, the scalar-valued observables are saved under **results** > **scalars**.

#### **Changes When Loading Previous Projects**

- **R2019a** or earlier projects Any existing expressions from the **Calculate Statistics** section of a task are added as observable objects to the model. If the expression names have conflicts, they are renamed by appending \_*N*, where *N* is a positive integer.
- **R2019b** projects Any existing expressions from the **Postprocessing: Calculate Statistics** step of a program and any expression in the SimData datasheets from the **LastRun** folder are added as observable objects to the model. Any results from **LastRun** or saved folders of the **Postprocessing: Calculate Statistics** program are converted from the table format to the SimData (simulation data) format.

#### **Changes to Plotting**

- You can drag the vector-valued observables onto a **time** plot to see their time courses. You can drag a scalar-valued observable to a time plot to see a constant (or threshold) line across the plot.
- Dragging the **scalars** folder onto a **Plot Matrix** plot creates a plot of the scalar observables versus sample values (or just the distribution of the scalar observables if there are no samples in the program).
- The **Calculate Observables** step in a program generates a plot matrix plot only if there are scalar observables.

To build or edit models, use the **SimBiology** app. Type **simbiology** at the command line or click **SimBiology** on the **Apps** tab.

The **SimBiology Model Analyzer** app replaces the **Task Editor** of the **SimBiology** app. For more information, see "SimBiology app no longer supports the Task Editor" on page 8-3.

### Simulate and fit a SimBiology model inside a parfor loop

You can now simulate and fit a SimBiology model inside a parfor loop. You no longer need to call parallel.pool.Constant prior to the parfor loop. See the following code example.

### Use rename with any SimBiology model component

You can now use the rename function with any SimBiology model component. The model components are Species, Parameter, Compartment, AbstractKineticLaw, KineticLaw, RepeatDose, ScheduleDose, Variant, Event, Reaction, and Rule.

## Functionality being removed or changed

#### SimBiology app no longer supports the Task Editor

Behavior change

The **SimBiology** app no longer supports the **Task Editor**. Use the **SimBiology Model Analyzer** app instead.

If you load a project created in R2019a or earlier using the **SimBiology Model Analyzer** or **SimBiology** app, the project is updated to support the new features. The changes follow.

- **SimBiology Model Analyzer** provides built-in analyses called programs. Programs let you chain together a sequence of analysis steps and run each step separately or in a sequence. Programs replace tasks.
- If you load a project created previously, the existing tasks are converted to equivalent programs. However, **SimBiology Model Analyzer** does not support the following tasks: Calculate conserved cycles, Search model(s), and Generate report.
- The Create custom analysis task has been renamed Custom Code.
- Any group simulation task is converted to a scan program.
- The taskInfo structure for a custom analysis task is not loaded when converted to a custom program.
- The **Fit Data** program does not support nlinfit. If Optimization Toolbox<sup>™</sup> is available, the program uses lsqnonlin. If not, the program uses the fminsearch function. Note that the command line function sbiofit still supports nlinfit as one of the estimation methods.
- The Sum, Fit Summary, and Sensitivity Matrix Subplot Max plots are not supported. Custom plots are also not supported.

- The Sensitivity Matrix Subplot plot generated by the Run scan with sensitivities task is not supported.
- SimBiology Model Analyzer does not support the Live Plots functionality of the Task Editor. However, if Live Plots in the Task Editor is turned on and Live Plots shows a time plot of simulation results, then an equivalent time plot is added on import to the SimBiology Model Analyzer app. The time plot is updated and displayed after the program finishes (not while it is running). If there are multiple axes within Live Plots, the app generates one time plot per axes.

If **Live Plots** shows a *time* plot from a math expression (also known as a math line or math data), the math data is added as variables in the *observables* table in the *results* folder of the corresponding program. You can drag and drop the variables to a new plot to visualize the data.

If **Live Plots** shows a *scan* plot containing custom expressions, neither the data nor the plot is imported. You can add the **Postprocessing: Calculate Statistics** step to your program to enter the custom expressions and view them using a new **Plot Matrix** plot.

- The app does not allow schedule doses added to the **Explorer** section to have dose sliders. You can add repeat doses and adjust them using sliders.
- If you save a project at the command line (using sbiosaveproject) and open the project in the app, only models in the project are loaded. No data is loaded.
- When you open an existing project created in R2019a or earlier, the app creates a backup of the original file. The backup file has the release information suffixed to its name, filename\_release.sbproj, where release is the MATLAB release you used to create the project. For example, if you open an R2019a project named foo.sbproj in the app, the app creates a backup file called foo\_R2019a.sbproj.
  - If foo\_R2019a.sbproj already exists, the app appends the release information again and saves the backup as foo\_R2019a\_R2019a.sbproj.
  - If foo\_R2019a\_R2019a.sbproj already exists, the app appends \_N to the file name, where N is a positive integer and increases monotonically as needed.

When you save a project, the app creates a backup file of the version prior to the saved version of the project. The backup file has the .bak extension (for example, foo.sbproj.bak). Every time you save the project, the BAK file is overwritten.

#### **Object properties are column vectors**

Behavior change

All SimBiology object properties are standardized to column vectors when possible. For example, the ScheduleDose object properties Amount, Rate, and Time are column vectors instead of row vectors.

#### getstoichmatrix and getadjacencymatrix returns species in a new order

Behavior change

The order of species in the output arguments (M and objSpecies) of getstoichmatrix matches the order of species returned by modelObj.Species.

Similarly, the order of species in the output arguments (M and Headings) of getadjacencymatrix matches the order of species returned by modelObj.Species.

**Many functions now return the input object as an output** *Behavior change*  The following functions now return the input object as an output.

- setTable

#### **Reactions are named automatically**

Behavior change

If you create a new reaction at the command line and do not specify its name, the reaction gets an automatic name Reaction\_N, where N is a positive integer. N increases monotonically as you add more reactions without specifying their names.

If you copy a reaction using copyobj, the name of the copied reaction is generated by appending \_N, where N is the smallest integer not in use by that prefix. For example, GivenName\_1 gets copied to GivenName\_1\_1.

# Parameterized Dosing: Specify dosing properties using model parameters for applications such as scaling dosing by body weight

You can specify the following RepeatDose object properties using model parameters: Amount, Rate, Interval, StartTime, and RepeatCount. Parameterized doses give you more flexibility to model different dosing scenarios such as scaling the dose amount by body weight. For details, see Parameterized and Adaptive Doses.

# **Compatibility Considerations**

If a parameter is referenced by the LagParameterName and DurationParameterName property of a RepeatDose object, the parameter must be constant to be an input for sensitivity analysis.

If a parameter is referenced by any other RepeatDose object properties, namely, Amount, Rate, Interval, StartTime, and RepeatCount, you cannot use the parameter as an input for sensitivity analysis.

# Adaptive Dosing: Change the behavior of the dose during a simulation in response to the values of model states or parameters

You can change the dosing behavior during a simulation in response to events, such as increasing the dose amount when the drug concentration drops below some threshold.

Some doses are not modeled as instantaneous changes. For example, an IV infusion involves drug being added at a fixed rate over a fixed duration. There are two options to define what happens if an event modifies a dose parameter while a dose is in progress. The first option lets you stop the active dose event if any relevant parameter values change (by setting the EventMode property of the dose object to 'stop'). The second option lets you continue the active dose event to completion, and updated parameter values only affect subsequent dose events (by setting EventMode to 'continue'). # Noncompartmental Analysis: Calculate NCA parameters from grouped data for mixed dosing schedules and mixed routes of administration

You can calculate NCA parameters from the concentration-time data that have both single dosing schedules (one dose per individual) and multiple dosing schedules (multiple doses per individual). Three types of drug administration routes are supported: IV bolus, IV infusion, and EV (extravascular) infusion.

From the command line, use sbionca to calculate NCA parameters. From the SimBiology desktop, select **Open > NCA** on the **Define Plot** tab after you import the data.

# **Compatibility Considerations**

In the SimBiology desktop, all relevant NCA parameters are computed and reported. You can no longer select the parameters to compute.

# Confidence Intervals: Calculate parameter and prediction confidence intervals using Gaussian, profile likelihood, and bootstrap approximation

You can calculate confidence intervals for parameters and model predictions estimated by sbiofit. For the confidence intervals of estimated parameters, use sbioparameterci. For the confidence intervals of estimated model predictions (that is, simulation results based on estimated parameters), use sbiopredictionci. Three different approximations for the confidence intervals are supported: Gaussian, profile likelihood, and bootstrap. Use the plot function of the corresponding confidence interval object to visualize the computed confidence intervals. Get a table of parameter confidence intervals by using the ci2table function.

# Steady State Calculations: Compute model steady states using an algebraic method

Use an algebraic method to compute steady states of a SimBiology model directly from its reactions, rate rules, and algebraic equations. When you run sbiosteadystate, use the name-value pair 'Method' to specify the 'Algebraic' or 'Simulation' approach. The simulation approach simulates the model to find steady states. The algebraic approach attempts to find steady states by root finding, solving systems of linear equations, or using optimization.

# **Compatibility Considerations**

The function now uses 'Algebraic' as the default method first. If unsuccessful, it then uses 'Simulation'. The steady state returned by the algebraic method is not guaranteed to be the same as the one found by the simulation method.

# **Diagram View: Annotate models using text blocks**

You can drag and drop text blocks on to the model diagram to annotate the model.
## Assignment Expressions: Enforce both initial and repeat assignment expressions at simulation start time

SimBiology reorders and evaluates all rules (including initial assignments) as a set of simultaneous constraints. Therefore, you cannot create a circular set of assignments, such as a = b + 1 and b = a + 1. The order in which the rules appear in the model has no effect on the simulation results.

#### **Compatibility Considerations**

- You might observe different simulation results with respect to initial assignments for previous releases of SimBiology (R2017a or earlier). To recover the same simulation results at time = 0, as in R2017a or earlier, use the updateInitialAssignments function in the command line. If you are using the SimBiology desktop, right-click the model from the **Project Workspace** and select **Remove Order Dependencies**. For details see Evaluation Order of Rules.
- In previous releases (R2017a or earlier), if a repeated assignment changed a compartment volume, SimBiology used the compartment capacity to determine the initial amount and conserved it when the compartment volume changed at time = 0. In R2017b or later, SimBiology uses the InitialAmount property of the species as the initial condition at time = 0. For details, see Conservation of Amounts During Simulation.
- **sbmlimport** adds an initial assignment rule when importing SBML models with the following conditions.
  - If an SBML model has a species *s* initialized to *X* using initialAmount and has the attribute setting hasOnlySubstanceUnits = false:
    - SimBiology sets the initial amount of *s* to *X*.
    - If the model does not already have an initial assignment or repeated assignment rule for s, SimBiology adds an initial assignment rule s = X / V, where V is the compartment volume (capacity). This rule ensures that the initial amount of s is a concentration unit.
    - If the model already has an initial assignment or repeated assignment rule for s, then SimBiology does not use the value X. Instead, SimBiology evaluates the rule and sets the appropriate initial amount.
  - If an SBML model has a species *s* initialized to *X* using initialConcentration and has the attribute setting hasOnlySubstanceUnits = true:
    - SimBiology sets the initial amount of *s* to *X*.
    - If the model does not already have an initial assignment or repeated assignment rule for s, SimBiology adds an initial assignment rule s = X \* V, where V is the compartment volume (capacity). This rule ensures that the initial amount of s is an amount unit.
    - If the model already has an initial assignment or repeated assignment rule for *s*, then SimBiology does not use the value *X*. Instead, SimBiology evaluates the rule and sets the appropriate initial amount.
- If a species *s* in an SBML model has the attribute setting hasOnlySubstanceUnits = true without any units defined, SimBiology issues a warning and sets the species amount unit to a default unit (mole) to ensure it is interpreted as an amount, not a concentration. The imported SimBiology model has the DimensionalAnalysis property set to false to prevent dimensional analysis errors.

### Parameter Estimation: Estimate parameters using scatter search global optimization

SimBiology provides a global optimization algorithm called scattersearch to overcome some of the challenges of parameter estimation problems in dynamic models such as convergence to local minima. Specify the estimation function name as 'scattersearch' when you call sbiofit.

### SimFunction with Variants: Specify parameters for simulation using variants

You can now use variants as inputs when creating or simulating a SimFunction object. Pass in a variant or vector of variants as the last input argument when you call createSimFunction, and the variant values are then applied to the model as baseline values. Similarly, when you execute a SimFunction object, you can pass in a matrix or cell array of variant objects, and these variant values are used as initial conditions during simulation.

#### SBML Support: Load SBML models with function definitions, and models that use reaction IDs to reference reaction rates in mathematical expressions

SimBiology lets you load SBML models with function definitions. You can also load SBML models that use reaction IDs to reference reaction rates in mathematical expressions such as assignment rules. For details, see SBML Support.

### Performance: Provide faster compilation of SimBiology models and faster simulation of models with large numbers of dosing events

SimBiology takes less time to accelerate models with large numbers of rules or reactions using sbioaccelerate or the accelerate method of a SimFunction object or an exported model (SimBiology.export.Model). The simulation of models with large numbers of dosing events has been improved, and it now takes less time to simulate them.

# Diagram View: Navigate between clone blocks, change reactions graphically, and generate variants from estimation and simulation results

In the diagram view of the SimBiology desktop, you can navigate between clone blocks by using the new keyboard shortcuts N or P keys. You can also update reactions interactively by dragging and dropping existing reaction lines to another species.

You can generate variants directly from the **Simulation** task or **Fit Data** task after it finishes running. The **Variants to Generate** section of the task provides options to generate variants with the final simulated or estimated value of each quantity.

### Noncompartmental Analysis: Handle sparse sampling in addition to serial sampling

The SimBiology desktop lets you perform noncompartmental analysis (NCA) on the measured timeconcentration profile data to calculate NCA parameters such as AUC, terminal half-life, and clearance. In cases where longitudinal data on a single subject is not available, the desktop now supports sparse sampling where data collected from multiple subjects are pooled to obtain NCA parameter values. To view NCA parameters, select **Open > NCA** on the **Define Plot** tab after you import the data.

# Diagram View: Configure block properties in place with graphical context menus

You can configure block properties using graphical context menus in the diagram view of the SimBiology desktop. Select a block in the diagram, and then hover over the graphical icons for the context menu options.



## Diagram View: Access model information directly from the graphical view

You can get more information about a model and its components directly from the diagram view. For instance, the diagram shows usages of a quantity by connecting lines from the quantity block to all the expressions that use it. Select **Show Expression Lines** from the context menu of a quantity block. Similarly for the expression blocks, the diagram shows the relationships between quantities and expressions graphically. For example, you can select **Show Expression and Lines** from the graphical context menu of an expression block to see which quantities are being used in the expression. In addition, you can remove unused quantities from the model by selecting **Remove Unused** from the **Model** tab.

## Model Usages: Determine model component usage from the command line using findUnusedComponents and findUsages functions

Use the findUnusedComponents method of a SimBiology model to find unused species, parameters, and compartments of the model. Use the findUsages method of a quantity to look for model components that are using the quantity.

## **Progress Plot for Fitting: Visualize parameter estimation progress in real time for both desktop and cluster simulations**

You can view the progress of parameter estimation while running the Fit task in the SimBiology desktop or using sbiofit in the command line. For the desktop, the plots are on by default. For the command line, set the 'ProgressPlot' option of sbiofit to true when you run the function. The plots also keep track of the progress when you perform estimation in parallel using remote clusters. The plots show the log-likelihood, termination criteria, estimated parameters for each iteration, and first-order optimality measure for applicable optimization function.

#### Model Selection Information: Report parameter estimation quality measures (log-likelihood, AIC, BIC) consistently across all estimation algorithms, allowing direct comparisons between model parameterizations

You can compare different models and select the best fit using the model information criteria such as log-likelihood, Akaike Information Criterion (AIC), and Bayesian Information Criterion (BIC). These values are stored in the LeastSquaresResults object and NLMEResults object returned by sbiofit and sbiofitmixed, respectively. This example compares estimation results from different error models. If you are using the desktop, open the **Task Data Comparison** tool to compare these values.

# Steady States: Compute model steady states using the sbiosteadystate function, for example to equilibrate a model prior to dosing

You can compute the steady states of a model by using the sbiosteadystate function.

## SBML Support: Load and save the most recent SBML file format (level 3 version 1)

SimBiology now supports the most recent specification of SBML (level 3 version 1).

#### Model Examples: Open SimBiology model examples hosted on the MATLAB Central File Exchange from within the SimBiology desktop

To open the hosted SimBiology example projects from within the desktop, select **Content > Recent Files**. The projects are listed under the **Example Projects on MATLAB Central File Exchange** section.

#### Application builder for model distribution and simulation

You can create standalone applications for model distribution and simulation from the SimBiology desktop. The application can be an executable that runs outside of MATLAB or a MATLAB app. To deploy a standalone application, you need MATLAB Compiler™.

To build an executable for model simulation, first add a simulation task and open it. Then in the **Task Editor**, on the **Editor** tab, select **Create App > Deploy**. For a MATLAB app, select **Create App > Package as MATLAB App**.

You can include model exploration tools in the application, such as sliders to adjust quantity values and dose schedules, as well as calculated statistics. To test the user interface and see the final deployed application or MATLAB app, select **Create App > Launch**.

#### **Equations view of models**

You can view the differential equations and other expressions of a model in the SimBiology desktop. On the **Model** tab, select **Open > Equations**.

#### Viewing and editing reaction rates in the diagram view

You can view and edit the reaction rate of a reaction in the **Diagram** view of a model. To see the reaction rate, press **Alt** + Click (or **Cmd** + Click for a Macintosh) on a reaction block. You can edit the reaction rate and kinetic law in the expressions view of the **Browser**. To open this view, select **View** > **By Expressions** on the **Model** tab.

#### **Bioavailability example**

This new example shows how to calculate the bioavailability of the drug Ondansetron. For details, see Estimating the Bioavailability of a Drug.

#### International character support

SimBiology supports non-English characters according to the locale settings of a target machine. For example, a user can enter species names using Japanese characters on a Japanese locale machine without corrupting or losing character data.

### DPI-aware SimBiology desktop graphics for Apple Retina displays and high-resolution displays on Windows

The SimBiology desktop looks sharp and properly scaled on all Windows<sup>®</sup> and Macintosh systems. These improvements are noticeable on the following high-DPI (dots-per-inch) systems:

- Macintosh systems with Apple Retina displays.
- Windows systems in which the DPI (dots-per-inch) value is higher than 96.

#### Automatic selection of amount and mass units for simulation

SimBiology automatically selects an amount or mass unit that is used internally during simulation when UnitConversion is on. This automatic selection is enabled by setting AmountUnits and

MassUnits property of an active configset object to a string '<automatic>', which is the default.

It is recommended that you use the default unit (<automatic>) or choose units for states such that the simulated values are neither too large (greater than 10<sup>6</sup>) or too small (less than 10<sup>-6</sup>).

If you need to recover the simulation behavior from releases prior to R2015b:

- Set the AmountUnits to mole. However, if the model has quantity units in molecule, set the unit to molecule instead.
- Set the MassUnits to kilogram.

#### Graphical representation of all modeling constructs

The SimBiology desktop includes the **Browser**, a table-like display of model quantities and expressions, to supplement the **Diagram** view of a model. The **Browser** lets you access every quantity and expression of the model and edit them easily.

The block library now has parameter, initial assignment, repeated assignment, rate rule, algebraic rule, event, repeat dose, schedule dose, and variant blocks.

### High-accuracy parameter sensitivities enabling more robust parameter optimization

sbiofit uses high accuracy sensitivities based on complex step differentiation to generate gradients
of objective functions. High accuracy gradients improve parameter estimation with lsqnonlin,
lsqcurvefit, fmincon, and fminunc.

#### **Response-specific error models**

You can specify a separate error model for each response in your model while fitting using sbiofit (except for with the nlinfit estimation method). For instance, if you have two responses in your model and would like to specify an exponential error model for the first response and a proportional model for the second, use:

fitResults = sbiofit(...,'ErrorModel',{'exponential','proportional'};

#### Sensitivity analysis using the SimFunction object

The SimFunction object lets you compute sensitivities. Specify the name-value pair arguments 'SensitivityInputs' and 'SensitivityOutputs' when you run createSimFunction to create the object. Then execute the function object to compute sensitivities.

#### Group simulation task enhancements

#### Estimation of category-specific parameters using the sbiofit function

You can estimate parameters specific to subpopulations which are defined by categories such as sex, age, or height. You can also simultaneously estimate population-wide parameters and individual-specific parameters.

The CategoryVariableName property of an estimatedInfo object defines the category of a parameter. The default category name is '<GroupVariableName>' which means the parameter has a group-specific estimate for each group defined in the data. If CategoryVariableName is set to '<none>', then the parameter has a population-wide estimate meaning all groups in the data use the same parameter estimate. The property can also be set to the name of a variable in your data that you intend to categorize by. For example, to estimate sex-specific values of parameter k1 use:

```
estimatedParam = estimatedInfo('k1','CategoryVariableName','Sex');
results = sbiofit(model,data,...,estimatedParam);
```

where Sex is the name of the variable in data that categorizes individuals by sex.

#### Parameter bounds in the sbiofit function

You can specify lower and upper bounds for estimated parameters during fitting using sbiofit. Set the Bounds property of an estimatedInfo object to define the bound constraints. For example, to estimate a parameter k1 with bound constraints:

```
estimatedParam = estimatedInfo('k1','Bounds',[1 3]);
results = sbiofit(model,data,...,estimatedParam);
```

### Desktop enhancements for model and task viewing, exploration, and editing

The SimBiology desktop includes the following enhancements:

- You can open different model pages such as model quantities, expressions, and modifiers at the same time. Each page opens as a new tab.
- A **View** tab allows tiling for better visualization and comparison of different tasks and model pages.
- The **Task Editor** opens in a new window allowing you to view different model pages and task pages at the same time.
- Each task page has three sections, namely **Task**, **Explorer Tools**, and **Live Plots**. The **Task** section describes the details of the task, the **Explorer Tools** section allows you to explore the model's quantities or doses without changing the model, and the **Live Plots** section shows simulation results.
- You can customize generated plots after each task runs as well as **Live Plots**. For example, you can change *x* and *y*-axes to log scale. To change to log scale on a generated plot, go to the **Plots**

to Generate section of a task, and click and click under axesStyle. To customize Live Plots, go to the context menu and select Properties > Axes Properties > Log scale for each axis.

- You can scan repeat dose amounts, rates, intervals, and number of doses.
- You can get additional details and tips about the model, tasks, and Explorer Tools using contextsensitive help. To view the content of context-sensitive help, hover your mouse over the information bubble ④.

#### sbiofit and sbiofitmixed functions for parameter estimation

SimBiology provides two additional functions for parameter estimation:

- sbiofit for estimating model parameters using nonlinear regression. sbiofit can be used with optimization methods from MATLAB, Optimization Toolbox, Global Optimization Toolbox, or Statistics Toolbox. It can be used in place of sbioparamestim and sbionlinfit to estimate grouped data or pooled data. sbiofit allows you to fit all groups using the same parameters (set 'Pooled' option to true) or fit each group separately using group-specific parameters (set 'Pooled' option to false).
- sbiofitmixed for estimating model parameters using nonlinear mixed-effects estimation. sbiofitmixed can be used in place of sbionlmefit and sbionlmefitsa, and requires Statistics Toolbox. sbiofitmixed supports covariate models.

Both functions support parameter transformations and specification of group-specific dosing. In addition, results objects returned by these functions provide additional plots such as the boxplot of parameter estimates for each parameter, plots of observations vs. predictions, and residual distributions.

#### Enhanced command-line calling of models for parameter scanning

The SimBiology model object now has a method called createSimFunction that creates a SimFunction object. In addition, SimBiology introduces two functions sbiosampleparameters and sbiosampleerror. Together, these enhancements provide:

- An interface for parameter scans from the command line
- A way to sample parameters based on the statistical model and then simulate the model for each parameter sample
- An interface similar to a function handle that can be used with other toolboxes including Curve Fitting Toolbox<sup>™</sup> and Control System Toolbox<sup>™</sup>
- Parallel execution if Parallel Computing Toolbox is available

#### Name-value pair argument for sbionmimport

sbionmimport has an additional name-value pair argument called 'OutputFormat' that controls
the output types from the function. The values are 'dataset' (default) and 'groupedData'.

# Fit Data Tool and Simulation Viewer to interactively visualize and explore data and models

The SimBiology desktop has a new tool and Simulation Viewer enhancements to improve interactions with data and models:

- **Fit Data Tool** New tool to explore imported data against multiple models, fit models to data, and compare fit results of multiple models. You can select this tool from the DEFINE PLOT or EXPLORE DATA tabs, which are available after importing external data.
- **Simulation Viewer Enhancements** Controls for this viewer are now available on a SIMULATION VIEWER tab in the desktop. You can use the controls on this tab to interact with the Simulation Viewer, including viewing sensitivities, adding and removing plots, and removing selected plot lines. Two new plots are available in the Simulation Viewer:
  - **Sensitivity Matrix Plot** Displays the results of a Sensitivity Analysis task by plotting the sensitivity matrix using the time integral for the sensitivities for the inputs and outputs.
  - **Scan Plot** Displays the results of a Scan task by plotting the result of a user-specified expression or sensitivity for each simulation run in the scan.

# Noncompartmental analysis for characterizing pharmacokinetic data

When importing data using the SimBiology desktop, the desktop now calculates and displays noncompartmental analysis (NCA) parameters in an **NCA** tab, assuming your data includes columns labeled independent variable, dependent variable, and dose. In addition to NCA parameters, statistics that were formerly on the **Statistics** tab (except for mean) now appear on the **NCA** tab.

NCA parameters include AUC, MRT, terminal half life, and clearance, and are useful to obtain initial estimates for parameters used in a **Fit parameters** task. For a full list of NCA parameters that SimBiology calculates, import data, right-click the table in the **NCA** tab, and then select **NCA Parameters to Calculate**.

# **Deployment of SimBiology models using MATLAB Compiler**

You can now export SimBiology models and deploy the exported model using MATLAB Compiler. To export a model, use the new export method.

For an example of using an exported model with MATLAB Compiler, see Deploy a SimBiology Model.

## SimBiology desktop enhancements

The SimBiology desktop includes the following enhancements:

- **Example Projects** The desktop Quick Start page now links to projects that are included with the software.
- **EXPLORE DATA tab** When viewing data in the desktop, options previously available on the EXCLUSION and ADD DATA tabs have been combined and included in the EXPLORE DATA tab.
- **Drag and Drop** The desktop has additional drag-and-drop functionality:
  - When editing a task, such as fitting or calculating sensitivities, you can drag compartments, species, parameters, and variants from a table in the MODEL tab to a task window.
  - When using the Simulation Viewer, you can drag compartments, species, parameters, and variants from a table in the MODEL tab to a plot in the Simulation Viewer.

# Import SBML from URL

## Scaled absolute tolerances

For SimBiology models containing species with varying scales or units, you can now improve simulation performance and convergence by enabling absolute tolerance scaling. When enabled, SimBiology scales the absolute error tolerances individually for state values during a simulation. Use either:

- Command line Use the new AbsoluteToleranceScaling property, and, if necessary, the AbsoluteToleranceStepSize property of the SolverOptions property of a Configset object.
- SimBiology desktop Use the **AbsoluteToleranceScaling** check box, and optionally, the **AbsoluteToleranceStepSize** text box in the Simulation Settings dialog box.

# **Compatibility Considerations**

If you load a model created in SimBiology R2012a or earlier, be aware that:

- The configuration settings now include the AbsoluteToleranceScaling property, which is enabled by default.
- For models generated using a PKModelDesign object or the PK Wizard, the default value for the AbsoluteTolerance property is now 1e-6, instead of 1e-15, and the AbsoluteToleranceScaling property is enabled.

#### **Enhancements to sensitivity analysis**

Performance is improved for model simulation using sbiosimulate and model acceleration using sbioaccelerate.

For sensitivity analysis, sbiosimulate ignores deterministic SolverType and always uses sundials.

## Log compartment data during simulations

# **Celsius and Fahrenheit Units Being Removed**

Celsius, celsius, and fahrenheit units will be removed from the built-in units library in a future release. Use kelvin units instead.

# **Compatibility Considerations**

If you have a model containing Celsius, celsius, or fahrenheit units, change the units to kelvin.

If you have a script that sets the ValueUnits property of a parameter to 'Celsius', 'celsius', or 'fahrenheit', set this property to 'kelvin' and adjust the Value property accordingly.

# **Enhanced Solver Support**

The default for the SolverType property has changed from sundials to ode15s. Possible values for the SolverType property have changed and are limited to:

- ode15s
- ode23t
- ode45
- sundials
- ssa
- expltau
- impltau

As a result of the above changes, when simulating models containing events or doses, you are no longer limited to using the SUNDIALS solver:

- When simulating models containing events, you can specify any deterministic (ODE or SUNDIALS) solver or the stochastic ssa solver for the SolverType property of the Configset object.
- When simulating models containing doses, you can specify any deterministic (ODE or SUNDIALS) solver for the SolverType property of the Configset object.

As a result of the above changes, when performing a parameter estimation or data fitting, you are no longer limited to using the SUNDIALS solver. You can specify any deterministic (ODE or SUNDIALS) solver for the SolverType property of the active Configset object.

# **Compatibility Considerations**

The following solvers are no longer valid:

If you load a model whose Configset object specifies one of the above solvers for the SolverType property, SimBiology changes the SolverType property to ode15s (default solver).

## **Enhanced Simulation Data Logging Support**

OutputTimes is a new property of the SolverOptions property of a Configset object. It lets you specify the times during a deterministic (ODE) simulation to log data.

## **Changes to Simulation Stop Criteria**

The StopTimeType property of a Configset object will be removed in a future release. It is being replaced by the StopTime property, which now always specifies simulation time, and two new properties: MaximumNumberOfLogs and MaximumWallClock. A simulation stops when it meets any of the criteria set by StopTime, MaximumNumberOfLogs, or MaximumWallClock.

Additionally, OutputTimes is a new property of the SolverOptions property of a Configset object. If you set the OutputTimes property, its values override the StopTime and MaximumNumberOfLogs criteria.

## Changes to the AbsoluteTolerance Property

The AbsoluteTolerance property of the SolverOptions property of a Configset object has changed. It no longer has an upper limit of 1.

## **Parameter Estimation and Fitting Enhancements**

There are improvements to the parameter estimation and fitting features in SimBiology. As a result:

- Some defaults for the *method* input for the sbioparamestim function have changed. Specifically, when using lsqcurvefit, lsqnonlin, or fmincon for the *method*, the default for the TypicalX field is 1e-6\*(initial values of components to be estimated).

# Weighted Least-Squares Fitting

When performing nonlinear least-squares regression, you can now fit data with nonconstant residual variance by specifying an error model or weights. You can do this by using either the:

- Command line Use sbionlinfit with either the ErrorModel or Weights name-value pair argument, or specify a value for the ErrorModel or Weights field in the optionStruct input argument.
- SimBiology desktop Add an individual fit task and use the **Response and Error Model Information** or **Residual Weights** settings.

## Simultaneously Fit Data from Multiple Dose Groups

You can now use either nonlinear least-squares regression or nonlinear mixed-effects modeling techniques to estimate a single set of parameters for a data set where only the dosing varies across individuals.

To simultaneously fit data from multiple dose groups using nonlinear regression, use either the:

- Command line Use sbionlinfit and set the Pooled field or name-value pair input argument to true.
- SimBiology desktop Add an **individual fit** task and select **Pool Data** in the **Algorithm Settings** section.

To simultaneously fit data from multiple dose groups using nonlinear mixed-effects, use either the:

- Command line Do either:
  - Use sbionlmefit with a CovariateModel object input argument and omit the random effect (eta) from the expressions in the CovariateModel object.
  - Use sbionlmefit with an InitEstimates input argument and set the REParamsSelect field or name-value pair input argument to a 1-by-*n* logical vector, with all entries set to false, where *n* equals the number of fixed effects.
- SimBiology desktop Add a **population fit** task and omit the random effect (eta) from the expressions in the **Estimated Parameters** section.

# **Dosing Enhancements**

Multiple dose objects in a model can now target the same species.

## **Covariate Class, Properties, and Methods**

The CovariateModel class and related properties and methods replace the PKCovariateModel class and related properties and methods, to perform covariate analysis for continuous covariates. The CovariateModel class lets you specify initial estimates as parameters in the covariate expression, instead of embedding them in the covariate expression. For details, see Specifying a Covariate Model and the demo, Modeling the Population Pharmacokinetics of Phenobarbital in Neonates.

The construct method of the PKModelDesign class returns a CovariateModel object with default expression information.

The PKData class includes a method, getCovariateData, which returns only the covariate data from a data set.

## **Compatibility Considerations**

The PKCovariateModel class and its related properties and methods now error. Use the CovariateModel class and related properties and methods instead.

## **Population Fitting Better Supports Covariate Analysis**

The sbionlmefit and sbionlmefitsa functions accept the CovariateModel object.

The sbionlmefit and sbionlmefitsa functions return results that are better annotated. The results output structure includes fields with more descriptive names. For details on the new fields, see the sbionlmefit and sbionlmefitsa reference pages.

- There is a new property, CovarianceMatrix, which contains the estimated covariance matrix for the fitted coefficients.

# **Changes to Sensitivity Analysis**

You can use parameters as outputs when performing sensitivity analysis.

## **Compatibility Considerations**

The ParameterInputFactors and SpeciesInputFactors properties of the SensitivityAnalysisOptions property of the Configset object error. Instead, use the new Inputs property.

Also, the SpeciesOutput property of the SensitivityAnalysisOptions property of the Configset object error. Instead, use the new Outputs property.

# SimData Object Stores Simulation Data

The SimBiology SimData object stores the data returned from any simulation.

# **Compatibility Considerations**

The SimData object is the container for simulation and analysis task data. Previously, simulation and analysis data were stored as time series objects. Functions that used to return time series objects now return SimData objects. Functions that used to take a time series object as an input argument now take a SimData object.

Support for time series objects in SimBiology functions has been removed. Although you can load a project containing a time series object, you can no longer use a time series object as an input argument. You must resimulate to create a SimData object.

The sbiogetsensmatrix and sbiogetnamedstate functions are now replaced by the SimData object methods getsensmatrix and selectbyname respectively.

The sbioupdate function is now removed.

# Submodel Support Removed

Support for submodels has been removed.

# **Compatibility Considerations**

While you can still load a project or model containing submodels, only the top-level model opens. You must manually add the submodel to the top-level model using compartments.

As a result of removing submodels, the following functionality is no longer relevant and has been removed:

The SimBiology desktop is redesigned to better support streamlined, iterative workflows. It no longer includes a Project Explorer to navigate between models, tasks, and data. Now, use the following management and navigation aids for projects and libraries:

- **Toolstrip** Displays the **HOME** tab and other tabs depending on what you select in the address bar.
- **HOME tab** Open and manage projects, including adding models, analysis tasks, and data to a project.
- Address bar Select a project, model, task, or data to view and edit in the desktop window. Navigate between models, tasks, and data. Select and view libraries.
- Actions button 🕑 Use to select actions appropriate for the item (project, model, task, data, or library) selected and displayed in the desktop.

**Tip** Selecting Project in the address bar displays all models, tasks, and data included in the project.

The MODEL, TASK, and DATA tabs better support the following iterative workflows:

- **Model-centric workflow** Refine a model by performing iterative edits on the model. Without leaving the model, run multiple tasks and view results to help guide you with your model edits.
- **Task-centric workflow** Refine an analysis task by performing iterative runs and edits on the task. Without leaving the task, select different models to run the task on. For example, select different models for a parameter fit task to find the model that best fits the data.
- Data-centric workflow Plot and explore data, all from the DATA tabs.

# New Feature to Import, Visualize, and Statistically Analyze Clinical and Experimental Data

You can import tabular data into the SimBiology desktop or the MATLAB Workspace. The supported file types are .xls, .csv, and .txt.

At the command line, you can process and visualize the data using command-line functions. In the SimBiology desktop, you can filter the raw data to suppress outliers, visualize data using MATLAB plots, and calculate statistics to analyze the data. You can further choose to plot the imported data with any analysis task.

# Support for Specifying Additional Inputs in Custom Plot Types

You can now specify additional inputs for plot types and define their types, default values, and ranges where applicable. For example, you can use this feature to extend the Time plot with an additional input to specify markers.

# **Compatibility Considerations**

This consideration applies when you previously created custom plot types. Before, you could define the number of species or parameters that could be specified for x or y arguments. This functionality has been removed. You should modify your plot code to enforce this constraint. For an example of enforcing the constraint, see the code for the built-in plot type XY.

To access this code:

- 1 In the SimBiology desktop, select **Desktop** > **Library Explorer**. The **Library Explorer** opens.
- 2 Select Plot Types.
- **3** In the plot types table, select XY. The code section updates to show XY plot type code.

### Edit Graphical Models Using the New Block Property Editor

The **Block Property Editor** is a tool that facilitates model building using the **Diagram View** pane by docking next to the diagram and allowing you to change properties of the selected block in the diagram. If you select multiple blocks, you can edit the properties that are common between each block. To open the **Block Property Editor**, select a block in the **Diagram View** pane, and then select **Diagram > Tools > Block Property Editor**.

## Manage and Share Libraries Using the New Library Explorer

The **Library Explorer** adds the ability to add, modify, and share the contents of kinetic law, plot type, unit, unit prefix, and block libraries. To open the **Library Explorer**, in the SimBiology desktop, select **Desktop** > **Show Library Explorer**.



The **Library Explorer** shows all built-in and user-defined components, namely kinetic laws, units, unit prefixes, plot types, and blocks.

- **Kinetic Laws** Contains kinetic laws that you can use as templates while creating a reaction rate expression.
- **Units** Contains units that you can specify for compartment capacity, species amounts and parameter values, to do dimensional analysis and unit conversion during simulation.

- **Unit Prefixes** Contains all unit prefixes that you can specify in combination with a valid unit for compartment capacity, species amounts and parameter values, to do dimensional analysis and unit conversion during simulation.
- **Plot Types** Contains different types of plots that you can use with **Model Tasks** to visualize your results.
- Blocks Contains blocks that you can use in the Diagram View.

For help, open the **Library Explorer** and select **Help > SimBiology Desktop Help** to see the context-sensitive help. Select a library in the **Library Explorer** to view information specific to the library.

# Additional Options for Renaming Compartments, Species, and Parameters

### New Method for Renaming at the Command Line

The newly added **rename** method allows you to change the name of a compartment, species, or parameter, and update the name in expressions that refer to the component. Use the **rename** method instead of the **set** method to enable the name change and expression update.

### New Options for Renaming in the SimBiology Desktop

You can specify how compartments, species, and parameter names should be updated in expressions. When you rename a compartment, species, or parameter, by default the names are set to be updated in all expressions that refer to the component being renamed. During renaming, if the component is used in one or more expressions, you will see a dialog box that tells you which expressions will be updated. For example, the following dialog box appears when you try to rename species G to Gnew.

You can choose not to see this dialog box for every instance of renaming. You can also set your preferences on whether expressions should be updated. To select preferences for renaming:

- 1 Select **File > Preferences**. The Preferences dialog box opens.
- 2 Click **Rename** to view and select default renaming options.

You can also specify whether to update expressions while renaming a component in the **Compartment**, **Species**, or **Parameter** panes. Right-click (Windows or Linux<sup>®</sup>) or **Ctrl**+click (Macintosh) the species, parameters, or compartment table and select **Rename**. This allows you to select whether to use the new name in all expressions referring to the component.

# **Compatibility Considerations**

Previously, if you changed the name in a table or the diagram, expressions that used the components were not updated unless you selected **Rename in Expressions** from the context menu. Now the default is to change the name in expressions. But, you will see a dialog box that allows you to cancel the action if necessary, and you can specify the default as shown in "Additional Options for Renaming Compartments, Species, and Parameters" on page 30-5.

## Change in the Random Number Generator Used During Stochastic Simulations

The default random number generator used during stochastic simulation has changed. The stochastic solver now uses the random numbers from the MATLAB default stream. When you run a model using a stochastic solver, and have set the RandomState property in the configuration set, you may see different simulation results relative to previous releases because the random numbers used may be different.

For more information about the change to the random number generator, see Upgrade to Random Number Generator in the MATLAB release notes.

# **Compatibility Considerations**

If you never set the RandomState property, there should be no compatibility considerations. If however, you have previously set RandomState for your model and want to reproduce your previous results, type rand('state',0); at the command line before running the simulation. This sets the random number generator to the one used in previous releases.

### Submodel Support Will Be Removed

Support for submodels will be removed in a future release. You can still open models containing submodels and create submodels, but you cannot simulate or perform any analysis tasks on the model. Therefore, you should transition to using compartments where applicable.

# **Compatibility Considerations**

If you have submodels in your previously created model, you can still open your model, but you must convert the submodels into top-level SimBiology models to be able to perform any tasks.

To convert submodels, use sbioupdate.

If you open a model that contains submodels in the SimBiology desktop, the submodels are automatically converted to models and placed in separate model sessions. See **sbioupdate** for more information.

As a result of removing submodels, the addmodel method and Models property of the model object are no longer relevant. You can still access the addmodel method and the Models property for this version of the software, though it may be removed in a future release.

### **Events**

You can now add events to SimBiology models. Use events to describe sudden changes in a model system. Events are supported only by the sundials solver and the stochastic solver ssa.

Select **Help** > **SimBiology Desktop Help** to see the context-sensitive help for information on how to generate reports.

### Changes to the Library Structure in the Root

Built-in and user-defined libraries for units, unit prefixes, and abstract kinetic laws are now organized under two root object properties, BuiltInLibrary and UserDefinedLibrary, with subcategories for units, unit prefixes, and abstract kinetic laws. See Root object, BuiltInLibrary, and UserDefinedLibrary in SimBiology Reference for more information.

### **Compatibility Considerations**

In previous versions, the libraries were organized under six properties:

- UserDefinedKineticLaws
- BuiltInKineticLaws
- UserDefinedUnits

- BuiltInUnits
- UserDefinedUnitPrefixes
- BuiltInUnitPrefixes

The changes to the library structure improve the organization of root object properties.

To illustrate the change using an example, previously you would access a user-defined kinetic law using the following syntax:

```
rootObj = sbioroot;
get(rootObj, 'UserDefinedKineticLaws')
```

You must now use the following syntax:

```
rootObj = sbioroot;
get(rootObj.UserDefinedLibrary, 'KineticLaws')
```

#### Support for Sundials Solvers

The Sundials package of solvers has been added in this release. The Sundials solvers are part of a freely available third-party package developed at Lawrence Livermore National Laboratory. Models that contain events are supported by the Sundials solvers and by the stochastic solver ssa. For more information, see Sundials Solvers in the SimBiology User's Guide.

#### New Property in Configuration Sets to Specify Species Dimensions

The new property DefaultSpeciesDimension lets you specify whether the default species dimensions should be concentration (default) or substance. This property thus lets you specify whether the solver should account for compartment capacity. If however, you specify the species units in the InitialAmountUnits property, these units define the species dimension regardless of the value in DefaultSpeciesDimension.

#### SimData Object Holds All Simulation Data

The SimBiology SimData object now stores the data returned from any simulation. For example, the output from the sbiosimulate function is now stored in a SimData object which holds time and state data as well as metadata, such as the types and names for the logged states or the configuration set used during simulation.

You can also store data from multiple simulation runs as an array of SimData objects. Thus, the output of sbioensemblerun is an array of SimData objects. See SimData object for more information and a list of methods and properties.

# **Compatibility Considerations**

The SimData object is now the preferred container for simulation and analysis task data. Previously, simulation and analysis data were stored as time series objects. Functions that used to return time series objects now return SimData objects. If you have time series objects in your projects, you can convert them using sbioupdate. Functions that used to take a time series object as an input argument now take SimData object. You can use time series objects in an input argument, but you see a warning. Support for time series objects in SimBiology functions may be removed in a future version.

The sbiogetsensmatrix and sbiogetnamedstate functions are being replaced by the SimData object methods getsensmatrix and selectbyname respectively.

# **New Plot Functions**

There are two new plot functions — sbioplot and sbiosubplot. Both functions let you plot data directly from the SimData object (see "SimData Object Holds All Simulation Data" on page 32-6).

sbioplot plots each simulation run for a SimData object or array of SimData objects from a model in the same figure. The plot is a time plot of each state in the object. The figure also shows a hierarchical display of all the runs in a tree, where you can choose which trajectories to show.

sbiosubplot plots each simulation run for a SimData object or array of objects into its own subplot. The subplot is a time plot of each state in the object. You can navigate through the plots in the figure window and select a subset of the plots to view.

# New Sensitivity Analysis Property for Species Outputs

To set up sensitivity analysis, you must now specify an additional property called SpeciesOutputs. In SpeciesOutputs, specify the species for which you want to compute sensitivities.

# **Compatibility Considerations**

Previously, sensitivity analysis used the species specified in StatesToLog as the species for which sensitivities should be calculated. SpeciesOutputs improves the functionality by separating the use of the properties.

If you have models from a previous version configured for sensitivity analysis, you must specify species for which you want to compute sensitivities in the SpeciesOutputs property. Until this property is specified, sensitivity analysis gives a warning that the SpeciesOutputs property is not set, and continues to use the species specified in StatesToLog. The use of StatesToLog in this context may not be available in a future version, so you should set the SpeciesOutputs property for your models, if applicable.

# New Way to Add Units and Unit Prefixes

Units and unit prefixes are now represented by objects. You can create units and prefixes and add them to the user-defined library using the function sbioaddtolibrary. See Unit object and UnitPrefix object for more information.

# **Compatibility Considerations**

Previously, sbioregisterunit and sbiounregisterunit created and removed units respectively. These functions now produce warnings and will be removed in a future version. Use unit objects and sbioremovefromlibrary instead.

Similarly, sbioregisterunitprefix and sbiounregisterunitprefix created and removed unit prefixes respectively. These functions now produce warnings and will be removed in a future version. Use unit prefix objects and sbioremovefromlibrary instead.

## Printing and Exporting the Diagram

You can annotate and print your pathway's block diagram in SimBiology, or export the diagram using .svg, .jpeg, or .pdf file formats. For example, you can annotate the diagram with the name of the author, the date, notes, and name of the organization. You can choose to place this content as a header or footer on the diagram page.

## **Diagram Menu**

The SimBiology desktop supports multiple diagram features and actions through the **Diagram** menu. Use the menu options to do the following:

- Copy, paste, and delete blocks.
- Select model or diagram components by category (for example, select all lines or all Species blocks).
- Filter selected portions of a model diagram to include only model or diagram components by category.
- Edit multiple blocks or lines.
- Add selected blocks to a Block Library.
- Annotate and print, or export your model diagram.
- Perform layout tasks, for example, hide and show blocks, move blocks to the front or back of a diagram, rotate a block, and pin or unpin selected blocks.
- Copy the style of a block and apply the style to a group of selected blocks.
- Reload a graphic used for a block in the Block Properties dialog box.
- Access diagram tools such as the Diagram Table View, Block Library Browser, Diagram Overview, and Block Overview.

### **Compatibility Considerations**

There is a compatibility consideration regarding the support for editing multiple blocks or lines. In SimBiology Versions 2.0 and 2.0.1, if you selected multiple blocks and/or lines and applied an editing action such as **Hide**, **Pin**, or **Hide Name**, the action applied only to the block on which you selected the right-click (context) menu. Starting in Version 2.1, applicable editing actions are propagated to all selected blocks.

### **Block Overview Tool**

The Block Overview tool provides a summary of key information about a particular block. Hover the mouse over a block to find information in the **Block Overview** pane. Each block includes information pertinent to that type of block, for example, a species block overview shows **Name**, **InitialAmount**, **InitialAmountUnits**, the number and list of reactions the species is involved in, and a description of any indicators shown in the diagram.

### **Miscellaneous Desktop Enhancements**

The enhancements for the SimBiology desktop let you do the following:

- Set your preference to open a SimBiology pane with a single-click in the **Project Explorer**. Select **File > Preferences** to open the Preferences dialog box.
- Interrupt and stop model verification by clicking **Stop** when **Verify** is running.
- Sort the available plot arguments in the **Simulation** and **Data** panes. The X and Y argument lists are now tabulated.
- View a species and any of its cloned blocks from the search results for the species.
- Select and view multiple results for **Find** and **Bookmarks** in either the diagram or the table form.

## **Diagram Interface**

The Diagram is a graphical user interface you can use to enter model pathways using block representations for species, reactions, and submodels. Use the Plot block to visualize simulation data during a simulation. For a tutorial, see Modeling Using the SimBiology Diagram in the SimBiology Getting Started Guide. You can also access video demos from a list of SimBiology demos.

## Find and Bookmarks in Projects

- **Find** Type a string in the **Find** box to quickly find matching model components in the project and in abstract kinetic laws.
- **Bookmarks** Use complex rules to identify objects from the project, and create a custom and persistent set of desktop and project objects.

## **Compatibility Considerations**

In Versions 1.0 and 1.0.1, SimBiology projects saved searches. In Version 2.0, the project saves bookmarks. The software converts a previous version's saved search into a bookmark. After you save a project in Version 2.0, a bookmark is saved and the old search is no longer available. If a project contains a search, you see a warning that the project file will contain a bookmark rather than a search after saving.

All functionality available in Version 1.0 searches are present in Version 2.0 bookmarks except for the ability to mix and match and or between the search rows. If you have a multiple-row search saved with a mixture of and and or, when you load this project into Version 2.0, it is converted to either all or any based on whether the software first encounters and or or.

# **Sensitivity Analysis**

You can perform sensitivity analysis using the following properties:

- SensitivityAnalysis Configuration set property that lets you calculate the time-dependent sensitivities of all the species states defined by the StatesToLog property with respect to species initial conditions and parameter values.
- SensitivityAnalysisOptions An object that holds the sensitivity analysis options in the configuration set object. Properties of SensitivityAnalysisOptions are summarized below:
  - SpeciesInputFactors Specify the species with respect to which you want to compute the sensitivities of the species states in your model.
  - **ParameterInputFactors** Specify the parameters with respect to which you want to compute the sensitivities of the species states in your model.
  - Normalization Specify the normalization for the calculated sensitivities.

For an introduction and an example, see Calculating Sensitivities in the SimBiology User's Guide.

### **Parameter Estimation**

The sbioparamestim function lets you estimate any or all parameters in your model using the experimental data you provide. The software uses the optimization functions in the MATLAB, Optimization Toolbox, and Global Optimization Toolbox software to enable parameter estimation.

Optimization Toolbox and Global Optimization Toolbox software are not required for you to use sbioparamestim. If you do not have these products installed, sbioparamestim uses the MATLAB function fminsearch by default.

# **Ensemble Simulation Runs**

You can perform ensemble simulations using the stochastic solvers to gather data from multiple stochastic runs of the model. The following functions let you perform ensemble runs:

- **sbioensemblerun** Performs multiple stochastic ensemble runs of the SimBiology model object.
- sbioensembleplot Shows a 2-D distribution plot or a 3-D shaded plot of the time varying distribution of one or more specified species in the ensemble data generated by sbioensemblerun.
- **sbioensemblestats** Gets mean and variance as a function of time for all the species in the ensemble data generated by **sbioensemblerun**.

# **Moiety Conservation**

The **sbioconsmoiety** function lets you calculate a complete set of linear conservation relations for the species in a SimBiology model object.

For an introduction and an example, see Moiety Conservation in the SimBiology User's Guide.

# Model Verification and Validation

SimBiology software performs model verification and validation either during simulation, or when you explicitly execute the commands for verification before simulation.

#### Verification at the Command Line

The following new functions let you verify and validate, at the command line, that your model is ready for simulation:

- verify Performs checks on a model to verify that you can simulate the model. You see stacked errors and warnings if any problems are found. To see the entire list of errors and warnings, use sbiolasterror and sbiolastwarning.
- **sbiolasterror** Returns a SimBiology diagnostic structure array containing the last errors that are generated.
- **sbiolastwarning** Returns a SimBiology diagnostic structure array containing the last warnings that are generated.

#### Verification on the SimBiology Desktop

Click the **Verify** button on the SimBiology desktop toolbar to perform verification and validation of your model. The **Output** pane opens to show the errors and warnings. You can double-click a result row to go to the location of the error or warning.

# Simulation and Solvers

The following new features and changes apply to simulation settings and solvers:

- MaxStep Lets you specify the upper bound on solver step size for a deterministic solver. MaxStep is a property of the SolverOptions object.
- Implicit Tau solver settings For impltau, AbsoluteTolerance holds the value for convergence tolerance for the nonlinear solver that is used internally by the Implicit Tau solver. You can now specify AbsoluteTolerance for impltau. Previously, if you selected the Implicit Tau solver, the software ignored any changes to the AbsoluteTolerance and RelativeTolerance options within a configuration set and used the default values set internally.
- UnitConversion Supported by both deterministic solvers and stochastic solvers. Previously UnitConversion was supported only by the stochastic solvers.

#### Implicit Tau Solver Settings Compatibility Considerations

The RelativeTolerance property is no longer valid for the Implicit Tau (impltau) solver.

When you load a file created in a previous version, the project loads the RelativeTolerance property. But when you save the file, the software updates the change.

#### **Unit Conversion Compatibility Considerations**

The UnitConversion property default is now 'false'. If you load a SimBiology project created in a previous version into the SimBiology desktop, the UnitConversion setting in each model in the project remains as the saved setting. If however, you are running a script, you must now remember to set the UnitConversion property to true if you want the software to perform unit conversions

# Introduction

SimBiology Version 1.0 (Release 14SP3+) is an integrated environment for modeling biological processes, simulating the dynamic behavior of these processes, and analyzing simulation and experimental data. Biological processes include metabolic, genetic, and signaling pathways with transform, binding, and transport reactions. You can use SimBiology software as a tool in three major areas:

- **Model** Design and build models by entering model components with a graphical desktop interface, or use the MATLAB Command Window.
- **Simulate** Select deterministic or stochastic solvers and observe the changes in species amounts and variable parameter values over time.
- **Analyze** Log data from a simulation and export the data to the MATLAB workspace. Compare simulation with experimental data for parameter estimation and model validation.

## Features

The features in SimBiology Version 1.0 are the following:

- **Graphical user interface** Provides access to the command-line functionality through a graphical user interface (GUI).
- **Command-line interface** All the features are accessible and executable from the MATLAB Command Window.
- **Data formats and projects** Organize and save related models, simulation data, and analysis results in project files. Save user-defined kinetic laws and units. Share models by exporting SBML Level 2 files.
- **Modeling** Create biological models by adding components that include reactions, species, parameters, kinetic laws, rules, and submodels.
- **Simulation** Select either deterministic or stochastic solvers with dimensional analysis and unit conversion.
- **Analysis** SimBiology software is fully integrated with MATLAB. Record data during a simulation and analyze results in MATLAB.

# **Known Software Problems**

To view important open bugs for SimBiology Version 1.0, use the Bug Reports interface on the MathWorks Web site.

**Note** If you are not already logged in to your MathWorks Account, when you link to the Bug Reports interface (see below), you will be prompted to log in or create an account.

After you are logged in, use this Bug Reports link. You will see the bug report for SimBiology. The report is sorted with fixed bugs listed first, and then open bugs. You can select the Status column to list the open bugs first.

If you are viewing these release notes in PDF form on the MathWorks Web site, you can refer to the HTML form of the release notes on the MathWorks Web site and use the link provided.

Software problems include unsupported SBML features and current feature and function limitations.

#### **Unsupported SBML Level 2 Version 1 Features**

SimBiology software supports a subset of the SBML Level 2 Version 1 specification. Unsupported features include:

- Compartments Model compartments are not supported. If an imported SBML model has a single compartment, the model is loaded as a top-level model. If the model has multiple compartments, you see a warning and the software does not load the SBML file.
- Volume Volume is not supported and cannot be specified.
- Events Events in an SBML file are ignored when you are importing into a project.
- Piecewise kinetics Models with piecewise kinetics are loaded in, but the software ignores the definitions for piecewise kinetics.
- Function definitions Models containing functional definitions are loaded, but you see a warning and the software ignores the function definitions.
- MATLAB incompatible variable names in UnitDefinition Models that have variable names incompatible with MATLAB in UnitDefinition are not loaded and you see an error message.

#### **Functional Limitations**

#### **Simulation and Solvers**

- Stochastic solvers support only mass action kinetics, while ODE solvers support all built-in and user-defined kinetic laws.
- If you use a stochastic solver to simulate a model, the software ignores any rate, assignment, or algebraic rules if present in the model.
- If you have DimensionalAnalysis and UnitConversion on for the stochastic solvers, note that the software assumes that volume is unity during simulation. The stochastic solvers perform calculations using species units in molecules. Therefore, if you specify the species units in molecules per unit volume or moles per unit volume, the software assumes volume to be unity and converts species amounts to molecules for simulation. The results are finally plotted in the units you specified for the species.

In addition, if you have reactions with stoichiometric coefficients greater than or equal to 2, you need to convert the deterministic rate constants to stochastic rate constants. For example, 2 R - > P has a reaction rate of v=k[R]^2. If R is moles/liter, the deterministic rate constant k has units of liter/mole-second. If the unit of species concentration is molecule, then the stochastic rate constant c has units of 1/molecule-second, and c = 2k/NV where N is Avogadro's Number, 6.022e23 molecules/mole, and V is the volume of the model in liters.

- When you select the Implicit Tau solver, the software ignores any changes to AbsoluteTolerance and RelativeTolerance options within a configuration set and uses the default values that are set internally.
- By default, StatesToLog is set to 'all' and all variable parameters are logged. Variable parameters are those that have ConstantValue cleared or false. If you choose the species to log, however, you cannot log the variable parameters.
- The characters \, ^, and \* in species and parameter names are not supported in rules.

#### Units

• Stochastic solvers support dimensional analysis and unit conversion. ODE solvers support dimensional analysis but not unit conversion.

• You can delete a unit that is being used in a model; however, you will see an error when you try to simulate the model or export to SBML.

#### Submodels

- The context menus (right-click options) for the **Species**, **Reaction**, **Parameter** and **Rule** nodes that appear beneath a submodel node all act on the corresponding parent model node, and not on the submodel node. For example, if you select **Delete All Species** in the submodel **Species** node, this selection deletes the species in the parent model.
- Rules are not supported in submodels.

#### **SBML Export Limitations**

There are features in SimBiology software that are not supported in SBML. When you export a model to an SBML file, you might lose some of these features.

- Submodels are not supported by SBML export.
- The abstract kinetic law name and corresponding expression are not supported by SBML, but the associated reaction rate equation is exported to SBML.
- The properties Tag, UserData, and Active are not supported by SBML export.

#### Tips

#### Naming SimBiology Variables

- If you are using a species or parameter name that is not a valid MATLAB variable name, do the following:
  - Enclose the name in square brackets when writing a reaction rate equation or a rule.
  - Enter the name without brackets when you are creating the species or parameter, or when you add a reaction.

For example, enclose [DNA polymerase+] and [K\_DNA polymerase+] within brackets in reaction rates and rules, but, enter DNA polymerase+ or K\_DNA polymerase+ when creating a species, adding a reaction, or creating a parameter.

The names i and j are reserved MATLAB characters. Because expressions in abstract kinetic laws, reaction rates, and rules are considered to be MATLAB code, the software evaluates i or j as an imaginary number and not as the value of species i or j. For example, an expression V\*S\*i/K is interpreted to have three names, V, S, and K, instead of four. Use brackets to protect such variables.

If a variable in a reaction rate equation or rule has the same name as a MATLAB function, the software evaluates the expression as a call to the MATLAB function. In general, when creating variable names, you should avoid using MATLAB function names or variable names that are invalid in MATLAB.

#### **Changing SimBiology Variable Names**

• If you change the Name of a parameter you must configure all applicable elements, such as rules that use the parameter, any user-specified ReactionRate, or the kinetic law object property ParameterVariableNames. Use the method setparameter to configure ParameterVariableNames.

To update parameter names in the SimBiology graphical user interface, access each appropriate pane through the **Project Explorer**.

• If you change the Name of a species you must configure all applicable elements, such as rules that use the parameter, any user-specified ReactionRate, or the kinetic law object property SpeciesVariableNames. Use the method setspecies to configure SpeciesVariableNames.

To update species names in the SimBiology graphical user interface, access each appropriate pane through the **Project Explorer**. The software automatically updates species names for reactions that use MassAction kinetic law.

## Upgrading from a Beta Release

Any projects that you created and saved with the SimBiology beta release version will not load in Version 1.0.

As a workaround, before upgrading to Version 1.0, save your models to SBML, upgrade to Version 1.0, and then import the SBML models into Version 1.0 projects. Alternatively, contact MathWorks for help with your conversion.
