Do Not Use Database Tools to Modify Oracle Applications Data

Oracle STRONGLY RECOMMENDS that you never use SQL*Plus, Oracle Data Browser, database triggers, or any other tool to modify Oracle Applications data unless otherwise instructed.

Oracle provides powerful tools you can use to create, store, change, retrieve, and maintain information in an Oracle database. But if you use Oracle tools such as SQL*Plus to modify Oracle Applications data, you risk destroying the integrity of your data and you lose the ability to audit changes to your data.

Because Oracle Applications tables are interrelated, any change you make using an Oracle Applications form can update many tables at once. But when you modify Oracle Applications data using anything other than Oracle Applications forms, you might change a row in one table without making corresponding changes in related tables. If your tables get out of synchronization with each other, you risk retrieving erroneous information and you risk unpredictable results throughout Oracle Applications.

When you use Oracle Applications forms to modify your data, Oracle Applications automatically checks that your changes are valid. Oracle Applications also keeps track of who changes information. But, if you enter information into database tables using database tools, you may store invalid information. You also lose the ability to track who has changed your information because SQL*Plus and other database tools do not keep a record of changes.

1 Setup

This chapter explains how to set up Oracle Financials for Greece.

Setting Up Oracle Financials for Greece

To set up Oracle Financials for Greece, follow these setup steps as well as related setup steps documented in the Oracle Financials Common Country Features User *Guide.* When necessary, these sections refer you to related setup sections in the Oracle Financials Common Country Features User Guide.

Oracle Financials for Greece includes these responsibilities:

- Greek General Ledger
- Greek Payables
- Greek Receivables
- Greek Fixed Assets

These responsibilities contain all the menus, programs, and profile options that you need to use Oracle Financials for Greece.

1. Define Parent Account Structure

Greek law currently requires that you use a statutory account class hierarchy for your chart of accounts. This hierarchy is called a *parent account structure*. Companies must report on both summarized account balances and account activity for one or more account class levels in the parent account structure.

Greek law requires that at a minimum the first two account levels of the account class hierarchy are parent, or *precision*, levels with a fixed digit width. The first level has a fixed width of two digits. The second level has a fixed width of four digits: the first two digits of the second level replicate the first parent level values. A parent defined at the third level has a fixed width of six digits: the first four digits replicate the second parent level values plus two additional digits.

Every child value in the chart of accounts must have a parent to appear in a summarized report. This parent must also have a parent, and so on, up to the highest parent level. The highest parent level must have a two-digit width.

The first (highest) level in the parent account structure is called a *class*; the second level is called a *sub-class*; the third level is called a *group*.

This table is an example of an account structure with child at the third level:

Value	Parent	Level	Regulated	Precision
60	Yes	First	Yes	Class
6000	Yes	Second	Yes	Sub-class
6000234	No	Third	No	Group

This table is an example of an account structure with parent at the third level:

Value	Parent	Level	Regulated	Precision
62	Yes	First	Yes	Class
6200	Yes	Second	Yes	Sub-class
620002	Yes	Third	No	Group
620202234	No	Fourth	No	No

Using the Parent Account Structure for Statutory Reporting

You must have a fixed parent account structure over the precision levels that are used for summarized reporting to fulfill statutory reporting requirements. Statutory reporting's summarized precision feature lets you report on accounts at the first, second, and third levels.

To provide a summarized report with the three levels, however, you cannot mix parent and child values at the third level in your chart of accounts because summarized statutory reporting cannot distinguish child values at the third level from parent values also defined at the third level.

You should set up a three-level parent account structure to make full use of the summarized statutory reporting functionality.


2. Define a Set of Books

Use the globalization flexfield in the Set of Books window to enter default cutoff rule and accounting sequence number information for your set of books.

For cutoff rules, indicate the default number of cutoff days to apply to General Ledger transactions and Global Accounting Engine events. Oracle General Ledger uses the default value that you enter during the posting process whenever a document category does not have a cutoff rule.

For accounting sequence numbering, indicate when to apply accounting sequences to AX journals, using the Assign Accounting Sequence to GL Journals from AX? field. If you are using a single journal book, enter *No* in this field. If you are using multiple journal books, enter *Yes* in this field. See Step 3. Set Up Accounting Sequence Numbering on page 1-7 for more information about setting up accounting sequences for single and multi-journal books.

You can also specify whether to prefix the Reference field at the journal header level with the accounting sequence number and name. With this prefix you can run queries at the journal header level using accounting sequences. See Viewing the Accounting Sequence Number on page 3-10 for more information about viewing the accounting sequence number.



To define a set of books for Greek accounting:

- Navigate to the Set of Books window.
- 2. Query or enter a set of books.
- Navigate to the globalization flexfield. For instructions, see Using Globalization Flexfields on page B-1.
- In the Default Cutoff Days field, enter the required number of cutoff days for Greece.
- In the Assign Accounting Sequence to GL Journals from AX? field, enter Yes if you are using multiple journal books, and No if you are using a single journal book.
 - See Step 3. Set Up Accounting Sequence Numbering on page 1-7 for more information.
- In the Prefix External Reference with Accounting Sequence? field, enter Yes to use the accounting sequence number and name as a prefix for the Reference field at the journal header level.
- Save your work.

3. Set Up Accounting Sequence Numbering

To set up an accounting sequence, define a matching document category under the European Localizations application for each required journal category and assign accounting sequences to each document category.

The allocation of sequence numbers to transactions differs slightly depending on whether your company uses a single journal book or multiple journal books.

You can create separate journal books for adjusting periods and for analytical accounting. See Step 6. Set Up Journal Allocation on page 1-17 for more information about analytical accounting journals.

Single Journal Book

If your company uses a single journal book, Oracle Financials for Greece uses one accounting sequence to assign accounting sequence numbers to all original transactions including AX transactions, General Ledger manual source transactions, and imported transactions to General Ledger from feeder systems.

Transactions recorded in adjusting General Ledger periods, however, are an exception to one accounting sequence used for a single journal book. Adjusting General Ledger periods use a separate accounting sequence and are reported in a separate journal book, even under a single journal book setup.

If you are using a single journal book, enter *No* in the Assign Accounting Sequence to GL Journals from AX? field in the globalization flexfield in the Set of Books window.

Analytical (allocated) accounting transactions are always recorded in normal periods. You can incorporate allocated accounting transactions in the single journal book, or you can create a separate journal book for allocated accounting. If you create a separate journal book, assign a separate accounting sequence to allocated accounting transactions.

Multiple Journal Books

If your company uses multiple journal books, Oracle Financials for Greece reports all original transactions in separate journal books and uses a different accounting sequence for each book.

Assign all General Ledger categories including custom categories implemented for feeder systems and AX Payables and AX Receivables transfer categories to a dedicated General Ledger sequence. For subledger journal books, define a different

document category for AX events. Adjusting General Ledger periods use a separate accounting sequence and are reported in a separate journal book.

You can incorporate analytical (allocated) accounting transactions in the General Ledger journal book, or you can create a separate journal book for allocated accounting. If you create a separate journal book, assign a separate accounting sequence to allocated accounting transactions.

If you are using multiple journal books, enter Yes in the Assign Accounting Sequence to GL Journals from AX? field in the globalization flexfield in the Set of Books window.

Only a system administrator or other authorized user should perform and maintain setup procedures.

The setup procedures for accounting sequence numbering are:

- **Define journal categories** Define journal categories and, if applicable, assign journal categories to Global Accounting Engine event types
- **Define document categories** Define a European Localizations document category for each journal category
- **Define accounting sequences** Define an accounting sequence for each journal
- Assign accounting sequences Assign accounting sequences to document categories

Defining Journal Categories

Use the Journal Categories window to define the journal categories used for your journal books.

If you are using a single journal book, define a journal category to assign to Global Accounting Engine event types for both Payables and Receivables.

Note: You can define more than one journal category for a single journal book, but you must assign all journal categories to the same accounting sequence.

If you are using multiple journal books, define as many journal categories as you need. For the Global Accounting Engine, you must define at least one journal category each, for Payables and Receivables. The maximum number of journal categories that you can define for the Global Accounting Engine is equal to the maximum number of event types.

For the Global Accounting Engine setup, use the Event Categories window after you define your journal categories to assign these journal categories to Global Accounting Engine event types.

To define journal categories for accounting sequence numbering:

- 1. Navigate to the Journal Categories window.
- 2. Enter a category name in the Name field.
- **3.** Enter a description of the category in the Description field.
- **4.** In the Reversal Method field, enter *Switch Dr/Cr* or *Change Sign*, depending on your accounting requirement. The default is *Switch Dr/Cr*.
- **5.** Save your work.
 - If you are defining a Global Accounting Engine journal category, go to step 6. Otherwise go to step 8.
- **6.** Navigate to the Event Categories window.
- **7.** In the Category field, assign a journal category to each event type.
- **8.** Repeat steps 1 to 7 for each journal category that you want to define.
- **9.** Save your work.

Defining Document Categories

Use the Document Categories window to define a document category for each of your journal categories. For each journal category, you need to register a document category under the application heading European Localizations.

Oracle Financials automatically creates a document category for the General Ledger journal category. The Global Accounting Engine uses General Ledger document categories. For General Ledger journal categories that require an accounting sequence, you need to define a new document category.

After you define a document category for each journal category, define a document sequence for each journal book and assign the document categories to the relevant accounting sequences.

Note: Whenever you create a new journal category, you must assign an accounting sequence by creating a corresponding document category in European Localizations for the journal category, and assigning an accounting sequence.

To define document categories for accounting sequence numbering:

- Navigate to the Document Categories window.
- Under the General Ledger application name, query the journal categories that you created for your journal books.

You need to create a matching document category for each journal category.

Note: Oracle Applications automatically creates a document category for your journal categories under the Oracle General Ledger application name and assigns a code.

- In the Application field, enter *European Localizations*.
- In the Code field, enter the same code that Oracle Applications assigned to the General Ledger version of your document category.

5. In the Name and Description fields, enter a name and description for this document category.

Note: The document category name should match the journal category name.

- **6.** In the Table Name field, enter the name of the header sequence table that corresponds to Greece: *JE_GR_JE_HEADER_SEQUENCE*.
- **7.** Repeat steps 3 to 6 for each journal category.
- **8.** Save your work.

Defining Accounting Sequences

Use the Document Sequences window to define accounting sequences. For each journal book, you can either define an accounting sequence for each fiscal year and set of books combination or assign a document sequence to more than one fiscal year range.

If you choose to assign a new sequence to each fiscal year, the sequence should begin with 1, as indicated by the Greek Code of Books and Regulations.

To define a document sequence for accounting sequence numbering:

- Navigate to the Document Sequences window.
- In the Name field, enter a name for this document sequence.
- In the Application field, enter *European Localizations*.
- In the From and To fields, enter the effective dates. The effective dates should correspond to the fiscal year that this accounting sequence refers to.
- In the Type field, enter *Gapless*. The default is *Automatic*.
- In the Initial Value field, enter the first sequence number.

If you are assigning a new sequence to each fiscal year, you should start the sequence with 1.

- Save your work.
- Repeat steps 2 to 7 for each accounting sequence that you want to create.

Assigning Accounting Sequences

Use the Sequence Assignments window to assign the document categories that you created for European Localizations journals to the appropriate accounting sequences.

The Global Accounting Engine assigns a sequence number to each journal entry during the AX translation process. General Ledger assigns a sequence number to each journal entry during the posting process. The sequence assignment is based on the combination of document category, date range, and set of books.

To assign a document category to an accounting sequence:

- Navigate to the Sequence Assignments window.
- **2.** In the Application field, enter *European Localizations*.
- **3.** In the Category field, choose the first document category that you want to assign to an accounting sequence.
- **4.** In the Set of Books field, enter the set of books to use for this accounting sequence.
- **5.** In the Method field, enter *Manual* if the document category is for manual AX and General Ledger entries. Otherwise enter *Automatic*.
- **6.** Navigate to the Assignment tabbed region.
- **7.** In the Start Date and End Date fields, enter the effective dates for this sequence assignment.
- **8.** In the Sequence field, enter the accounting sequence to use for this assignment.

Note: The list of values associated with the Sequence field contains sequences from all Oracle applications.

- **9.** Repeat steps 2 to 8 for each document category.
- **10.** Save your work.

4. Define Accounting Cutoff Rules

Use the Define Cutoff Rules window to define accounting cutoff rules for your set of books and document categories. In Greece, the current accounting cutoff rules are:

- General Ledger, Payables, and Receivables transactions 15 days
- Inventory journal entries 10 days
- Adjustment journal entries 4 months
- Analytical accounting entries end of the following fiscal period. You should set this value to 15 days.

Oracle Financials for Greece verifies transactions when you validate and translate subledger entries in the Global Accounting Engine, and when you post entries to General Ledger. Journals that are not completed within the rule period generate an error message during processing.


If an error message appears when you approve an invoice, for example, check that the transaction General Ledger date is defined within the cutoff rule period. Change the General Ledger date to within the rule period to continue processing the transaction.

If the cutoff rule is violated when you translate events in the Global Accounting Engine, the events are not translated and the errors appear in the AX Event Translation report. General Ledger cannot import events that are not yet translated.

If the cutoff rule is violated when you post to General Ledger, the journal batches fail the posting process. The Journal Posting Execution Report lists the failed batches and journal headers. You must resubmit the journal batch after you correct the error.

If you do not define a cutoff rule for a document category, Oracle General Ledger takes the cutoff date from the value that you entered in the globalization flexfield in the Set of Books window. See Step 2. Define a Set of Books on page 1-5 for more information.

If you change any of the cutoff rule parameters, you must close Oracle Financials for Greece and reopen to activate the changes.



Note: Only a system administrator or other authorized user should perform and maintain this setup procedure.

To define accounting cutoff rules:

- 1. Navigate to the Define Cutoff Rules window.
- **2.** Check the Enabled check box to activate the cutoff rule.
- **3.** Enter the set of books name in the Set of Books field.
- **4.** Enter the document category that requires validation in the Document Category field.

The subledger application for your set of books and document category appears in the Application field.

- **5.** Enter the number of cutoff days for your cutoff rule in the Cutoff Days field.
- **6.** Enter the default *Error Fail* in the Violation Response field.

Error - Fail means that Oracle General Ledger displays an error message and prevents you from processing the transaction or batch until you change the General Ledger date of the entry that failed the cutoff rule.

7. Save your work.

5. Define Concurrent Programs for AX Journal Reports

Use the Define Concurrent Programs window to set program definitions for the Global Accounting Engine Daily Journal Book - Line Descriptions report and Daily Journal Book - Header Descriptions report.

You need to enter these settings:

- Set the Official Run parameter to displayed. Setting this parameter lets the Global Accounting Engine print an official run of the Daily Journal Book - Line Descriptions report and Daily Journal Book - Header Descriptions report for statutory reporting.
- Enter Yes in the Initialize YTD Amounts field. Entering this value lets the Global Accounting Engine print year-to-date balances from prior periods in the Daily Journal Book - Line Descriptions report and Daily Journal Book - Header Descriptions report.

Only a system administrator or other authorized user should perform and maintain this setup procedure.

To define concurrent programs for AX journal reports:

- Navigate to the Define Concurrent Programs window.
- Navigate to the Official Run parameter.
- **3.** Check the Display check box.
- Navigate to the Initialize YTD Amounts parameter.
- Enter Yes in the Default Value field.
- **6.** Save your work.

6. Set Up Journal Allocation

In Greece, companies must create an allocated accounting structure for all revenue and expense type accounts, as well as a subset of asset accounts. Allocated accounts are often referred to as *analytical accounts*. You designate the analytical accounting structure as a set of group 9 accounts. Entries posted to natural accounts that begin with values from the list below are reflected in parallel with appropriate entries in the analytical accounts.

This table shows the natural account values in Greece that require analytical accounting:

Group	Туре	Description
2	Asset	Stocks - Inventory
6	Expense	Expenses
7	Revenue	Revenues
8	Revenue/Expense	Result Accounts

Group 9 accounts are defined within the chart of accounts as asset accounts. Entries posted to these accounts do not affect the balance of the Retained Earning account.

You also need to define for your analytical accounts:

- Accounting sequence numbering Oracle General Ledger assigns an accounting sequence number to analytical accounting entries when entries are posted to General Ledger. See 3. Set Up Accounting Sequence Numbering on page 1-7 for more information.
- Accounting cutoff rules Allocated journals are subject to a period-end accounting cutoff rule. See 4. Define Accounting Cutoff Rules on page 1-14 for more information.

Note: If you create a separate journal book for analytical accounting journals, you must set up separate accounting sequence numbering from the General Ledger journal.

7. Enter Statutory Company Information

Use the globalization flexfield in the Location window to enter company statutory information. You can access the Location window from either Oracle Payables or Oracle Receivables.


In Greece, all statutory reports must contain this fiscal header information about a company:

- Company name
- Company address
- Tax office that the company submits its reports to
- Company VAT number
- Company tax region
- Company business activity
- Title of the report that the header is used for
- Optional title of the report that the header is used for

The company information that you enter appears in the header of all statutory reports submitted to the tax authority.

After you define location information for your company, use the Organization window to assign this location to the organization that you defined as your operating unit.

You also use the globalization flexfield in the Location window to enter your company's electronic file number. You must enter the electronic file number before you can submit the Greek Payables Supplier Turnover Report Set and the Greek Receivables Customer Report Set. For more information, see Greek Payables Supplier Turnover Listing and File Format on page 4-6 and Greek Receivables Customer Turnover Listing and File Format on page 5-3.



To enter statutory information for your company:

- Navigate to the Location window.
- **2.** Query or enter the location that you want.
- **3.** Navigate to the globalization flexfield. For instructions, see Using Globalization Flexfields on page B-1.
- **4.** In the Fiscal Company field, enter the name of your company.
- **5.** In the VAT Number field, enter your company's VAT number.
- **6.** In the Tax Office field, enter your company's tax office code.
- 7. In the Tax Area field, enter your company's tax region.
- **8.** In the Company Activity field, enter your company's business activity.
- **9.** In the Electronic File Number field, enter your company's electronic file number.
- **10.** Press the OK button.
- **11.** Save your work.
- 12. Navigate to the Organization window.
- **13.** Query the organization that you want.
- **14.** Choose the location that has the company information that you defined in steps 4 to 8.
- **15.** Save your work.

8. Implement the Global Accounting Engine (AX)

The Global Accounting Engine (AX) is required to implement Oracle Financials for Greece.

To set up the Global Accounting Engine, complete these tasks:

Set up your posting manager defaults.

Set the Line Type field in the Default Posting Options area in the Subledger Setup window to *Daily Summary*. This setting lets Oracle Financials for Greece comply with the Greek legal requirement to preserve the General Ledger date on transactions through AX Posting.

Compile the Global Accounting Engine program.

Before you compile the Global Accounting Engine program, assign the relevant journal categories to use for your AX journal books to your AX events. See Step 3. Set Up Accounting Sequence Numbering on page 1-7 for more information.

3. Set up your control accounts.

Oracle General Ledger

This chapter discusses Oracle General Ledger processing in Oracle Financials for Greece.

Journal Allocation

Run the journal allocation process for your analytical accounts at the end of each period after you post all period journals.

If you raise additional journal entries after you create the journal allocations for a given period, you can manually enter corresponding journal entries in the analytical accounts.

Analytical accounts are not subject to the standard 15-day cutoff rule and can remain open until the end of the following fiscal period, which is the end of the following month.

Accounting Cutoff Rules

The following cutoff rules apply to postings in Oracle General Ledger:

- Post General Ledger, Payables, Receivables, and Cash Management transactions within 15 days of their General Ledger date.
- Post inventory journal entries within 10 days of their General Ledger date.
- Post adjustment journal entries within four months of their General Ledger date. These recommendations apply to adjustment journal entries: the General Ledger date for the closing adjustment period is the last day of the current fiscal year; the General Ledger date for the opening adjustment period is the first day of the following fiscal year.
- Post analytical accounting entries by the end of the following fiscal period, preferably within 15 days.

Posting Entries

You must post all journals within the designated cutoff rule period. Oracle General Ledger invalidates journals that are not posted within the cutoff period, and the entire journal batch fails the posting process.

Oracle General Ledger automatically enforces the cutoff rules when you post a journal batch. Use the Journal Posting Execution report to review journal entries that failed due to cutoff rule violations.

To correct journals that violate cutoff rules:

- Change the journal header effective date to within the cutoff rule period.
- Save your changes.
- Resubmit the journal batch for posting.

Analytical Accounts

Run the allocate journal process to create your analytical accounting entries at the end of each period, after you:

- Complete all General Ledger and subledger entries
- Post all period journals

Analytical accounting journals can remain open until the end of the following fiscal period, which is the end of the following month. You should, however, complete journals within 15 days because Oracle Financials for Greece defines rule periods as a set number of days, and the number of days in a rule period is not consistent from month to month.

Adjustment Period Journals

You can update unposted adjustment period journal entries for up to four months before posting. Adjustment periods overlap the beginning and end period for the fiscal year. Journal entries made to these adjustment periods are usually dated January 1 or December 31.

Accounting Sequence Numbering

In Greece, every accounting transaction must carry an accounting sequence number at the journal header level. The accounting sequence number is used to identify transactions on statutory reports.

Depending on whether you use a single journal book or multiple journal books, you may need to define separate accounting sequences for each journal book, adjustment journal book, and analytical journal book.

These rules apply to each accounting sequence that you define:

- Accounting sequence numbers are unique within a set of books
- Accounting sequence numbers are automatically allocated when posting to General Ledger
- Accounting sequence number ranges cannot have any gaps
- Once an accounting sequence number is assigned to a transaction, you cannot modify the transaction or the sequence number
- Reversal transactions have a unique accounting sequence number

Oracle General Ledger assigns an accounting sequence number when you post a journal batch. Check that you have defined and assigned your accounting sequence numbers before you post to General Ledger.

See Step 3. Set Up Accounting Sequence Numbering on page 1-7 for more information.

Viewing the Accounting Sequence Number

Use the globalization flexfield in the More Details window, which you navigate to from the Journals window, to review the accounting sequence number for a journal header. You can only review the accounting sequence number at the journal level after the journal is posted.

If you are using a single journal book, you can only view the accounting sequence number for Payables, Receivables, and Cash Management transactions in the Global Accounting Engine (AX) View Transactions window. If you entered No in the Assign Accounting Sequence to GL Journals from AX? field in the globalization flexfield in the Set of Books window, General Ledger does not assign an accounting sequence number to a journal with an AX Payables or AX Receivables journal category when posting transactions to General Ledger. For sequencing purposes, the globalization flexfield does not display the accounting sequence numbers assigned by the Global Accounting Engine to Payables and Receivables transactions.

If you are using multiple journal books, accounting sequence numbers are assigned from both the subledger and the General Ledger accounting sequence ranges. The AX View Transactions window displays the accounting sequence number that is assigned to the transaction from the relevant Global Accounting Engine subledger journal book.

When Global Accounting Engine transactions are imported and posted to General Ledger, Oracle General Ledger assigns the journal header a different sequence number from its own accounting sequence. The globalization flexfield displays this General Ledger accounting sequence number. You cannot delete the information in these fields.

If you entered *Yes* in the Prefix External Reference with Accounting Sequence? field in the globalization flexfield in the Set of Books window, the Reference field in the More Details window displays the accounting sequence number and name. You can also query the prefix in the External Reference field. The accounting sequence number and name appears as a prefix to any reference text that you enter.

See Step 3. Set Up Accounting Sequence Numbering on page 1-7 for more information about the accounting sequence number prefix.

Prerequisites

Before you can review the accounting sequence number, you must post journals in General Ledger.



To review accounting sequence numbers from General Ledger:

- Navigate to the Enter Journals window.
- 2. Query the journal that you want.
- 3. Navigate to the Journals window by pressing the Review Journal button.
- Navigate to the More Details window by pressing the More Details button.
- 5. Review the sequence number and name in the Reference field, if a number and name are displayed. Otherwise go to step 6.
- **6.** Navigate to the globalization flexfield. For instructions, see Using Globalization Flexfields on page B-1.

The Accounting Sequence Name and Accounting Sequence Number fields display the accounting sequence number and name assigned by General Ledger.

To query accounting sequence numbers from General Ledger:

- 1. Navigate to the Enter Journals window.
- Query the journal that you want.
- Navigate to the External Reference field by choosing Show Field from the Folder menu.
- **4.** Query the accounting sequence number and name that you want in the External Reference field.

Global Accounting Engine

This chapter discusses the Global Accounting Engine in Oracle Financials for Greece.

Overview

You must use the Global Accounting Engine (AX) for all Payables and Receivables transactions in Greece. The following features of the Greek accounting requirement apply to the Global Accounting Engine:

- **Journal Import** Freeze all journals once the journals are transferred from the Global Accounting Engine to General Ledger
- **Accounting Cutoff Rules** A subset of the cutoff rules apply to Global Accounting Engine transactions
- **Accounting Sequence Numbering** Global Accounting Engine transactions must carry an accounting sequence number

The Global Accounting Engine provides these reports to help you meet Greek accounting requirements:

- **Account Ledger by Account Report** Provides a review of all accounting entry lines per account and period.
- **Daily Journal Book Line Descriptions Report Provides a review of all** accounting entries for your set of books by accounting sequence number and period.
- **Daily Journal Book Header Descriptions Report Provides a review of all** accounting entries for your set of books by accounting sequence number and period.
- **Untranslated Events Report** Provides a review of AX events that are not yet translated by the Global Accounting Engine, and of the number of aging days that a transaction is over a specified number of days.
- **Supplier/Customer Trial Balance Report** Provides a review of information about balances and period activities by account and supplier/customer for one or more accounting periods.
- **Supplier/Customer Subledger Report** Provides a review of the activity per control account in your subledger for a chosen period or periods.

Journal Import

The Journal Import program in the Global Accounting Engine transfers subledger accounting entries to General Ledger journals. To see the entries in the General Ledger journals, you must run the Journal Import program.

You should freeze journals that you import from the Global Accounting Engine into General Ledger to prevent further updates. This ensures integrity between the AX subledgers and General Ledger.

Use the Freeze Journals option in the Journal Source window for Global Accounting Engine journal sources. Enable the Freeze Journals option for the AX Payables and AX Receivables journal sources.

If you are using a single journal book, an accounting sequence number is assigned only in the Global Accounting Engine to AX-based accounting entries. AX journal updates recorded in General Ledger do not receive a sequence number, if you entered No in the Assign Accounting Sequence to GL Journals from AX? field in the globalization flexfield in the Set of Books window.

See Assigning Accounting Sequences on page 1-13 for more information.

To enable freeze journals for Global Accounting Engine journal sources:

- 1. Navigate to the Journal Sources window.
- 2. Query or enter the journal sources *AX Payables* and *AX Receivables*.
- 3. Check the Import Journal References check box for both journal sources.
- Check the Freeze Journals check box both journal sources. 4.
- In the Effective Date Rule field, enter Roll Date for both journal sources.
- Save your work.

Accounting Cutoff Rules

The 15-day accounting cutoff rule applies to Global Accounting Engine Payables and Receivables transactions. You must post Payables, Receivables, and Cash Management transactions to General Ledger within 15 days of their General Ledger date.

Entering Transactions

Payables and Receivables transactions must have a General Ledger date within 15 days of the current system date.

The Global Accounting Engine automatically enforces the cutoff rule when you validate a transaction. If the transaction violates the cutoff rule, Oracle Payables or Oracle Receivables displays an error message.

To correct a transaction that violates the cutoff rule period:

- Correct the General Ledger date of the transaction.
- Resubmit the transaction for validation.

AX Translation

You must translate all transactions in the Global Accounting Engine within the designated cutoff rule period. The Global Accounting Engine validates transactions at the time of translation. Transactions that are not translated in the Global Accounting Engine within the cutoff rule period fail the translation process.

Use the AX Event Translation report to review transaction entries that failed due to cutoff rule violations.

To correct transactions that violate cutoff rules:

- Navigate to the transaction.
- Change the General Ledger date of the transaction date to within the cutoff rule period.
- Validate the transaction.
- Run the Translation process.

Posting AX Journals to General Ledger

You must post all AX journals to General Ledger within the designated cutoff period. Oracle General Ledger automatically enforces the cutoff rules during the posting process. Use the Posting Execution report to review journal batches that fail due to cutoff rule violations.

To correct a batch that was translated but failed the General Ledger posting process, you must cancel the original entries in the subledgers because translated events cannot be untranslated. You must also delete the journal batch that violated the cutoff rule, as well as the newly imported batch for the canceled subledger transactions. Re-enter all failed transactions, and validate, translate, and post the transactions to General Ledger within the cutoff rule period.

Note: To avoid this process for correcting a journal batch, you should automatically post journals after the transfer to General Ledger. You can set the automatic posting option in the AX Subledger Setup window.

To correct a journal batch that violates cutoff rules:

- Delete the imported journal in General Ledger.
- Cancel the transactions in the appropriate subledger that are contained in the journal batch that violated the cutoff rule.
- Validate and translate the transactions. 3.
- Import the journal batch for the canceled transactions into General Ledger.
- Delete the journal batch in General Ledger.
- Re-enter subledger transactions with a General Ledger date that is within the cutoff rule period.
- Validate and translate the new transactions. 7.
- Import the journal batch for the new transactions into General Ledger.
- Post the journal batch to General Ledger.

Accounting Sequence Numbering

Every transaction in the Global Accounting Engine must carry an accounting sequence number. The accounting sequence number is used to identify transactions in these Global Accounting Engine reports:

- Account Ledger by Account report
- Daily Journal Book Line Descriptions report
- Daily Journal Book Header Descriptions report
- Supplier/Customer Trial Balance report
- Supplier/Customer Subledger report

Depending on whether you use a single journal book or multiple journal books, you may need to define separate accounting sequences for each journal book, adjustment journal book, and analytical journal book.

These rules apply to each accounting sequence that you define:

- Accounting sequence numbers are unique within a set of books.
- Accounting sequence numbers are automatically allocated upon translation in the Global Accounting Engine.
- Accounting sequence number ranges cannot have any gaps.
- Once an accounting sequence number is assigned to a transaction, you cannot modify the transaction or the sequence number.
- Reversal transactions have a unique accounting sequence number.

The Global Accounting Engine assigns an accounting sequence number to every AX transaction at the time of AX translation.

See Step 3. Set Up Accounting Sequence Numbering on page 1-7 for more information.

Viewing the Accounting Sequence Number

Use the View Transactions window in AX Payables or AX Receivables to review the accounting sequence numbers for Global Accounting Engine transaction entries. You can only review the accounting sequence number after AX translation.

If you are using a single journal book, you can only view the accounting sequence number for Payables, Receivables, and Cash Management transactions in the View Transactions window. General Ledger does not assign an accounting sequence number to AX journals when posting transactions to General Ledger, if you entered No in the Assign Accounting Sequence to GL Journals from AX? field in the globalization flexfield in the Set of Books window. For sequencing purposes, the globalization flexfield in the More Details window, which you access from the Journals window, does not display the accounting sequence numbers assigned by the Global Accounting Engine to Payables and Receivables transactions.

If you are using multiple journal books, there are two accounting sequence numbers. The View Transactions window displays the accounting sequence number assigned to the transaction from the relevant Global Accounting Engine subledger journal book.

When Global Accounting Engine transactions are imported and posted to General Ledger, Oracle General Ledger assigns the journal header another sequence number from its own accounting sequence. The globalization flexfield displays the General Ledger accounting sequence number.

Prerequisites

Before you can review the accounting sequence number, you must translate transaction entries in the Global Accounting Engine.

To review accounting sequence numbers from AX:

- Navigate to the View Transactions window.
- 2. Query the transaction that you want.
- The Accounting Sequence Name and Accounting Sequence Number fields display the accounting sequence number and name.

Oracle Payables

This chapter discusses supplier turnover reporting in Oracle Payables.

Defining Turnover Exclusion Rules

Use the Define Turnover Exclusion Rules window to define and maintain exclusion rules. Exclusion rules let you specify the supplier type/customer class, invoice/transaction types, or invoice/transaction distribution line types that you want to exclude from your Payables and Receivables turnover reporting.

For example, if you want to report on the accumulated purchases from all suppliers except suppliers that are designated as a No Tax Recovery supplier type, complete these steps:

- Define an exclusion rule that excludes the No Tax Recovery supplier type from your turnover reporting.
- 2. Enter the rule in the Exclusion Rule Name parameter field when you submit the Greek Payables Supplier Turnover Report Set. Oracle Payables considers all suppliers for inclusion in the Greek Payables Supplier Turnover Listing and File Format, *except* suppliers with the No Tax Recovery supplier type.

The Greek Payables Supplier Turnover Listing/File Format Note: and the Greek Receivables Customer Turnover Listing/File Format display public sector companies as a single line. If you define a Payables or Receivables exclusion rule for the public sector company supplier type/customer class, all public sector companies are excluded from your Payables or Receivables turnover reporting.

See Greek Payables Supplier Turnover Listing and File Format on page 4-6 and Greek Receivables Customer Turnover Listing and File Format on page 5-3 for more information.



To define turnover exclusion rules:

- Navigate to the Define Turnover Exclusion Rules window.
- In the Rule Name field, enter a unique rule name for the rule that you want to define.
- In the Description field, enter a description of the rule that you want to define.
- **4.** Check the Enabled check box.
- Navigate to the Rule Lines region to define specific rule line types that you want to create an exclusion rule for.

If you define an exclusion rule with no lines, all transactions are extracted in the turnover reporting process for this particular rule.

- **6.** In the Group Type field, from the list of values, select the lookup type (supplier type/customer class, invoice/transaction type, or invoice/transaction distribution line type) that you want to exclude from your turnover reporting with this rule.
- 7. In the Name field, from the list of values, select the lookup code that you want to exclude for this rule.
 - Lookup code selections that exist in the list of values are dependent on the entry that you make in the Group Type field.
 - The Description field is automatically populated with a description of the lookup code that you enter in the Name field.
- **8.** Check the Excluded check box to exclude this rule line type from the turnover reporting process.
 - If you do not check the Excluded check box, the rule line type is considered for inclusion in the turnover reporting process.
- **9.** Save your work.

Defining Public Sector Suppliers

When you run the Greek Payables Supplier Turnover Listing and File Format, invoices from public sector companies are reported on a single line. You specify whether a supplier is a public sector company by choosing the Public Sector Companies supplier type in the Suppliers window in Oracle Payables.

Oracle Financials for Greece provides you with the flexibility to classify a non-public sector supplier as a public sector company for turnover reporting purposes, and vice versa.

Use the globalization flexfield in the Suppliers window to specify if a supplier is a public sector company. When you run the Greek Payables Supplier Turnover Listing and File Format, the value that you enter in this flexfield overrides the company's designated supplier type.

- Enter or query the supplier that you want. 2.

- Choose the OK button to save your work.

Use the Greek Payables Supplier Turnover Listing and Greek Payables Supplier Turnover File Format to report on the purchase turnover (purchase accumulation) of your suppliers. You run the Greek Payables Supplier Turnover Listing and File Format together as part of the Greek Payables Supplier Turnover Report Set.

The Greek Payables Supplier Turnover Listing and File Format show the total number of purchase invoices for each supplier during a specified period. You can specify which supplier types, invoice types, and invoice distribution line types that you want to report on by selecting a turnover exclusion rule when you submit the report set.

Public sector companies are displayed in summary form on a single line. You specify whether a supplier is a public sector company at the supplier level.

You must submit the Greek Payables Supplier Turnover File Format to the Greek tax authorities annually. For the electronic file content, see Electronic File Content on page D-1.

Use the Standard Request Submission windows to submit the Greek Supplier Turnover Report Set.

Defining Public Sector Customers

When you run the Greek Receivables Customer Turnover Listing and File Format, invoices from public sector companies are reported on a single line. You specify whether a customer is a public sector company by choosing the Public Sector Companies customer class in the Customers - Standard window in Oracle Receivables.

Oracle Financials for Greece provides you with the flexibility to classify a non-public sector customer as a public sector company for turnover reporting purposes, and vice versa.

Use the globalization flexfield in the Customers - Standard window to specify if a customer is a public sector company. When you run the Greek Receivables Customer Turnover Listing and File Format, the value that you enter in this flexfield overrides the company's designated customer class.

Use the Greek Receivables Customer Turnover Listing and Greek Receivables Customer Turnover File Format to report on the sales turnover (sales accumulation) of your customers. You run the Greek Receivables Customer Turnover Listing and File Format together as part of the Greek Receivables Customer Turnover Report Set.

The Greek Receivables Customer Turnover Listing and File Format show the total number of sales invoices for each customer during a specified period. You can specify which customer types, transaction types, and transaction distribution line types that you want to report on by selecting a turnover exclusion rule when you submit the report set.

Public sector companies are displayed in summary form on a single line. You specify whether a customer is a public sector company at the customer level.

You must submit the Greek Receivables Customer Turnover File Format to the Greek tax authorities annually. For the electronic file content, see Electronic File Content on page D-1.

Use the Standard Request Submission windows to submit the Greek Receivables Customer Turnover Report Set.



Entering Asset Information

Use the globalization flexfield in the Asset Details window or the QuickAdditions window to enter additional asset information. Enter the following additional information to fulfill the Greek statutory requirement for fixed assets:

- **Investment laws** incentives available to businesses, depending on the region and the nature of the investor's business. The current incentives are direct subsidy, interest subsidy, leasing subsidy, and tax exemption.
- Commitments current financial burdens recorded against the asset, such as existing mortgages or pre-notices of mortgages.

Additional assets information is reported in the Statutory Asset Ledger Report. See Statutory Asset Reports on page 7-8 for more information.



To enter additional information for assets:

- 1. Navigate to the Assets window.
- 2. Query or enter the asset that you want.
- 3. Navigate to the Asset Details window.
- **4.** Navigate to the globalization flexfield. For instructions, see Using Globalization Flexfields on page B-1.
- **5.** In the Commitment field, enter the commitments, such as *existing mortgages*, against this asset.
- **6.** In the Investment Law field, enter the incentive, if any, against this asset, such as direct subsidy or interest subsidy.

Statutory Asset Reports

In Greece, companies are required to submit statutory summary and detailed reports on fixed asset costs and accumulated depreciation. Oracle Assets provides three reports that help you comply with Greek accounting requirements for fixed assets:

- **Statutory Asset Cost Detail** provides information about period changes in fixed asset costs
- Statutory Asset Reserve Detail provides information on changes in fixed asset accumulated depreciation
- Statutory Asset Ledger report provides summarized cost, accumulated depreciation, and net book value information per asset

You can also optionally summarize by parent account in all three reports. The three reports are designed to reconcile with each other in order to help you reconcile your fixed asset books with General Ledger account balances.

Greek Accounting Requirements

This chapter contains topical essays that discuss the accounting and business requirements for Greece.

Accounting and Business Requirements in Greece

These topical essays provide background information about the current business requirements for companies that do business in Greece, including:

- The 15-Day Posting Rule
- Accounting Sequence Numbering
- **Analytical Accounting**
- Investment Law and Commitment Storage for Assets
- Company Statutory Information Storage
- **Statutory Header Reports**

The 15-Day Posting Rule

Accounting entries in Greece must comply with a statutory limited-period posting rule. This requirement prohibits the validation and posting of accounting data after a specified number of days, counted from the system date of the transaction. The current specified number of days is 15.

The 15-day posting rule requires that the accounting date for all entries tall within 15 days of the current system date. If the accounting date falls outside of this period, you must change the entry's date for the system to validate the transaction.

Example 1:

Accounting Date (System Date = March 16, 1999)

Transactions that you enter cannot have an accounting date before March 2, 1999: General Ledger cannot validate transactions with an accounting date on or before March 1, 1999, because there are more than 15 days between the accounting date and the system date.

Once a transaction is entered in General Ledger or approved in the subledgers, you must translate and/or post the transaction within 15 days of the accounting date.

Example 2:

Posting (Accounting Date = March 16, 1999)

Transactions that you enter cannot have a translation/posting date later than March 30, 1999: the Global Accounting Engine and General Ledger cannot translate or post transactions with accounting dates of March 16, 1999 after March 30, 1999, because there are more than 15 days between the accounting date and the required posting date.

Accounting entries with an accounting date that is 15 days after the system date fail the translation or posting process and are not included in the balances for their respective accounts.

The 15-day posting rule applies to all entries made through the Global Accounting Engine and General Ledger, as well as journals imported in General Ledger from feeder systems such as Oracle Assets.

Global Accounting Engine

You must complete Global Accounting Engine transactions that were entered through Oracle Payables and Oracle Receivables before 15 days have passed between the accounting date and the current system date.

Global Accounting Engine validates the 15-day posting rule at two levels:

- When an event is validated.
- When an event is translated (posted). At this point you can view the accounting entries created in the AX journals using the AX View Transactions window.

Global Accounting Engine posting consists of four processes, which you can automate using the Standard Request Submission windows:

- **AX Translation** The process of transferring accounting entries from subledgers into Global Accounting Engine, based on the rules defined within the Global Accounting Engine.
- **General Ledger Transfer** The process of transferring translated accounting entries to the General Ledger Interface tables.
- **Journal Import** The process of importing transferred data, temporarily stored in the General Ledger Interface tables, into General Ledger.
- **General Ledger Posting** The process of posting accounting entries to their respective accounts.

Oracle General Ledger

The 15-day posting rule applies to journal entries made directly into General Ledger and imported from feeder systems and the AX imported journals.

Journals not posted within the rule period, regardless of the source, are invalidated, and do not complete the posting process.

Oracle Assets

Journals that are generated in Oracle Assets are subject to the 15-day posting rule once imported into General Ledger.

Once journals are transferred to General Ledger, the depreciation journal and other asset accounting journals are subject to same posting restrictions placed on General Ledger journals. Users, however, must verify that accounting entries generated in Oracle Assets are transferred to General Ledger in a timely manner.

15-Day Posting Rule Exceptions

Several exceptions currently exist to the 15-day posting rule:

- **Allocation journals** Allocated journals, or analytical accounts, are derived from the allocation process, which is run after the subledgers and General Ledger are completed for the period. Journals can remain unposted up until the end of the following period.
- **Adjustment period journals** Transactions posted to adjustment periods can remain unposted for a period of up to four months.
- **Inventory transactions** You must complete inventory accounting entries within a 10-day period.

The limited period posting rule is established by Greek authorities. The numbers that denote the rule periods, such as 15 days for journals and four months for Adjustment Period journals, are defined in the Define Cutoff Rules window. Consult your system administrator or other authorized user to make any changes to these rule periods.

See Step 4. Define Accounting Cutoff Rules on page 1-14 for more information.

Accounting Sequence Numbering

The Greek accounting requirement specifies that each accounting transaction entered in General Ledger, Payables, Receivables, and Cash Management must carry a unique sequential number at the header level. This number is called an accounting sequence number.

The accounting sequence number is assigned when the transaction is complete, which lets Oracle Financials for Greece show all accounting entries in a date/accounting entry and sequence number order that is required by Greek authorities for statutory reporting. Accounting sequence numbering also ensures that no gaps exist in accounting entries, due to user error for example.

Accounting sequence numbering in each application must comply with these legal requirements:

- The numbers are unique within a set of books.
- Each entry within each set of books must have a unique number.
- The numbers are automatically allocated upon posting.
- No gaps exist in the sequence of numbers allocated.
- For statutory reports, transactions are listed in date and sequence number order.
- Accounting entries for the Opening and Closing Fiscal Year transactions must have a different numbering convention from other accounting entries.
- Once a number is assigned to a transaction, the user cannot alter the transaction or the number.

Global Accounting Engine

The allocation of accounting sequence numbers for Global Accounting Engine transactions is managed by the standard AX Accounting Sequence Numbering function. The Global Accounting Engine allocates numbers at AX translation. You can control the timing of allocation, within the 15-day posting rule limit, by determining when the accounting entry is complete and ready for translation.

General Ledger

Accounting number sequencing is a requirement for all General Ledger manual and imported journal entries, including AX transferred journals (for multiple journal books). The number is allocated when accounting entries are posted to General Ledger.

During the posting process, Oracle General Ledger populates the global descriptive flexfield in the Journals > More Details window with the appropriate accounting sequence number. If you entered Yes in the Prefix External Reference with Accounting Sequence? field in the globalization flexfield in the Set of Books window, Oracle General Ledger also populates the Reference field in the Journals > More Details window with the accounting sequence number and name.

Journals generated for adjustment periods must have a unique number sequence. This sequence is shared by journals generated for either the opening or closing period, because the journals belong to the same journal book and share the same document sequence. The sequence, however, is different from the number sequence used for normal General Ledger journals.

Allocated journals for analytical accounting can also have there own unique number sequence. See Analytical Accounting on page 8-8 for more information.

Analytical Accounting

Greek Analytical Accounting became law on January 1, 1997 after an announcement in mid 1996 and is effective for fiscal year 1998, according to Presidential decree 1082121/1206/1996.

This law specifies that Greek companies must record and report the cost effect of certain accounting transactions, generally Profit and Loss transactions, in greater detail, in additional Group 9 accounts. These Group 9 accounts are reported on in selected General Ledger statutory reports.

In this way, analytical accounting lets Greek companies report on the nature and purpose of their revenue and expenses and simulate a monthly close process.

Analytical accounting involves the parallel processing of transactions affecting certain General Ledger accounts with the Group 9 accounts. Analytical accounting is required for all entries posted to natural account segments commencing with the values in this table:

Group	Туре	Description

Group 9 accounts are marked as asset accounts. Entries recorded to these accounts, as part of the analytical accounting process, do not affect the balance of the Retained Earning account and thus do not distort a company's true accounting position.

Analytical entries are derived automatically according to rules established by Greek legislation. In Oracle Financials for Greece, the accounting entries are derived from a process run after the subledgers and General Ledger are completed for the period, as a monthly or accounting period process. This creates a separate allocated journal with the corresponding analytical entries.

The Define Journal Allocations window in Oracle General Ledger lets you define rules for creating allocated journals. You can specify the account ranges to be analyzed and create one or more destination accounts for the resulting allocated journal lines. The Journal Allocations - Allocate concurrent program automatically creates the allocated journal entries according to the rules entered in the Define Journal Allocations window.

Note: You can only run the Journal Allocations - Allocate program after completing all accounting entries for the period. Your company should establish this practice as a regular business procedure to ensure the proper handling of analytical accounting.

If necessary, you can manually create analytical journal entries for any late accounting.

The allocated journal that results from the Journal Allocations - Allocate program is imported into General Ledger in either summary or detail mode, using the standard General Ledger Interface process.

Allocated journals can have their own accounting sequence numbering. The accounting sequence number is assigned to allocated journals during the General Ledger Posting process. This number is only allocated to successfully posted journals.

You can use the audit trail function in Oracle Financials for Greece for any audit requirement that you must track the rule sets created for allocated journals.

Detailed requirements for analytical accounting are:

- All entries to natural account segment values that begin with 2, 6, 7, and 8 must be reflected by an equal entry in an analytical account. This analytical account is represented by a natural account segment value that begins with the number 9.
- Analytical accounting entries are processed on a monthly basis.
- You can post journal entries directly to analytical accounts.
- Transactions that result from the allocated journal process are assigned a unique accounting sequence number in General Ledger.
- Analytical accounting entries are reported in certain statutory General Ledger reports. The analytical accounting entries in these reports are displayed separately from non-analytical entries.
- The balances of analytical accounting entries are included in the first level summaries of the parent values of the natural account in the General Ledger Summary Report.
- All brought-forward entries must be kept separate.
- All year-end entries must be kept separate.

Definitions

Analytical/Allocated Accounts - Accounts have a natural account segment value that begins with the number 9. These category 9 accounts are a special group in the Greek Chart of Accounts and are assigned an account type of Asset to prevent these entries from influencing the retained earnings account.

Category 2, 6, 7, and 8 Accounts - Accounts with a natural account segment value that begins with a 2, 6, 7, and 8 and are defined in the normal Greek Chart of Accounts. These accounts generally have an account type of Revenue or Expense, with the exception of category 2 accounts which relate to Inventory accounts and have an Account type of Asset.

Investment Law and Commitment Storage

Greek law requires the storage of Asset Investment Law and Commitment Information for each asset when you enter assets. This requirement is based on the provisions of the Presidential Decree 1123/80 General Chart of Accounts (GCA) which requires companies to reflect additional information items within asset accounts, such as information about:

- Whether or not each asset was purchased under favorable investment law provisions.
- Whether each fixed asset has legal burdens.

Asset Investment Law

Investment Laws (EPENDYTIKOS NOMOS) provide certain incentives that vary depending on the region where the investment is effected and according to the nature of the business of the investing enterprise (industrial, commercial, and so on). Current incentives include direct subsidy (direct capital flow), interest subsidy (loan financing), leasing subsidy (lease payment financing), or tax exemption (untaxed reserves or tax deduction on the purchased value of the asset). You need to record the appropriate investment law that applies to the purchasing decision of the asset against the newly acquired asset.

Commitment

Commitment information is recorded as part of the additional legal information storage. Commitments (DESMEYSEIS), such as existing mortgages, pre-notices of mortgages or any other financial burden, are recorded against any asset that they refer to.

Companies must store commitment information when an asset is entered. This additional information is maintained in a global descriptive flexfield in the Asset Details window.

The additional information both for investment law and commitment is displayed in the official Asset Ledger Report.

Company Statutory Information Storage

Greek law requires Greek companies to store information about themselves in their financial applications, which is used to create the Greek Statutory Headings Report. The statutory header, once printed, is endorsed and stamped by the Greek tax authorities. The company in turn prints all official versions of reports on government-certified statutory report paper.

The statutory header contains:

- Fiscal company name
- VAT number
- Tax area
- Tax office code
- Company activity

You enter and maintain this information in the globalization flexfield in the Location window.

Company Statutory Report Headings Report

You can divide Greek reporting requirements into two categories: official reports, reports printed on official paper with the company statutory header and required by the Greek tax authority, and official reconciliation reports, required by the company and auditors.

Statutory Header Reports are used by Greek companies to print their official reports for the tax authority. These Header Reports must comply with the Greek statutory report format defined by Greek tax authorities. The official reports must contain specific company information and a pre-printed sequence number.

To help companies format Header Reports and display the appropriate information, Greek tax authorities produced a standard report header template. Companies must use this template when devising the layout of their own official report headers.

Information that must appear on the header report includes:

- Fiscal Company Name Name of the company
- Tax Office Name of the tax office that the company submits its reports to
- Company Activity Business activity of the company
- Tax registration number
- Fiscal company VAT number
- Title of the statutory books

This information is stored as part of the company statutory information storage requirement. See Company Statutory Information Storage on page 8-13 for more information.

The Header Report produced by the company is endorsed and stamped by the tax authority to certify the validity of the numerical sequence for the purpose of statutory reporting. The validated Header Report is used to print the official reports required by Greek legislation.

- Statutory Asset Reserve Detail Report
- Statutory Asset Ledger Report
- Daily Journal Book Line Descriptions Report
- Daily Journal Book Header Descriptions Report
